Dear Manhattan Beach Property Owner/ Resident:

Included in the City's Capital Improvement Program is the water main replacement project at the following locations:

- Highland Ave from 6th Street to 7th Street
- 6th Street from Highland Ave to Ocean Dr
- 7th Street from Crest Dr to Ocean Dr
- Morningside Dr from 2nd Street to 3rd Street

The purpose of this project is to replace the existing water mains which are undersized, deteriorated and/or restricted by a build-up of deposits over the years. The improvements will reduce maintenance, improve overall circulation in the water system and insure adequate water pressure for both residential use and fire prevention flow. Proposed reconstruction will be primarily oriented toward the installation of the new water main with residential service connections; the installation of valves and fire hydrants; as well as, the restoration of surface improvements.

2011-2012 WATER MAIN REPLACEMENT PROJECT, PHASE 2

******* FREQUENTLY ASKED QUESTIONS *******

Q: What type of project is this and what is the purpose of the project?

A: This project is a water main replacement. A new water main will be constructed along a trench line in the paved roadway or walkway. The goal of this project will be to replace and abandon the existing aged water line, reconnect new house service lateral connections and restore the roadway and/or walkway improvements. The walk-street locations will be repaved the full width where needed.

Q: When will this project begin and what is the project schedule?

A: This project will begin in April/May 2013 and will end in July/August 2013. Each project street will take approximately 6-weeks to complete. Working hours are from 7:30am to 5:00pm, Monday through Friday.

Q: Will my water service be shutdown?

A: In order to connect the new water main to the existing system, water service will be temporarily turned off at various times during the course of construction for up to 4 hours. Residents will be notified 48 hours in advance. Following the major connections, each individual property's water service will be reconnected to the new water main on a case by case basis and water service will need to be turned off temporarily for up to 1 hour. Residents will, again, be notified 48 hours in advance. Water shutdowns will be coordinated to minimize the impact as feasibly possible.
