07/0123.1 Presentation and Discussion of the Community Facilities Strategic Plan

Consultant Jim Favaro, of MDA Johnson and Favaro, presented an overview of the Community Facilities Strategic Plan Preliminary Report, dated December 2006, to the Commissioners. The report documents the work that was completed by the consultants during the reconnaissance and analysis phase of the year-long planning effort including community outreach, document review, and field observation. Mr. Favaro gave a summary of the five sections in the report: 1) introduction, 2) sites analysis, 3) facilities analysis, 4) preliminary needs assessment, and 5)

preliminary speculations. He demonstrated through illustrations several options for the community's expressed priorities and how adjacent un-programmed open space could be preserved or expanded. Mr. Favaro also gave an overview of the next steps in the planning process, which will include a second round of outreach to the community, cost analysis, and the development of specific options. Following the presentation there was an open question and answer period during which the process for the remaining planning period was discussed.
