## V. <u>GENERAL BUSINESS</u>

## 02/0612.13 Sculpture Garden

Commissioner Duncan recapped the Sculpture Garden installation and dedication, acknowledging the tremendous effort by Public Works and appreciation to Mayor Cohen, Council Members Montgomery and Powell, and City Manager Geoff Dolan for their participation. The artists complimented the City on the Sculpture Garden layout and for the sites chosen for each of the sculptures.

The Commissioners are very happy with the inaugural exhibition and they look forward to working on the subsequent show in 2010. Susannah Rosenthal referred the Commissioners to the <u>Sculpture by the Sea</u> website where they could review new sculptural forms. These international art works are not readily available but they can provide food for thought with a wide variety of styles that are installed on or near a beach environment.

## VI. <u>REPORTS AND OTHER BUSINESS</u>

#### Children's Theater

Ms. Purner responded to the Commission's question regarding fundraising for the Children's Theater, a program that was suspended due to the City's budget deficit. The Commission is asked to submit a proposal for review that identifies the funding source, amount of funds raised that will cover all the performance costs plus sponsorship opportunities and collateral for the sponsors.

#### New Projects

The Commissioners agreed to devote time for the exploration and discussion of new cultural arts projects. Organizing an ad hoc committee is an option. Commissioner DeMaria shared his list of new items for consideration. Several of the items were of particular interest to the Commission; an Art Lecture Series; development of Student Art and Design Competitions; and creating an Artist in Residence Program that would bring artists to the City to give lectures, classes and demonstrations. Finding host housing for the artists could reduce the expense of such a program.

Fundraising ideas include a CAC booth with a public hands-on art project that invites community involvement at the Hometown Fair; or a large artist postcard project composed of individually designed postcards that can be auctioned off at the close of the exhibition.

In conclusion, the Commission agreed that before submitting proposed programs to Council, there are many policy and fundraising issues to clarify. The information-gathering phase could take until November.
