V. GENERAL BUSINESS

07/0129.5 City Entryway & Logo

The Commission discussed the City Council's comments at the last Council Meeting with Mr. Andrews from Graphic Solutions and the possible changes in the conceptual design. The following points were mentioned:

Signage

A. General Comments

- Different renderings for each entry site; three renditions of the two designs selected
- Enhance the sand and sun in the logo
- The color of "stone" sign needs to be a more natural color
- Material samples (concrete or stucco) were requested
- Planters shown in front of the sign need to be removed
- Treatment to the back of sign needs consideration; it may need appropriate landscape
- The scale of signage on Manhattan Beach Blvd. needs to be modified. It was suggested that the truck be removed to eliminate size comparison
- Perhaps the sign could be slanted considering the driver's perspective
- Cost estimates should be included for City Council presentation
- Mosaic design can be executed by an artist if needed
- The Cultural Arts Commission will participate in the approval of tiles and materials
- B. Specific comments to horizontal-shaped design
 - The sun could be brighter
 - Letters to be curved on the stone
 - Contrast to be adjusted
- C. Specific comments to vertical design:
 - Scale needs adjustment

Logo

- Remove nautical motifs from the design
- Create options for the logo with and without "The City of" and California
- Council requested samples of stationery with logo

02/0514.3 Sculpture Garden

Given the nature of the sites, sculpture "path" was suggested as a name for the project instead of sculpture "garden."
