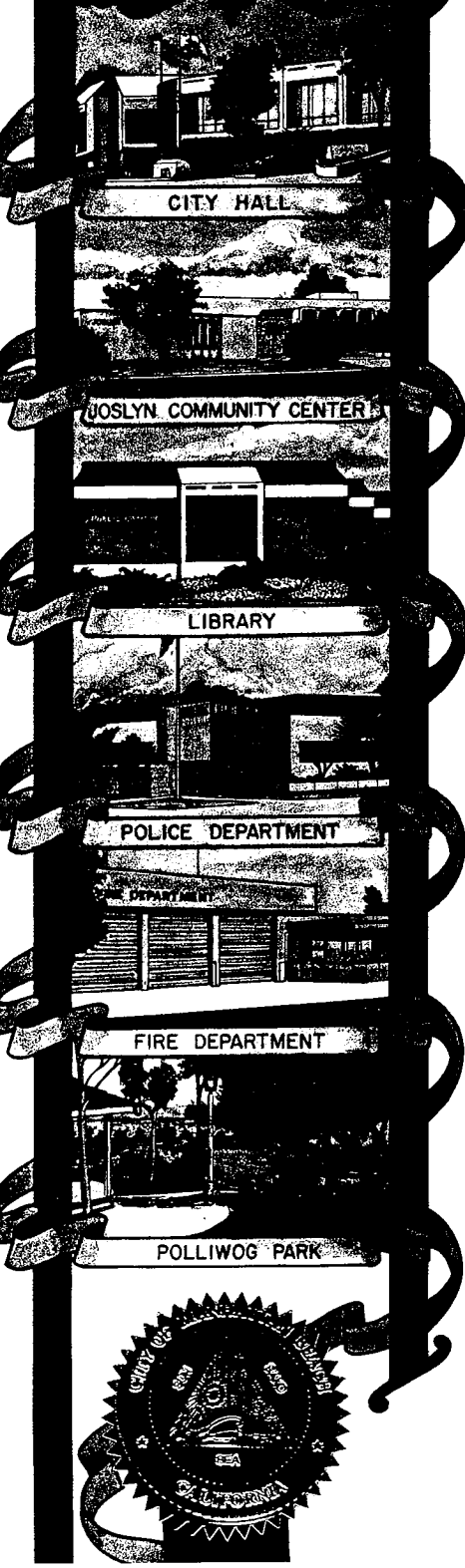

WHEREAS, the team won a national championship title; and

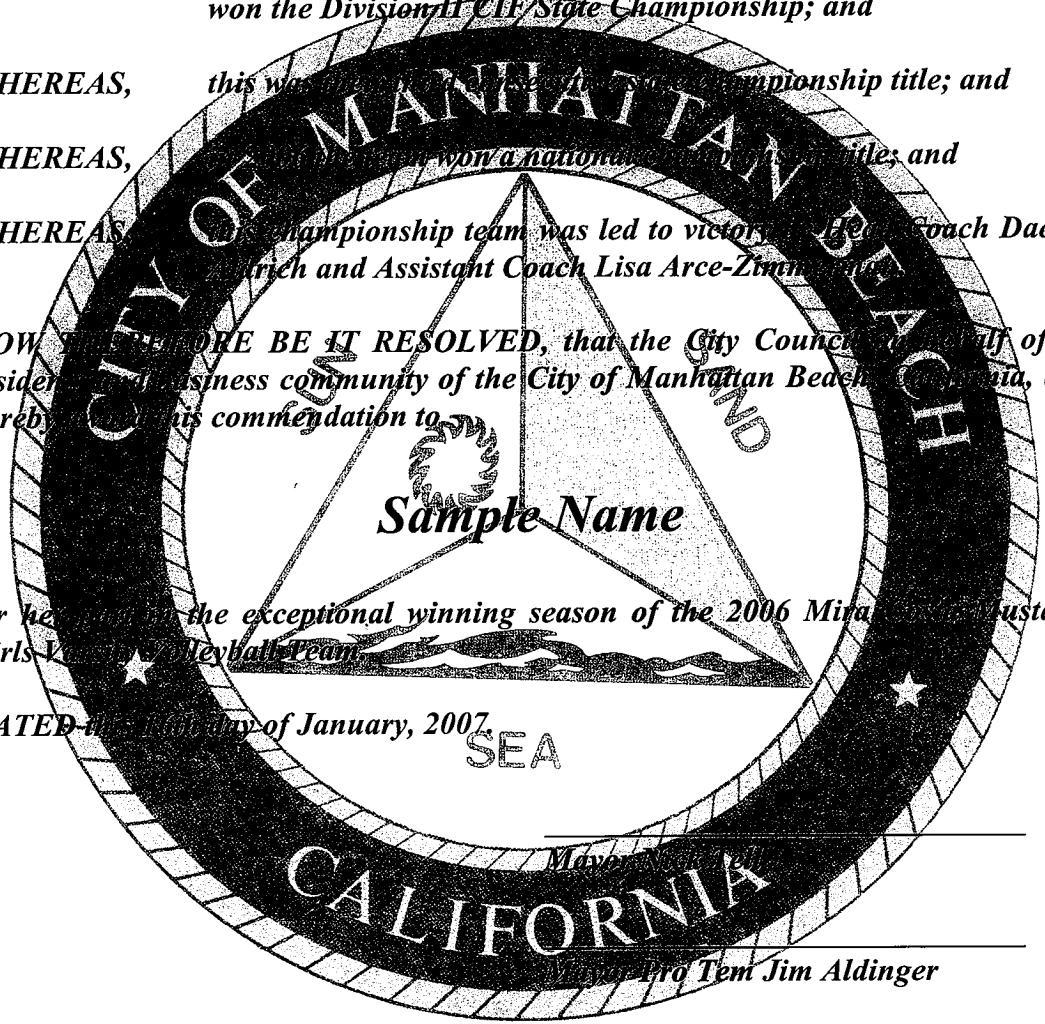
