SUBJECT: Consider a Request for Stop Signs at 21st Street/22nd Street and Magnolia Avenue

RECOMMENDATION:

Staff recommends that the Parking and Public Improvements Commission pass a motion to recommend that the City Council adopt a resolution to install stop signs in all directions at the intersection of 21st Street/22nd Street and Magnolia Avenue.

BACKGROUND:

On August 14, 2013, the City received a request from Ms. Mecia Sabbe, a local resident, to install stop signs in all directions at the intersection of 21st Street/22nd Street and Magnolia Avenue (Exhibit 1). She explained that she has been involved in several incidences when crossing the intersection with her children. Ms. Sabbe says there is limited visibility due to the curves, and parked cars make it difficult to see oncoming vehicles.

DISCUSSION:

The intersection of 21st Street and 22nd Street at Magnolia Avenue is located in a residential area east of Sepulveda Boulevard (Exhibit 2). 21st Street is the southwest leg of the intersection, 22nd Street is the northwest leg, and Magnolia Avenue forms the southeast and northeast legs. All streets are 30-foot wide two-lane local streets with a 25mph prima facie speed limit that carry approximately 300 vehicles per day each. 21st Street and 22nd Street are stopped at Cedar Avenue to the west. Magnolia Avenue is stopped at Marine Avenue to the north and 18th Street to the south. All streets are improved with curbs, and sidewalks. Curb parking is allowed on both streets, except for street sweeping restrictions. Curb parking demand is generally light during the day to moderate at night. There is a horizontal curve on the southeast leg of 21st Street and the northeast leg of Magnolia Avenue that reduce sight distance.

Field Observations

Field observations were made on typical days during peak and non-peak periods. Field observations confirm low traffic volumes on all legs and other physical characteristics at the intersection as noted above. Proper right-of-way is assigned by stop signs on two of the four approaches. There is adequate sight distance for motorists stopped on the southeast leg of Magnolia Avenue looking southwest and northeast. However, sight distance for drivers on 22nd Street is reduced below the recommended minimum stopping sight distance for stopped

intersections due to the horizontal curves on 21st Street and Magnolia Avenue (Exhibit 3). Recurrent speeding was not observed on any of the approaching street segments because of the curves in the neighborhood and narrow streets with parked cars.

The traffic collision history between January 1, 2005 and December 31, 2011 was analyzed for both intersections. According to City records, there have been no collisions reported near the intersection during this seven (7) year period.

Multi-way Stop Signs

The State of California has established guidelines for the installation of stop signs. These criteria have been widely accepted and are used by the City of Manhattan Beach. Multi-way or all-way stop controls are generally recommended when one or more of the State criteria are satisfied and indicate the existing traffic control devices are not sufficient to assign proper right-of-way or cannot be remedied through other means.

A stop sign warrant checklist was completed that indicates that multi-way stop signs ARE warranted at this intersection (Exhibit 4). This intersection has sufficient right-of-way controls, does not meet minimum traffic volumes and has no collision history. However, the existing sight distance restriction is unable to be remedied by removal of curb parking. Therefore, stop signs in all directions are appropriate at this intersection due to the geometric conditions of the street alignment.

Public Notice

Residents within 500 feet of the intersection and the petitioners were notified by mail of the proposed stop sign request and were invited to give input to the Commission (Exhibits 5 & 6).

CONCLUSION:

Based on minimum State guidelines, multi-way stop signs are justified at the intersection of 21st Street/22nd Street and Magnolia Avenue at this time. It is recommended that the Commission pass a motion to recommend that the City Council adopt a resolution to install stop signs in all directions at 21st Street/22nd Street and Magnolia Avenue.

Thank you for contacting the City with your concerns. 
