13/0813.1 Ansel Adams Exhibition

The exhibition is part of the Creative Arts Center's 2014 schedule. The exhibition has been scheduled for September 12, 2014 through October 9, 2014. The Cultural Arts Division has budgeted \$1125.00 for regular art exhibition expenses such as installation, opening reception and marketing cost. Below is a proposed budget for additional expenses previously presented to the Commission.
