SUBJECT: Consideration of Resolutions to Pay and Report the Value of Employer Paid

Member Contributions (EPMC) for the Manhattan Beach Firefighters' Association, the Manhattan Beach Police Officers' Association, the Manhattan Beach Miscellaneous Employees Represented by California Teamsters Local 911 and the Management/Confidential Group. **ADOPT RESOLUTION NO. 6065, RESOLUTION NO. 6066, RESOLUTION NO. 6067 AND RESOLUTION**

RECOMMENDATION:

Staff recommends that the City Council approve Resolutions No. 6065, No. 6066, No. 6067 and No. 6068 to Pay and Report the Value of Employer Paid Member Contributions (EPMC) for the Manhattan Beach Firefighters' Association, the Manhattan Beach Police Officers' Association, the Manhattan Beach Miscellaneous Employees Represented by California Teamsters Local 911 and the Management/Confidential Group.

FISCAL IMPLICATION:

Implementing EPMC will impact future CalPERS contributions; which will vary by group. The costs associated were included in the total costs of each bargaining contract or group that were previously approved by City Council.

BACKGROUND:

EPMC is a negotiated benefit between the three bargaining units and the City. The bargaining units agreed to five (5) year contracts based on implementing the EPMC benefit. The EPMC benefit is effective on different dates for each bargaining group. The Management/Confidential Group is receiving EPMC in order to provide a comparable benefit and equity with the miscellaneous employees' group and also to insure consistency in benefits for promotional purposes.

DISCUSSION:

In order to effect this benefit, CalPERS requires that the City pass the attached resolutions which reflect the agreed-upon change and implementation dates for each bargaining unit/group:

- The EPMC benefit is effective the pay period including January 1, 2007 for the members of the Manhattan Beach Firefighters' Association.
- The EPMC benefit is effective the pay period including January 1, 2009 for the members of the Manhattan Beach Police Officers' Association.
- The EPMC benefit is effective the pay period including July 1, 2010 for the members of the Manhattan Beach Miscellaneous Employees represented by Teamster Local 911 and members of the Management/Confidential Group.

CONCLUSION:

Staff is pleased to present resolutions for the retirement benefit for the City Council's approval.
