## **BACKGROUND:**

City Council recognizes that the increasing social, regulatory and financial complexities surrounding potable water and stormwater management are largely complicated and invisible to the general public. Accordingly, City Council directed staff to facilitate a workshop highlighting current and evolving potable water and stormwater issues and challenges.

Subject matter that will be presented and discussed at this study session via a powerpoint presentation includes:

#### 1. Potable Water:

- a. Water Administration in the State
  - i. Existing Water Districts, Water Rights
- b. Imported Water and Groundwater Supplies
- c. Water Rates
  - i. Basic Methodology for Setting of Rates
- d. Water Drought including recent Emergency Drought Regulations
- e. Water Conservation Ordinance

- i. Current Restrictions
- ii. Potential Future Restrictions
- iii. Incentives
- f. Future of Seawater Desalination in South Bay

#### 2. Stormwater:

- a. New National Pollutant Discharge Elimination System (NPDES) Regulations
- b. City Stormwater Infrastructure Condition Assessment and Anticipated Rehabilitation Costs.

Since multiple parties are contributing to the powerpoint presentation, the powerpoint slides were not available by the date of this writing and are not attached. However, hard copies will be made available at the study session meeting and will simultaneously be made available on the City's website.

## **DISCUSSION:**

In order to address this variety of water and stormwater topics, City staff will lead the discussion and has invited the West Basin Municipal Water District (West Basin), Water Replenishment District of Southern California (WRD), and Geosyntec Consultants to assist in the presentation. The following is a brief description of their role in the water industry along with additional information regarding the topics they will be discussing at the meeting:

## **West Basin Municipal Water District**

West Basin purchases treated imported water from the Metropolitan Water District of Southern California and wholesales it to cities and private companies within a 185-square mile service area in southwest Los Angeles County. West Basin is also involved in the production and distribution of recycled water and produces comprehensive conservation and education programs.

At the meeting, West Basin will further describe their mission, provide an overview of overall water supplies, discuss the administration of imported water in the State, and the setting of imported water rates. Afterwards, West Basin will elaborate on its *Water Reliability 2020* program, which is designed to reduce the region's dependence on imported water by doubling its water recycling program, doubling its water conservation program, and adding ocean water desalination to further diversify future water supplies. Additionally, West Basin will describe its water conservation outreach program, including financial incentive to help water users reduce consumption.

## Water Replenishment District of Southern California

WRD manages groundwater for nearly four million residents in 43 cities of southern Los Angeles County and is involved in groundwater monitoring, safe drinking water programs, combating seawater intrusion, and groundwater replenishment operations.

At the meeting, WRD will further describe their mission, provide an overview of the administration of groundwater in the Central and West Coast Basin, and the setting of groundwater replenishment rates. WRD will then elaborate upon its efforts on the *Water Independence Now* program, which is a series of projects that will fully utilize stormwater and

recycled water to restore and protect the groundwater resources of the Central and West Coast Basins by creating a locally sustainable groundwater supply.

## **Geosyntec Consultants**

Geosyntec Consultants has been the City's stormwater consultant for many years. They have helped guide the City through the implementation of numerous stormwater permits including the most recent fourth National Pollutant Discharge Elimination System Permit (Permit), which became effective on December 28, 2012. The Permit identifies conditions, requirements and programs that municipalities must comply with to protect regional water resources from adverse impacts associated with pollutants in stormwater and urban runoff.

An important permit requirement was for the affected cities in the Permit, including Manhattan Beach, to develop and implement an Enhanced Watershed Management Plan (EWMP) and Coordinated Integrated Management Plan (CIMP). As a result, the City of Manhattan Beach partnered with the Los Angeles County Flood Control District and the cities of Hermosa Beach, Redondo Beach and Torrance, and contracted with Geosyntec Consultants to develop such plans consistent with the Permit.

An overview of the applicable Permit provisions will be presented by Geosyntec Consultants along with a status of the EWMP and CIMP.

## **City Utility Staff**

The Utility Division within the Department of Public Works is responsible for the operation and maintenance of the City's water, sewer, and stormwater infrastructure. Utility staff will present an overview of City's water and stormwater system and will discuss how all of the aforementioned systems work together for the City of Manhattan Beach. Presentation and discussion will include:

- A. Potable water system infrastructure, conveyance system and hydraulics; sources of imported water and groundwater supply; relationship with the WRD and West Basin; water conservation ordinance; water conservation efforts; and tiered water rates.
- B. Stormwater conveyance system, in addition to presenting findings of the Storm Drain Condition Assessment (SDCA). The SDCA was conducted using Closed Circuit Television (CCTV) to investigate the current structural and operational conditions of the City's storm drain system. Review and analysis of the CCTV inspections identified recommendations for a Capital Improvement Program for the City's highest risk storm drains. Through the SDCA, recommended capital improvements projects totaling \$4.01 Million were developed and programmed over a 10-year planning horizon.
