SUBJECT:	Consideration of Resolution of Intention to Provide for Annual Levy and Collection of Assessments for the North End Business Improvement District and Setting July 18, 2006 for a Public Hearing

RECOMMENDATION:

The North End Business Improvement District Advisory Board and City staff recommend that the City Council adopt Resolution No. 6039 announcing the City's intention to set assessments for the North End Business Improvement District (BID) for fiscal year 2006-2007, and setting the public hearing for July 18, 2006.

FISCAL IMPLICATION:

There is no budgetary or other financial implication associated with the adoption of the Resolution of Intention.

BACKGROUND:

From 1969 to 2004 a North End Business Improvement District (BID) existed for commercial properties located along the northern portion of Highland Avenue and a few businesses located along Rosecrans Avenue just east of Highland. This BID, formed under the Parking and Business Improvement District Law of 1965, was fairly limited in scope and was mainly used to address parking acquisition and construction.

In December, 2004, Council approved revamped the North End BID because it was apparent that opportunities for increased parking in this section of the community were limited. Additionally, the business owners in this area were interested in using the accumulated funds (now totaling over \$400,000) for business promotional purposes, and to create an identity for the North End. As a result, the old BID was converted from the 1965 law to the 1989 BID law, which permits funds to be used for broad purposes such as marketing, promotions, capital improvements and special events to name a few.

The Parking and Business Improvement Area Law of 1989 requires that the district and the associated assessments be renewed annually. Therefore, at its meeting of July 18, 2006, the City Council will hold a public hearing to consider the request from the Downtown Business Improvement District Advisory Board to renew the district for fiscal year 2006-2007 and levy the associated assessments (80% surcharge on business license fees to a maximum of \$500).

DISCUSSION:

The purpose of the Resolution is to announce the City's intention to renew the BID, establish the method of assessment, outline the activities and services to be funded by the assessment, and to set the date for a formal public hearing (July 18, 2006). The funding for the BID is an 80% surcharge on the business license tax, not-to-exceed \$500 for any individual business.

On May 23, 2006 the North End Business Improvement District Advisory Board met to discuss the proposed service program and associated budget for fiscal year 2006-2007 (meeting minutes are provided as Exhibit "A"). At that time, the Board unanimously approved the FY 2006-2007 program (Exhibit "B") and now request that the City Council consider adopting the Resolution of Intention (Exhibit "C").

If adopted by the City Council, this Resolution of Intention will be circulated to all business owners within the BID, as notification of the public hearing on July 18, 2006. In addition, a notice advertising the public hearing will be placed in <u>*The Beach Reporter*</u>. At the public hearing, all proponents and opponents of the proposed BID will have an opportunity to present information to the City Council.

NORTH MANHATTAN BEACH BUSINESS IMPROVEMENT PROJECT

Enhancement Project and Activity Plan 2006-2007

Location:	 The area generally surrounding the Rosecrans Avenue and Highland Avenue intersection. Specific boundaries are: (north to south) the extent of the Highland Avenue right-of-way from the northernmost City line at 45th Street to 32nd Place on the south: (east to west) the extent of Rosecrans Avenue right-of-way from Bell Avenue to the west side of Highland Avenue
Stakeholders:	North End Businesses – All business license holders in the North End area, with the exception of home-based businesses and commercial property owners.
Improvements And Activities:	A. Capital improvement Project DesignB. Marketing & AdvertisingC. Project ImplementationD. Professional Communications
Method of Financing:	Benefit-based assessments on City Business License Tax
Assessment:	An 80% surcharge on the City Business License Tax not to exceed \$500.00.
Collection of Assessment:	The fees are collected in March/April of each year with the Business License Tax. The funds shall be retained in a designated fund and disbursed through the City.
Governance:	 A City Council ratified Advisory Board serves to make recommendations to the City Council for the North Manhattan Business Improvement District (BID) on such topics as budget and assessments. The Advisory Board consists of seven (7) members composed of business owners located within the boundaries of the BID and elected members. [Current volunteer members: Hal Keasler, Ab Lawrence, Jim Wharton, Paul Dorr, Frank Oliver, Marie Garvey, Muriel Savikas.] It is anticipated that the Advisory Board will meet at least once annually. In delivering BID improvements and activities, the Advisory Board will aim to meet the following objectives: Maximize coordination with the City and other civic organizations to leverage resources; Identify streetscape improvements and create an identity plan for the North End of Manhattan Beach;

	 Manage these projects through a cost-effective and non- bureaucratic organization that may feature the retention of a project manager who works directly with the North Manhattan BID stakeholders; Provide accountability to business owners who pay assessments.
<i>Maintaining the District:</i>	The City Council maintains the district by adopting a Resolution of Intention. A public hearing shall be held not less than 20 or more than 30 days after the adoption of the Resolution of Intention. If there is insufficient protest from owners representing over 50% of the assessments to be paid, the BID assessment will continue.
Benefits of the District:	 The BID allows for streetscape, signage and landscape improvements, and creation of a North Manhattan identity through integrated marketing efforts such as promotions, banners throughout the area and advertising. The BID shall provide key promotional and organizational support through a variety of functions that directly benefit its ratepayers as well as the City. Such as: Hiring a project manager to ensure the development of the goals of the BID; Enhancing the appearance of North Manhattan through signage, landscaping, and curb and sidewalk upgrades; Establishing and implementing a North Manhattan vision, a beautification image that is in line with the rest of Manhattan Beach and one that reflects the good health and economic vitality of the entire city, making the city an attractive venue for business; Providing an inclusive link to the north end of the city.

ENHANCEMENT PROJECT AND ACTIVITY PLAN

As a result of the concerns of business owners and residents through numerous meetings, the BID proposes the following plan:

A. **Project Design**

• Develop streetscape improvement and identity plan in the north end;

- Create public works improvements that ensure each incremental project in the north end incorporates the larger vision and coordinates street furniture and equipment at time of replacement;
- Create façade improvement and program with overall signage and color guidelines;
- Improve aesthetics of the public and private realm by providing the framework of a larger urban plan and vision;
- Research and review traffic model/flow/need;
- Allow traffic to move through the north end with improvements to intersections and signal timing;
- Focus on improving this area as an interesting and safe pedestrian environment for the local residents;
- Address the safe and practical cohabitation of vehicular traffic with pedestrians;
- Compile a comprehensive inventory and future strategy for parking;
- Continue to research traffic flow facilitation in the north end;
- Work with the City to collaborate on the long-range plan of the City.

B. Marketing & Advertising

- Develop a program wide marketing and advertising identity to promote the North Manhattan area as a Gateway to the City;
- Create a new 'sense of place' which draws on the unique character of the natural, man-made, and cultural heritage of the north end;
- Work with residents and business owners alike to retain and underscore a pride in the updating and development of the north end;
- Work with the City to collaborate on enhancing the North Manhattan community environment.

C. **Project Implementation**

- Hire a Project Manager to obtain costs, prepare a budget and initiate the design and implementation of the identity for the Project;
- Subcontract a Graphic Designer to create the following:
 - Logo Design
 - Banners
 - Posters
 - Flyers

Gateway Signage;

- Initiate Banner printing/production/space planning;
- Position Posters in business windows;
- Distribute flyers to the neighborhood;
- Conduct inventory study of parking in the north end;
- Preserve existing parking supply of parking along street;
- Research cross-utilization of businesses for parking needs;
- Implement flag and banner programs for the north end identity;

- Coordinate with public works department of the City the placement of signage, redesigns for crosswalk, landscaping and medians and other long-range improvements;
- Project Manager to obtain specifications on Pole Signage/Lightbox and Overstreet Signage and consult with Public Works Department;
- Project Manager to prepare and present budget analysis to BID;
- Committee to assess status of funding with City and direct Project Manager to begin Signage/pole/landmark and streetscape Production as Budget allows;

D. Professional Management & Communications

- Maintain professional management to ensure the project success and implementation of the north Manhattan Enhancement Project and Activity Plan;
- Maintain communication with north end business owners and the City;
- Continue informing north end business owners and residents of important issues affecting North Manhattan;
- Provide representation to help mitigate traffic, construction and parking issues.

ENHANCEMENT IMPROVEMENT & ACTIVITY PLAN BUDGETS

I. EXPENSES

A. 2006 Operating Budget - \$370,000

- Identity formation and development and implementation of signage and banners.
- Design and coordinate crosswalk improvements to coincide with street resurfacing.

II. INCOME

A. 2006-2007 Operating Budget

• \$12,000 collection from North End businesses.

III. SURPLUS FROM PREVIOUS FICAL YEAR

• \$427,607

RESOLUTION NO. 6039

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANHATTAN BEACH, CALIFORNIA, DECLARING ITS INTENTION TO PROVIDE FOR ANNUAL LEVY AND COLLECTION OF ASSESSMENTS FOR THE NORTH END BUSINESS IMPROVEMENT DISTRICT, PURSUANT TO SECTION 36500 OF THE STREETS & HIGHWAYS CODE OF THE STATE OF CALIFORNIA AND SETTING A TIME AND PLACE FOR PUBLIC HEARING THEREON

WHEREAS, this City Council has previously formed a Property and Business Improvement District in North End Manhattan Beach, pursuant to Streets and Highways Code Section 36500 et. seq. (SB 1424 - Parking & Business Improvement Law of 1989, Chapter 2); and

WHEREAS, the North End Business Improvement District Advisory Board met on May 23, 2006 and unanimously supported the proposed operating program and budget of the North End Business Improvement District for FY 2006-07; and

WHEREAS, this City Council is desirous of continuing the assessment on businesses within the Parking & Business Improvement District to allow the business owners within the District to utilize the funds for a range of services and activities that will promote and enhance the North End of Manhattan Beach.

NOW, THEREFORE, BE IT RESOLVED THAT THE CITY COUNCIL OF THE CITY OF MANHATTAN BEACH, CALIFORNIA, DOES HEREBY DECLARE, FIND, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. The above recitals are true and correct.

<u>SECTION 2</u>. The Business Improvement District is known as the North End Business Improvement District (herein referred to as District).

<u>SECTION 3.</u> The District physical boundaries include all operating businesses along Highland Avenue from 45th Street to the North and to 32nd Place to the South, and along Rosecrans Avenue from Highland Avenue to the West to the 500 block of Rosecrans to the East. A map identifying the specific, legal boundary for the Manhattan Beach North End Business Improvement District is available for review in the Office of the City Clerk.

<u>SECTION 4</u>. All businesses within the boundaries of said District as described herein are subject to the provisions of the additional assessment which will be levied annually to pay for all improvements and activities within the District.

<u>SECTION 5</u>. The assessment methodology for funding the services and activities of the North End Business Improvement District shall be a surcharge of 80% on the business license tax, not to exceed \$500.00 per business license.

<u>SECTION 6</u>. The funds generated by the business license surcharge shall be use for the following purposes:

Parking & Transportation Marketing and Promotions Special Events Management Services

<u>SECTION 7</u>. The City Council shall convene a Public Hearing regarding the levying of assessments by the North End Business Improvement District on July 18, 2006 at 6:30 p.m. in the City Council Chambers located at 1400 Highland Avenue in said City. At that time, the City Council will hear testimony of all interested parties for or against the levying of assessments by the District, the extent of the District, and/or the activities and services which shall be provided through the District.

SECTION 8. This Resolution shall be circulated to each business owner within seven (7) days of the date of adoption by the City Council.

SECTION 9. The City Clerk shall make this Resolution reasonably available for public inspection within thirty (30) days of the date this Resolution is adopted.

<u>SECTION 10</u>. The City Clerk shall certify to the adoption of this Resolution and thenceforth and thereafter the same shall be in full force and effect.
