Finance

Council directed staff to return at a future meeting with background information on the Chamber of Commerce surcharge that is added on to business licenses.

Council held general discussion on performance measurements and service indicators and Staff committed to a renewed focus of these measurements in the coming year with revisions in the next (FY 2007-2008) budget.
