SUBJECT: Investment Portfolio for October 2015

RECOMMENDATION:

Staff recommends that the Finance Subcommittee accepts the status report on the City's investment portfolio as of October 31, 2015.

FISCAL IMPLICATION:

There are no fiscal implications associated with the recommended action. As of October 31, 2015, the City's investment portfolio totaled \$85.2 million in book value (\$84.8 million par value).

DISCUSSION:

Since the last update as of the May 2015, the City's investment portfolio has decreased \$9.4 million in par value. Consistent with prior years, normal operating activities (warrant and payroll coverage) contributed to the decrease in portfolio value. The first five months of the fiscal year typically operate at a deficit until December and January when Property Taxes are received. Property Tax receipts in excess of \$10.0 million are anticipated in December and January.

During the May through October time period, yields on securities have not shown dramatic improvement from the prior months. Ten government and high-grade medium-term corporate securities totaling \$12.0 million were purchased to maintain diversity in the portfolio. Several securities were redeemed, including two called federal agency securities, one medium-term corporate note, and nine Certificates of Deposit. Redeemed investments since June 1 totaled \$6.7 million.

Market conditions and investment opportunities are monitored regularly. Efforts are made to ensure the portfolio is well-balanced for the safety of principal by investing in high-grade securities that are diversified in origin and maturity date.


