## **2. Approval of Minutes from the January 6, 2016 North MB BID Meeting**

- 3. Proposed Placement of New Trees in North MB** – Keith Darling, Maintenance Manager with the City explained that the ADA code will have to be followed for all public sidewalk areas. There must be no hindrance to public right of way with respect to trees. All tree well cut-outs/squares/grates will have to be uniform in size and consistent. North Manhattan Beach aluminum signs will all be re-supported due to recent high winds. The Board will do the tree counts, measure the cut-outs and get adjustable grates to accommodate the tree growth.

Discussion of North MB BID Parking Opportunities on Weekends and Busy Points During the Year** – Per information received from City Public Works management staff, North Manhattan Beach business customers can use the City Yard for parking (as available) at a 2 hour time limit or posted time limit during the weekends.
