#### SUBJECT:

Salute to the Troops Event and Community Sunscreen Lotion Dispensers (Parks and Recreation Director Leyman).

## **RECOMMENDATION:**

Staff recommends that the Parks and Recreation Commission discuss the Salute to the Troops event and community sunscreen lotion dispensers to gather information and provide recommendations to the City Council.

#### FISCAL IMPLICATIONS:

There is no fiscal implication associated with this request.

#### **BACKGROUND:**

At the October 20, 2015 City Council meeting, the City Council approved two discussion items for the Commission to discuss: the Salute to the Troops Event and community sunscreen lotion dispensers.

#### **DISCUSSION:**

The Parks and Recreation Commission requested permission to discuss the Salute to the Troops Event so they may begin planning for the 2016 event, and the sunscreen lotion dispensers to evaluate a possible pilot program within the community (Attachment 1).

#### Salute to the Troops

The Commission would like to continue in their planning and support of the Salute to the Troops event, and therefore would like to begin discussions now for the 2016 event. The Commission will continue to provide outreach for sponsorships and has proposed a 2016 event date of Sunday, July 3, 2016. For the 2015 event, the Commission raised over \$20,000 in sponsorships, which covered all of the event expenditures.

## Sunscreen Lotion Dispensers

The Commission would like discuss and explore options for City Council consideration of a sunscreen lotion dispenser pilot program in the community. The Commission will research the possibility of installing the dispensers at elementary school and various locations in the City. Research will include costs, number of dispensers and sponsorship to pay for ongoing expenses.

## **CONCLUSION:**

Staff recommends that the Parks and Recreation Commission discuss the Salute to the

Troops event and community sunscreen lotion dispensers to gather information and provide recommendations to the City Council.

## 15/1027.1 Discussion of Salute to the Troops 2016 Event –

Commissioners Jones and Paralusz gave a brief history and background of the event to new commissioners Karger and Turkmany. Commissioner Jones reviewed the event program schedule.

Commissioner Jones asked the Caskeys if they would distribute their lawn flags with the Salute to the Troops ad next year. They agreed to do that and also offered a donation for the current event.

Dennis McNeil approached the podium to confirm program details and reported that the first half of the show will be more traditional patriotic and the second half is designed to get people dancing. The schedule was finalized.

Dennis McNeil mentioned that if there is sponsorship money in the budget for compensation, it would be accepted.

Commissioners Jones and Paralusz thanked Mr. McNeil for his involvement in the project.

Commissioner Paralusz stated that she was disappointed that the City Council decided not to move forward with the sunscreen project and thanked Commissioner Jones for the work that she did on the project.
