SUBJECT: Consideration of Options for Changing the Title of Mayor Pro Tem

RECOMMENDATION:

Staff recommends that the City Council discuss the title of Mayor Pro Tem and provide further direction.

FISCAL IMPLICATION:

There are no fiscal implications associated with staff's recommendation.

BACKGROUND:

At the Council meeting of April 5, 2005, the City Council directed staff to return with information about the title of Mayor Pro Tem, including options for changing that title.

DISCUSSION:

The phrase "pro tem" is Latin for "pro tempore" and means "temporarily assuming the duties of another" or "for the time being." Synonyms include "acting, interim, provisional, and temporary." Common titles incorporating this phrase include: President Pro Tem of the Senate, Judge Pro Tem, and Pro Tem Speaker of the House.

Section 34905 of the California government code includes the title of Mayor Pro Tem. Since the city of Manhattan Beach is a general law city, we are subject to the California government code and therefore are required to have such a title/position which cannot legally be changed. The Council could informally change the title for local usage by resolution or minute vote; our research found that there are several general law cities in California who use alternative titles including Oceanside, Solano Beach and Ventura who use the title of Deputy Mayor, and Lancaster, Beverly Hills and Brentwood who use the title of Vice Mayor.

Staff researched titles used by other cities in California; we received information on 191 cities (see attachment "A"). Of those, 64% (123 cities) use the Mayor Pro Tem title; all of the South Bay cities, excluding the city of Los Angeles (who uses President and President Pro Tem) use this title.

The second most common title was Vice Mayor, with 32% (61 cities) using this title. Five (3%) of the cities surveyed use the Deputy Mayor title and two (1%) use President Pro Tem (Los Angeles and Fresno).

The term "vice" when used as a prefix means "one who acts in the place of another" or "rather than." Synonyms include "associate and secondary." Common titles incorporating this word include: Vice Chancellor, Vice Chairman and Vice President.

The term "deputy" means "a person appointed as a substitute with power to act." Synonyms include "delegate, representative and proxy." Common titles incorporating this word include: Deputy Sheriff, Deputy Minister and Deputy Secretary of Defense.

CONCLUSION:

Staff has provided information about the title of Mayor Pro Tem along with alternatives and is asking that the City Council discuss and provide further direction.
