DISCUSSION:

Strand Improvement Project Progress Payment No. 1

The Contractor has completed 1% of the construction contract. Work accomplished includes demolition of the westerly curb area for Phase I (45th Street to 36th Street) of the project. The Contractor has also removed all of the existing light poles and fixtures in that area.

The Contractor is currently proceeding with installation of storm drain pipe and construction of the westerly concrete curb. As construction of the westerly curb progresses, the Contractor will install electrical conduit and construct the new concrete light pole footings, bench alcoves, and trash receptacle pads.

The Contractor has submitted a request for Progress Payment No. 1 in the net amount of \$39,019.50. All work items covered by this payment have been reviewed by the Public Works Department and found to be in conformance with the plans, specifications, and the approved schedule of values.

El Porto Retaining Wall Project Progress Payment No. 2

The Contractor has completed 45% of the construction contract. Work accomplished since the last progress payment includes construction of approximately 300 linear feet of concrete retaining wall.

The Contractor is currently installing rebar and placing forms.

The Contractor has submitted a request for Progress Payment No. 2 in the net amount of \$167,122.56. All work items covered by this payment have been reviewed by the Public Works Department and found to be in conformance with the plans and specifications.
