### **RECOMMENDATION:**

Adopt Resolution No. 17-0058 repealing Resolution No. 16-0032 to return to the City's prior practice of interviewing, appointing, and voting for Commissioners, Board Members and Committee Members.

### **FISCAL IMPLICATIONS:**

There are no fiscal implications associated with the recommended action.

### **BACKGROUND:**

At the April 20, 2016 City Council Meeting, the City Council adopted Resolution No. 16-0032 to change the interview, appointment and voting process for City Boards, Commissions and Committees.

### **DISCUSSION:**

At the April 18, 2017 City Council meeting, City Council directed staff to bring back a resolution for its consideration to repeal the interview process modified by Resolution No. 16-0032. Prior to 2016, the City Council has used a "one-on-one" process to interview board and commission candidates, and the Council would like to return to that format. Repealing Resolution No. 16-0032 allows the City Council to return to that practice, and provides greater flexibility to change the process in the future.

A RESOLUTION OF THE MANHATTAN BEACH CITY COUNCIL REPEALING RESOLUTION NO. 16-0032 REGARDING THE APPOINTMENT PROCESS FOR CITY COMMISSIONERS, BOARDMEMBERS AND COMMITTEE MEMBERS

WHEREAS, the City Council adopted Resolution No. 16-0032 on April 19, 2016 modifying the City's traditional interview, appointment and voting process for commissioners, boardmembers, and committee members;

WHEREAS, the City Council would like to return to its traditional appointment practice; and

WHEREAS, on April 18, 2017, the City Council directed staff to draft a resolution to repeal Resolution No. 16-0032 to resume its traditional appointment process and provide greater flexibility in the future.

NOW THEREFORE, THE MANHATTAN BEACH CITY COUNCIL HEREBY RESOLVES AS FOLLOWS:

Section 1. The City Council hereby repeals Resolution No. 16-0032.

<u>Section 2</u>. This Resolution shall take effect immediately upon adoption.

### **RECOMMENDATION:**

Adopt Resolution No. 17-0059 amending the membership requirements set forth in existing resolutions governing the Parks and Recreation Commission, Library Commission, and Cultural Arts Commission.

### **FISCAL IMPLICATIONS:**

No fiscal implications associated with the recommended action.

### **BACKGROUND:**

At the April 18, 2017 City Council meeting, staff presented the Modernized and Updated Boards and Commissions Handbook for City Council review. While the final version of the Boards and Commissions Handbook has not been approved, the City Council discussed the recommended changes to the membership requirements to the Parks and Recreation Commission, Library Commission, and Cultural Arts Commission.

### **DISCUSSION:**

In order for the proposed changes to the Parks and Recreation Department Commissions membership to be implemented, the City Council must adopt Resolution No. 17-0059. Resolution No. 17-0059 formally authorizes the City Council to amend the membership requirements set forth within existing resolutions that govern the Parks and Recreation Commission, Library Commission, and Cultural Arts Commission. A summary and reasoning for the membership amendments are detailed below.

### Refined Language for the Parks and Recreation Commission Membership

The Parks and Recreation Commission has one seat represented by a student serving a one year term. Language has been refined for the student representative seat on the Parks and Recreation Commission to open the opportunity to all High School students regardless of whether they attend Mira Costa High School. The student representative must still be a Manhattan Beach resident and will now be appointed by the City Council instead of the Mira Costa High School Principal.

Adding Student Representative Seat to Library Commission and Cultural Arts Commission The Library Commission and Cultural Arts Commission currently consist of five members. Resolution No. 17-0059 amends the membership requirements for each commission to reflect the City Council approved change to six members. The City Council also approved the designation of the sixth seat to be that of a Student Representative. A Student Representative was considered to strengthen the collaboration with the Manhattan Beach Unified School District.

The Library Commission is attempting to partner with school district librarians and a student representative would provide a new perspective and further engage the community's youth in providing library services that are the highest utilized in Los Angeles County.

The Cultural Arts Commission has been focusing its efforts on developing programs for High School Students. The Cultural Arts Commission is currently collaborating with High School on four different programs: Curator tours, annual student art exhibition, StArt Projects, and the summer music program. Adding a student representative to the Commission would strengthen the collaboration and give the Cultural Arts Commission a new perspective on the needs of young people in the community

Following City Council adoption of Resolution No. 17-0059, staff will return to City Council with an ordinance amending Section 2.44.030 of the Manhattan Beach Municipal Code to maintain policy consistencies between both governing documents.

### **RESOLUTION NO. 17-0059**

A RESOLUTION OF THE MANHATTAN BEACH CITY COUNCIL AMENDING THE MEMBERSHIP REQUIREMENTS OF PARKS AND RECREATION COMMISSION, LIBRARY COMMISSION, AND CULTURAL ARTS COMMISSION

THE MANHATTAN BEACH CITY COUNCIL RESOLVES AS FOLLOWS:

<u>Section 1</u>. The City Council hereby amends Section 4 (Membership) of Resolution No. 6242 regarding the Parks and Recreation Commission to read as follows:

### MEMBERSHIP.

- (a) The Commission shall be composed of seven residents of the City of Manhattan Beach, appointed, and subject to removal by a majority of the City Council.
- (b) Commissioners No. 1, No. 3, No. 4, and No. 6 shall be members-at-large nominated and appointed by the City Council.
- (c) Commissioner No. 2 shall be nominated by the Board of Trustees of the Manhattan Beach Unified School District and thereafter appointed by the City Council at its discretion.
- (d) Commissioner No. 5 shall be an "Older Adult" (55+ years of age) nominated and appointed by the City Council.
- (e) Commissioner No. 7 shall be a high school student appointed by the City Council at its discretion and shall serve for a term of one year.
- <u>Section 2</u>. The City Council hereby amends Section 1 (Membership) of Resolution No. 6136 regarding the Cultural Arts Commission to read as follows:

### MEMBERSHIP.

- (a) The Commission shall be composed of six residents of the City of Manhattan Beach, appointed and subject to removal by a majority of the City Council.
- (b) Commissioner No. 1 shall be selected by City Council with art experience. This commissioner shall possess knowledge about contemporary visual, performing, or literary arts; be capable of engaging effectively in a committee process; and be open minded and responsible.
- (c) Commissioners No. 2, No. 3, No. 4, and No. 5 shall be members-at-large nominated and appointed by the City Council. These commissioners shall be individuals interested in the arts; be capable of engaging effectively in a committee process; and be open minded and responsible.

- (d) Commissioners No. 6 shall be a high school student appointed by the City Council at its discretion and shall serve for a term of one year.
- (e) Gallery owners, dealers, producers, agents, and other profit-orientated intermediaries are not eligible for appointment to the commission.
- <u>Section 3</u>. The City Council hereby amends Section 3 (Membership) of Resolution No. 5363 regarding the Library Commission to read as follows:
- (a) The Commission shall be composed of six residents of the City of Manhattan Beach, appointed, and subject to removal, by a majority of the City Council.
- (b) Commissioners No. 1, No. 2, No. 3, No. 4 and No. 5 shall be members-at-large nominated and appointed by the City Council.
- (c) Commissioners No. 6 shall be a high school student appointed by the City Council at its discretion and shall serve for a term of one year.
- <u>Section 4</u>. The City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.

### **RECOMMENDATION:**

   (1 Member-at-Large, 1 Student Representative)
- Parks and Recreation Commission 3 Seats
   (1 Member-at-Large, 1 Manhattan Beach Unified School District Nominee, 1 Student Representative)
- Parking and Public Improvements Commission 3 Seats
   (2 Members-at-Large, 1 Business Community Member)
- Planning Commission 3 Seats (3 Members-at-Large).

Included in the staff report is the list of interested applicants to date. However, additional applicants may apply to the City's Boards and Commissions from the time the agenda packet is distributed to the application deadline, which is currently set for May 1, 2017 at 12:00 PM. Therefore, a supplemental document will be distributed prior to the interviews if the City receives additional applications.

### **FISCAL IMPLICATIONS:**

No fiscal implications associated with the recommended action.

### **BACKGROUND:**

In preparation for the upcoming Boards and Commissions appointments, the City Clerk's Office and staff liaisons have been in contact with current commissioners regarding upcoming vacancies.

In addition, the City Clerk's office placed advertisements in the March 9, 2017, April 13, 2017, and April 20, 2017 editions of the Beach Reporter, posted notices on the City's website (www.citymb.info), the City's posting boards, placed a home page slide on the City's website, posted on the City's Facebook and Twitter pages seven times each, and e-notifications were sent asking community members to apply for upcoming vacancies on the City's Boards and Commissions.

### Historic Preservation Commission and Board of Building Appeals:

Based on City Council direction at the April 18, 2017 City Council meeting, appointments to the Historic Preservation Commission and Board of Building Appeals has been postponed until City Council discussion at the June 20, 2017 City Council meeting.

### **DISCUSSION:**

### Cultural Arts Commission:

The Cultural Arts Commission is responsible for the continued development and implementation of the master plan for cultural arts in the City, encouraging and supporting art education programs in the community and schools, visual and performing arts and Art in Public Places. Pending City Council approval of Resolution No. 17-0059 at the May 2, 2017 Adjourned City Council Meeting, the Commission will consist of six (6) members: four (4) members selected at-large, one (1) member selected as an artist representative, and one (1) student representative. The Commission meets the 3rd Monday of every month at 6:00 PM.

### Parks and Recreation Commission:

The Parks and Recreation Commission serves in an advisory capacity to the City Council regarding the recreational needs of all citizens, and promotes supervised public recreation within the City. The Commission consists of seven (7) members: five (5) at large members, one (1) representative from the Manhattan Beach Unified School District and one (1) student representative. The Commission meets the 4th Monday of every month at 6:00 PM.

### Seat No. 2 - Manhattan Beach Unified School District Nominee

Seat No. 2 is a seat nominated by the Manhattan Beach Unified School District currently held by Kathleen Paralusz. Commissioner Paralusz's term will expire on May 31, 2017 and has indicated she will not apply for re-appointment to this specific seat but has applied for Seat No. 3 discussed below. At the time of the printing of this report, the Manhattan Beach Unified School Board has not nominated a new individual. City Council is required to ratify the appointment to Seat No. 2 for a three-year term (June 1, 2017 - May 31, 2020). ### Planning Commission:

Pursuant to California Planning and Zoning Law and the California Environmental Quality Act (CEQA), the Planning Commission considers land use applications such as use permits, variances, planned development permits, CEQA, and appeals of certain decisions made by the Directors of Community Development, and recommends to the City Council zone changes, code amendments, and modifications to long-range planning documents, including but not limited to the City's General Plan and Local Coastal Plan. The application deadline extension notice was posted on the display boards at City Hall, posted to the City's website, and posted on the City's Facebook and Twitter pages multiples times once again.

### **ENVIRONMENTAL REVIEW**
