**SUBJECT:** Recite the Facts and Declare the Results of the March 8, 2005 General Municipal

Election

#### **RECOMMENDATION:**

It is recommended that the City Council adopt Resolution No. 5969 which recites the facts of the General Municipal Election held in Manhattan Beach on March 8, 2005, declaring the results and such other matters as are provided by law.

#### FISCAL IMPLICATION:

There are no fiscal implications associated with the recommended action.

#### **BACKGROUND:**

On February 25, 2005 a Notice of Appointment of Absent Voter Ballot Canvassing Board was posted identifying that a canvass is to be completed by the City Clerk's Office prior to the second Tuesday following the Election and whereby certification of those results shall be made to the City Council by the second Tuesday following the election.

#### **DISCUSSION:**

On March 10, 2005 staff conducted the canvass of the March 8, 2005 General Municipal Election. Please find attached, for Council approval, a true and correct *Canvass Certificate*.

#### RESOLUTION NO. 5969

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANHATTAN BEACH, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD ON TUESDAY, MARCH 8, 2005, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Manhattan Beach, California, on Tuesday, March 8, 2005, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the City Clerk canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MANHATTAN BEACH, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the precincts except absent voter ballots and provisional ballots was 4,341. That the whole number of absent voter and provisional ballots cast in the City was 2,743. That the total number of ballots cast in the City was 7,084.

SECTION 2. That the names of persons voted for at the election for Member of the City Council are as follows:

SECTION 3. That the names of persons voted for at the election for City Treasurer are

as follows:

SECTION 4. The City Council does declare and determine that Nick Tell, Jim Aldinger and Richard P. Montgomery were elected as Members of the City Council for the full term of four years and that Tim Lilligren was elected as City Treasurer for the full term of four years.

 $\underline{\text{SECTION 5}}$ . That the following measure ("Measure 2005-A") was submitted to the electors of said City, to wit:

"SHALL AN ORDINANCE BE ADOPTED WHICH REPEALS EXISTING TERM LIMITS FOR CITY COUNCILMEMBERS?"

<u>SECTION 6</u>. That the total number of votes cast on said Measure 2005-A is as follows:

YES: 957 NO: 5,701

SECTION 7. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates and for and against the measure were as listed in "Exhibit B" attached.

SECTION 8. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of ballots cast in the City; (2) The names of the persons voted for; (3) For what office each person was voted for; and (4) The number of votes given at each precinct to each person.

SECTION 9. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 10. That this resolution shall take effect immediately. The City Clerk shall make this resolution readily available for public inspection within thirty (30) days of the date this resolution is adopted.

SECTION 11. That the City Clerk shall certify to the passage and adoption of this resolution and thenceforth and thereafter the same shall be in full force and effect.
