Dear Mr Masters,

Thank you for taking the time this morning to meet with me at the building department to go over the proposed AT&T plans for adding new cell towers in Manhattan Beach.

We are very concerned with the proposed installation located at the North west corner of 36th Street and Manhattan ave, and the proposed equipment cabinet at the South/ East side of 36th Street just above the corner.

Our concerns are that it will not only impend my wheelchair travel to this corner, but also the proposed Lamp post / cellular additions which are mounted on the new post, so near our home pose a very troubling concern about the amount of Radiation that they emit and their proximity to our second and third floor windows.

I know that you are far more educated in the field of cellular towers than I, and that you personally have been working on this very project for many months so when I tell you about the many discussions concerning the amount of RF in relation to the proximity to buildings and people it comes to no surprise that these types of installations should be best kept as far away as possible from structures as possible.

Although these devices proposed are mounted atop street light poles where they are high above street Level, in our case our home is Three Stories and the actual devices will be in very close proximity to our living space and more concerning our windows which we fear will offer little to no protection from the damaging RF.

I urge you and the City Council to please review our concerns and continue to work with AT&T to find a safer more satisfactory location for these towers.
