

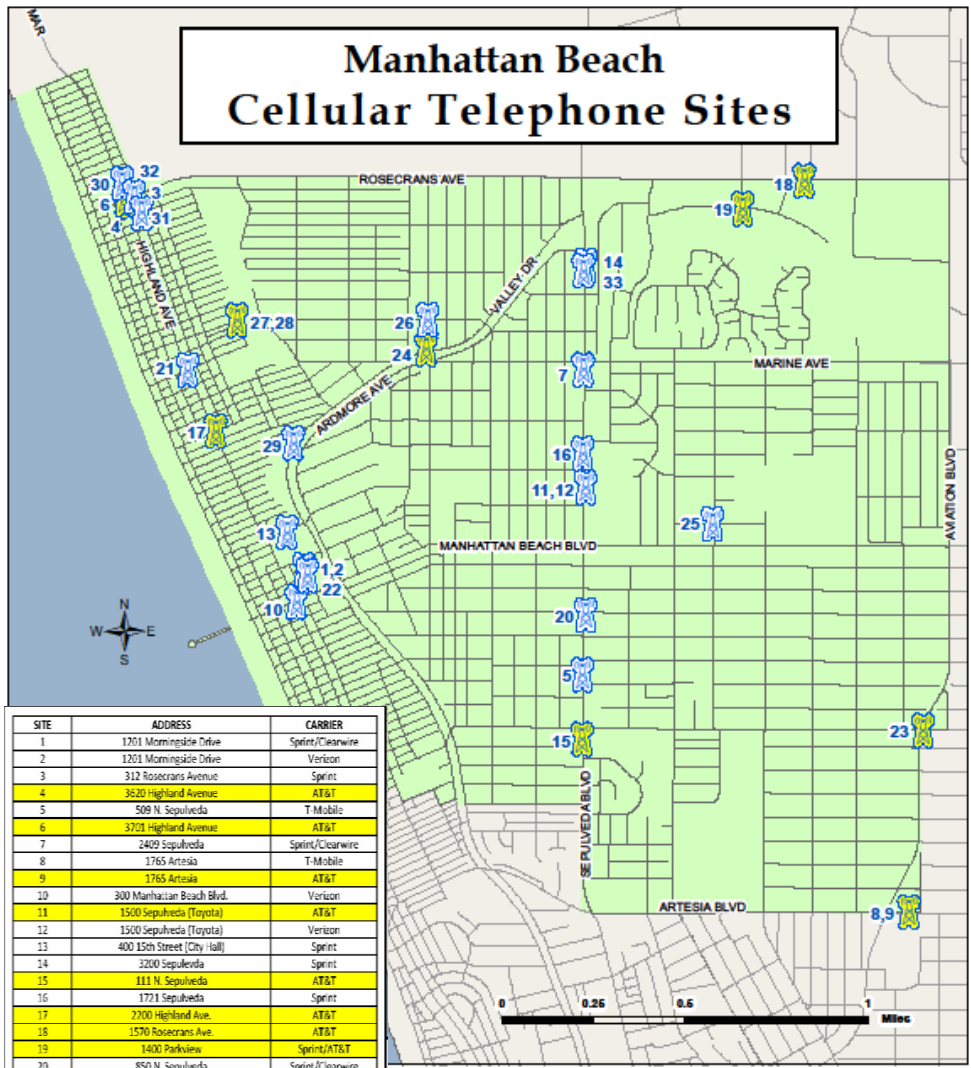

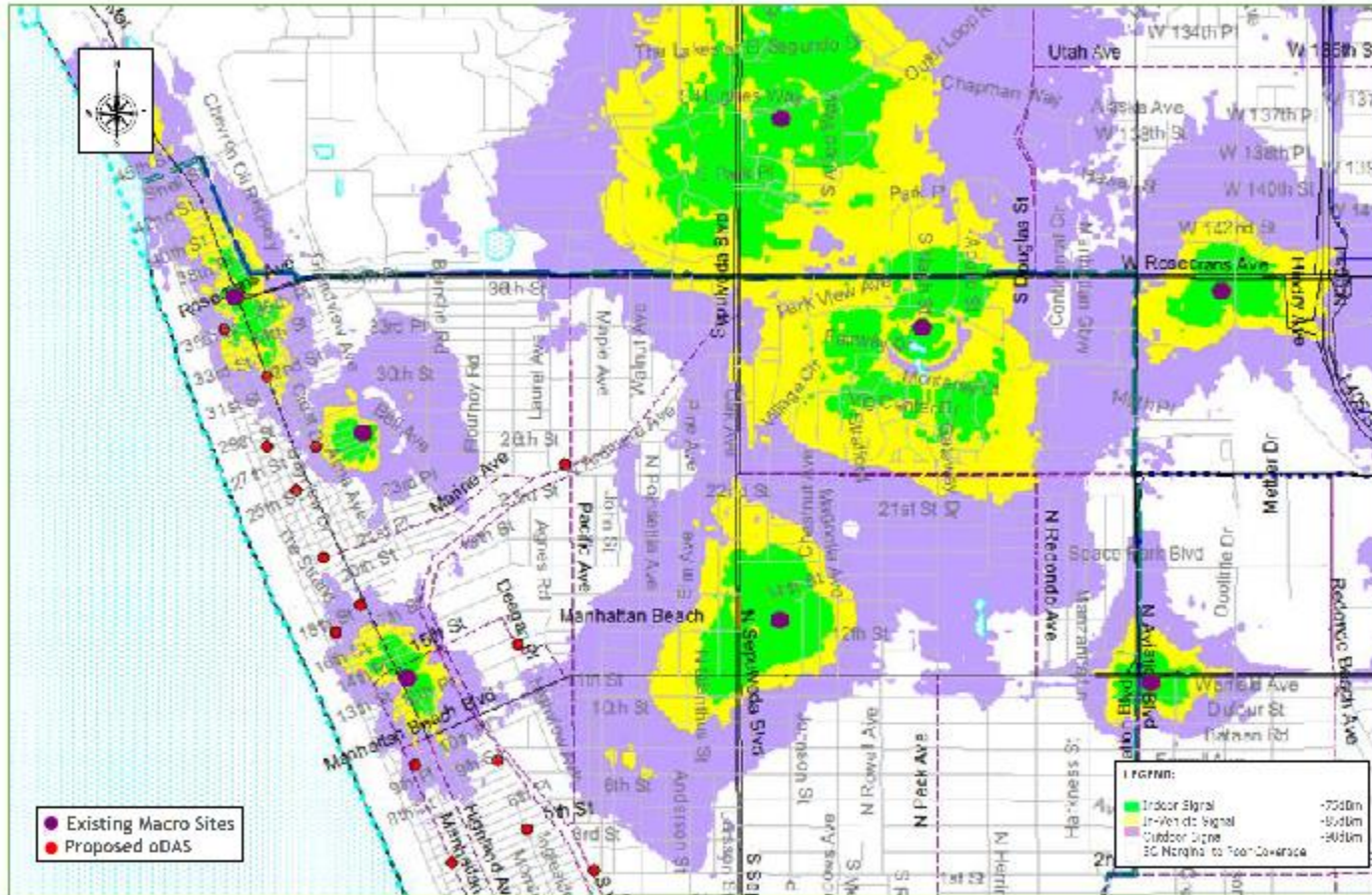

LTE Existing Macro - Coverage

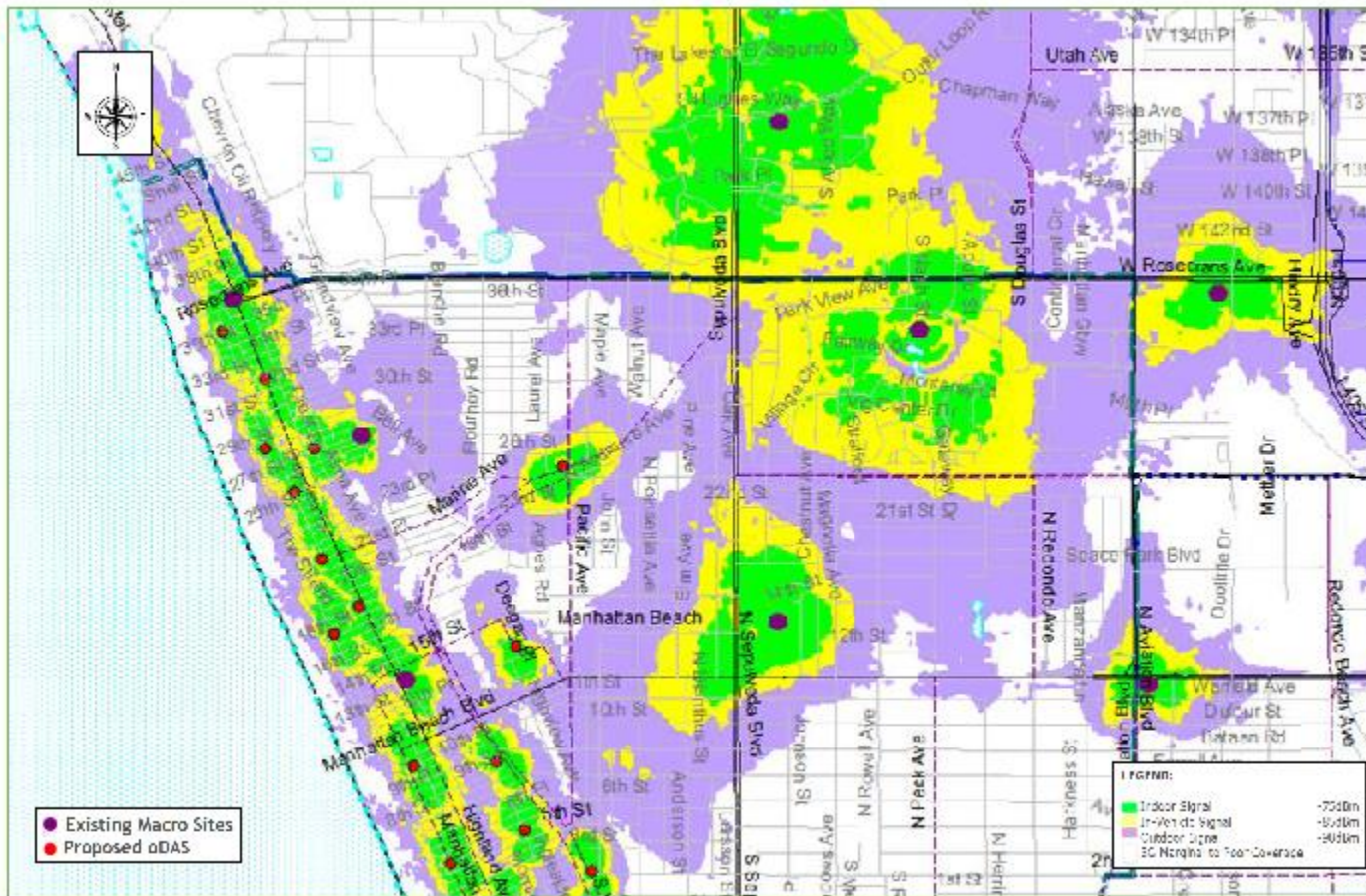
