SUBJECT: Presentation of Proposed Downtown Streetscape Improvements

RECOMMENDATION:

Staff recommends that the City Council receive this presentation of proposed improvements to the downtown Streetscape area, discuss the issues and provide direction to staff.

FISCAL IMPLICATION:

It is estimated that appropriations in the amount of \$100,000 from the Gas Tax Fund (\$50,000) and General Fund (\$50,000 from the City Council Contingency) will be required to complete this project. An additional \$20,000 would be expended from various budgeted operating accounts.

BACKGROUND:

In July of 2004, the City received a letter from the Downtown Manhattan Beach Business and Professional Association (DMBBPA) requesting the City to consider making some improvements to the aesthetics of the downtown. The letter points out that with the upcoming completion of the Community Plaza that the downtown may look a little worn in comparison.

Since the receipt of that letter City staff has met with Carol Rowe, the Executive Director of the DMBBPA to clarify the priorities in the request letter. In addition, staff has met to discuss the feasibility and preliminary costing of items requested by the DMBBPA. One improvement on the list, replacing string-lighting in the trees with up-lighting, has already taken place. The City Council approved this modification at its October 19, 2005 meeting. The cost of this improvement was approximately \$12,500. However, staff believes this lighting change will save at least this much in maintenance cost per year because it was very labor intensive to remove and replace the string-lighting during tree the tree trimming operation.

DISCUSSION:

Below is a chart of improvements divided into three categories. The first category is minor improvements which have relatively low costs and can be completed within approximately six months (to coincide with Metlox/community plaza completion). The second category is other improvements which will add to the aesthetics of the downtown, but for which a funding source has not been identified. The third category includes higher cost items which have been discussed

between the DMBBPA and City Staff but which have not been estimated nor has a funding source been identified.

Category I Proposed for Funding

The issue at hand is whether the appropriation and subsequent expenditures of these funds takes priority over other needs. The Streetscape improvements were constructed in 1989. After 15 years many of the improvements and landscaping material is in need of refurbishment or replacement. The members of the DMBBPA have expressed concern that the newness of the Metlox commercial development along with the Community Plaza will highlight the age of the existing downtown improvements.

It should be noted that if approved, slurry seal work will require downtown streets to be completely closed for most of one day.

CONCLUSION:

The Downtown Manhattan Beach Business and Professional Association has requested that the City contribute to a facelift of some of the Streetscape Improvements. Staff proposes that Category 1 improvements would be an appropriate level of expenditure given current budget constraints while assisting the Downtown with some of their requests.

ALTERNATIVES

One alternative is to use no City funds for these improvements and ask the DMBBPA to consider an increase in their Business Improvement District (BID) assessment to fund any improvements.
