3. Approval of Minutes from the March 6, 2019 North MB BID Meeting -

Street closure would cost a considerable amount, the Advisory Board discussed and voted not to spend the monies to close Highland Ave. for the Christmas event, but consider the alternative idea to close some spots on Highland Ave. for vendors and local businesses. This plan was approved by the Fire and Police departments, as well as the City Engineer during a meeting in January 2019. The Committee will contact possible vendors and local businesses and decide how many areas to set aside for the event. The date of the event, December 7 or 14, 2019, will be discussed and voted on at the April 2019 meeting (City MB fireworks is scheduled to take place on December 8, 2019).
