### 9. 2019 Events

E. Zandvliet, CMB Traffic Engineer and Lt. Harrod, CMB Police, discussed different safety options for the Holiday Stroll and opening up more area for vendors. The best option is to block the event area and parking spots with barriers on Highland Avenue. The three areas approved by the City were given to the Committee for discussion and vote at the June 2019 meeting. Chairman McCleary mentioned that since the CMB now owns the electric street light poles, to use ornaments that light up instead of just regular ornaments. This item will be discussed and voted on at the June 2019 meeting.

#### 10. Leadership Manhattan Beach AED Donation

Sgt. Kitsios, CMB Police, spoke about installing AED units in police cars, as well as in locations throughout the city. The goal is to install 2 -3 unit in the North MB area and asked if North MB BID would contribute towards the purchase of these units. The BID Committee agreed to fund the purchase of 2 units.

#### 11. North Manhattan Beach BID By-Laws Correction

The BID committee agreed and unanimously approved to the correct and change the By-Laws to read that 50% of board members must be present in order to have a quorum to hold a meeting.
