- <u>Public Comments</u> –Burt Fuller, MB resident expressed that it is dangerous to cross 41<sup>st</sup> and Highland due to the two lane traffic transition into a single lane; he asked that the North MB BID to assist in getting a lighted crosswalk. - 3. <u>Approval of Minutes from the July 3, 2019 North MB BID Meeting</u> -The North MB BID Board unanimously approved the minutes of the July 3, 2019 meeting.
- 4. <u>Tree Grates Installation and Replacement of Trees (replant existing to other locations) Ernest Area,</u> <u>CMB Arborist and Erik Zandvliet, CMB Traffic Engineer</u>
  - Trees E. Area (CMB Arborist), Eric Zandvliet (CMB Traffic Engineer not present) Ernest discussed having taller palms (per CMB regulations) installed; there are a total of 19 trees that will be removed and replaced at an estimated cost of \$69k, including grates. The trees will need to be watered 3 to 4 times per week for the first year. Additional information will be forthcoming at the September 11, 2019 meeting.
- <u>Street Lighting Poles/Sculptures/Monument 2019 Stroll Ornaments with Lights</u> Ernest conveyed a message from PW Director Katsouleas that she is waiting for estimates on the street lighting. No one has responded for Manhappenings at this time, waiting for October 1 deadline.
