SOME KEY DEFINITIONS

To make this as user-friendly as possible, here are the definitions of some words or phrases that will be used in the power point slides:

| Word or Phrase | Definition | |
|-----------------|--|--|
| Proposition 218 | A CA law requiring cities to notify property owners & rate payers of utility rate increases for a 5-year period. | |
| Refuse | A term commonly used to refer to solid waste (trash and recyclables). | |
| Solid Waste | Another "umbrella" term to describe the area or industry of disposal – landfill, recycling, compost, etc. e.g.: The solid waste industry. | |
| Trash | Refers to material disposed at the landfill. e.g.: A trash cart should be used to dispose materials intended for the landfill. | |
| Recycling | Refers to the process of making something into a new item. With regards to curbside collection, represents certain glass, metal, paper and plastics. e.g.: A recycling cart is used to dispose items which will be remade into a new item. | |
| Organics | Refers to yard clippings, food scraps & soiled paper that can or will be reutilized. | |
| Carts | Refers to plastic, wheeled solid waste containers with flip-lids that are used by all single- family residential, some multi-family and some commercial customers for refuse collection. | |
| Bins | Refers to 2, 3, 4 & 6 cubic yard metal bins on wheels used for commercial or large multi-family dwelling refuse collection (landfill trash = green metal bin, recycling = white metal bin). | |

| July 18, 2017 | City Council directed staff to begin procurement process for new hauling contract. | |
| September 28 – November 3, 2017 | Staff conducted community outreach, including a residential survey regarding current and future services. | |
| November 7, 2017 - May 15, 2018 | Council subcommittee members finalized the solid waste services desired for new contract; prepared a Request for Proposals (RFP) and released it for bids. | |
| August 23 and October 1, 2018 | Proposals were received from 3 waste hauling companies on August 23 rd . Oral interviews held on October 1 st following a comprehensive review of the proposals. | |
| October 2, 2018 - January 15, 2019 | Three negotiated contracts were finalized and presented to City Council on January 15, 2019. See the 01-15-19 City Council Agenda for more details. | |
| February 5, 2019 | Council awards the next solid waste contract to Waste Management (lowest bidder). | |
| March 3, 2020 | Council initiates Proposition 218 process; sets May 5, 2020 for Public Hearing. | |



KEY NEW CONTRACT CHANGES

Solid Waste contracts typically last for 7-10 years. Each new contract reflects the changing needs of the community and services offered in the solid waste industry. The following list highlights some key changes in the new Waste Management (WM) contract effective July 1, 2020. Learn more about these changes at www.citymb.info/newcontract2020.

| Contract Change | Brief Description | |
|--|--|--|
| New Refuse Billing Process | WM will be taking over REFUSE billing only for all customers. Water/sewer bills still with City. | |
| Residential Food Waste | ALL food, soiled paper & yard waste will be <u>mixed</u> in the green Organics cart. NO BAGS! | |
| Paper Shredding Events Increased | WM will host four (4) community paper shredding events every calendar year. | |
| Bulky Item Pick-Ups Increased from 9 Items to 18 items | Residential and Multi-Family customers can request six (6) visits per home/dwelling unit, at three (3) items per visit. A total of 18 items per calendar year per home/dwelling unit. | |
| Plastics Recycling Changes Community-Wide | Beginning July 1, 2020, only plastics #1, 2 and 5 will be accepted in recycling containers community-wide (residential, multi-family, commercial, schools, public cans, government). | |
| Highland Ave. Collection Restrictions/Traffic | To reduce travel congestion during peak times, WM is restricted from servicing sections of Highland Ave. during designated times. Visit <u>www.citymb.info/newcontract2020</u> for details. | |
| Rate Change for Commercial Business Recycling | Commercial business recycling (blue carts and white bins) will be provided and serviced at a rate for the first time. The cost of recycling will be 50% of the trash rate for the same cart or bin size. Food Waste will continue at no additional charge. | |
| 20 gallon gray trash cart | Residents can order a 20-gallon trash cart; the cost is the same as the 35-gallon cart. May benefit smaller, single households, those with spatial constraints or if 35-gallon is too heavy. | |
| Downtown Refuse Group | WM will develop a working group of stakeholders to address Downtown refuse-related needs. | |



PROPOSITION 218 PROCESS

What is Proposition 218?

- Passed by CA voters in 1996.
- Proscribe ("limits") methods local governments can create or increase taxes/fees/charges.
- Allows property owners or rate payers (a person who pays the solid waste bill, which could be a tenant) to protest rate increases.
- City is required to provide a 45-day protest period for property owners/rate payers to submit protests.
- A **Public Hearing & absence of a majority protest** is required prior to Council adoption of new rates.
 - Public Hearing date is May 5, 2020.



What's Required by the State of California & City of MB

 (State of CA) The public agency must send notice and rates to each property owner and rate payer.

City of Manhattan Beach Actions

- Sent notices and proposed rates to property owners, rate payers (and tenants for informational purposes only).
- Publish Public Notices/ads in Beach Reporter on 3/19, 3/26, 4/2, 4/9 and 4/16.
- Created this power point & posted on City website to help with understanding the process.



How to Protest the Rate Increase

Protests must be received between March II, 2020 – May 5, 2020, and prior to the close of the public hearing.

Only **property owners** or **rate payers** may submit written protest. One protest per parcel of property will be counted in calculating a majority protest.



How Do I Participate in the Public Hearing on May 5, 2020? Will I Be Able to Attend the City Council Meeting?

Should City Hall remain closed past April 30, 2020, the public will be given the opportunity to participate *remotely* in the City Council Meeting/Public Hearing on May 5, 2020 at 6:00 PM.

What Happens if the City Receives Enough Protests to Overturn the Rate Increase?

The City Council may not approve the rate increase if there is a "majority protest." A majority protest exists if the City Clerk must receive written protests from 50% + 1 of the property owners/rate payers in Manhattan Beach to prevent the rate increase from taking effect.

- 1. If 50% + 1 of property owners/rate payers submit protests, *City Council* <u>cannot</u> implement the rate increase to property owners/rate payers.
- 2. The City will then pay the increase from the General Fund for the term of the contract.
- 3. City Council can amend its contract with Waste Management, to reduce services to lower the contract rate.
- 4. City Council can also initiate the Proposition 218 process again.
