I respectfully ask the City Council to pass an emergency ordinance banning residential wood burning due to its negative health impacts.

The world is facing a pandemic of unprecedented proportions. To preserve the health and safety of our community in this uncertain time, all man-made health hazards should be mitigated. Wood smoke is a known health hazard. The particulate matter found in wood smoke penetrate "deep into the lungs, harming the lungs, blood vessels, and heart." Older adults and individuals with pre-existing conditions, including lung disease, asthma, or bronchitis, are particularly impacted by smoke pollution. Exposure can increase susceptibility to respiratory infections, and can cause reduced lung function, heart attacks, lung cancer, and even premature death. Because individuals with respiratory infections, asthma, and lung disease "are at increased risk for serious complications from COVID-19," banning indoor and outdoor residential wood burning is extremely important for the health and safety for those members of our community.

In addition to protecting the residents of Manhattan Beach, a ban on indoor and outdoor residential wood burning will alleviate strain on the already-overburdened health system. For example, smoke inhalation can cause upper respiratory symptoms, which could incorrectly be attributed to COVID-19. This conflation may lead to unnecessary trips to the ER, testing, or self-isolation. A ban implementing an abstention from residential wood-burning will mitigate avoidable strain on healthcare professionals, and will ultimately allow them to devote more attention to individuals battling COVID-19.

Despite the detrimental effects of wood burning, residents in our city continue to wood burn at all hours. I wake up early for my daily walk and smell smoke. I open my windows in the afternoon or evening to let in "fresh air" as we have been advised to do to allow our indoor air to recirculate and I do not get fresh air, just acrid wood smoke. Many other residents I have spoken with have complained of this as well. Because we are all mandated to "stay home," all community members are particularly harmed by the smokey air. The asthmatic who suffers an attack from poor air quality and seeks out ER care is taxing the system. The individual on home oxygen is at risk. The quality of the air in our homes where we may be spending 24 hours a day is at risk.
