COVID-19 SITUATION REPORT APRIL 16, 2020

CURRENT INITIATIVES AND UPDATES

- Manhattan Beach Unified School District Closure "Until Further Notice" At its April 16, 2020, Board of Trustees meeting, the School District extended its school closure "until further notice." The move leaves room for the board to discuss the issue further and consider any new information when it next meets on May 6.
- Manhattan Beach COVID-19 Dashboard The City's COVID-19 Dashboard has been
 enhanced to showcase graphs that illustrate whether the City of Manhattan Beach and Los
 Angeles County are "flattening the curve." Visit the City's <u>dashboard</u> for a breakdown of
 COVID-19 in the City of Manhattan Beach, the neighboring cities, and Los Angeles County.
- Care for Your Foliage Residents are reminded to care for foliage that extends into public rights-of-way, as it is their responsibility to do so. During the public health orders, gardening and landscaping maintenance may offer residents an opportunity to take care of these responsibilities and keep yourself busy.

FEDERAL, STATE, AND COUNTY UPDATES

- Strategies to Optimize Supply of Personal Protective Equipment (PPE) In a FEMA News
 Release, one of the strategies to optimize the supply of Personal Protective Equipment (PPE)
 mentioned, is a new preservation practice with Battelle Critical Care Decontamination
 System (CCDS). The system can sterilize 80,000 N95 masks daily and sixty CCDS' have been
 purchased for use nationwide. FEMA also released best practices on how to preserve PPE in
 communities to sustain their availability for health care workers, first responders and
 patients.
- Economic Impact Payment (i.e. Stimulus Payments) from the IRS The Internal Revenue Service (IRS) is currently in the process of distributing Economic Impact Payments to the public, as required by the federal government's CARES Act legislation. No further action is needed by taxpayers who filed tax returns in 2018 and 2019 and most seniors and retirees. If you normally do not file a tax return or the IRS does not have your direct deposit information, the IRS is prepared to assist you with their Get My Payment tool. For more information or to see if you are eligible for an Economic Impact Payment, go to the IRS's website.
- Governor Newsom Signs Legislation on Food Sector Workers Governor Newsom signed an Executive Order benefiting workers in grocery stores, fast-food chains, and delivery drivers. The Order gives two weeks of supplemental paid sick leave to food sector workers if

- they are subject to a quarantine, isolation order, or a medical directive. The Order also calls for increased hand-washing measures at food facilities to increase consumer protection.
- Employment Development Department will Operate 7 Days a Week At the Governor's direction, the Employment Development Department (EDD) will launch a new call center on Monday that will operate 7 days a week from 8:00 AM to 8:00 PM. The Unemployment Insurance Branch will be up-staffed with 1,340 employees, including 740 EDD employees and 600 employees from across state government. The Governor protects California's gig workers and also directs EDD to expedite access to the Work Share program to avert layoffs.
- Los Angeles County Health Services' Portal The Department of Health Services' Portal updates this <u>Dashboard</u> daily on LA County's healthcare systems from four service hospitals on number of patients, hospital beds, available hospital beds, ventilators, and personal protective equipment.
- COVID-19 LA County Daily Briefing Statistics The Los Angeles County Department of Public Health confirmed 55 new deaths and 399 new cases of COVID-19 in today's daily briefing. This is the largest increase in new deaths for the third consecutive day. Testing capacity continues to increase in LA County, with testing results available for over 70,000 individuals, resulting in 11% of people testing positive.
