COVID-19 SITUATION REPORT APRIL 17, 2020

CURRENT INITIATIVES AND UPDATES

- Community Encouraged to Contribute to Local Fundraising and Donation Opportunities

 The Business community is assisting local hospitals by sourcing meals for Health Care
 workers and their families. The entire community is encouraged to participate in two
 opportunities to help:
 - ✓ FeedOurHeroesLA: Simms Restaurants is keeping their workforce employed by preparing meals for Health Care workers. They are looking to drop off meals 50 at a time so that their restaurant teams can execute their mission effectively. At \$10/meal that's a \$500 sponsorship at a time. If you hit the \$500 milestone you can have meals delivered to a specific hospital in your name. Meals can be delivered anywhere locally. Or, if you'd simply like to make a donation on FeedOurHeroesLA, any amount is welcomed and appreciated.
 - ✓ <u>Downtown MB Feeds the Heroes</u>: Downtown Manhattan Beach is also helping downtown restaurant employees keep working and showing appreciation for Providence Little Company of Mary and Torrance Memorial Emergency Room staff. It costs about \$4,200/day to feed 270 employees. If you're able, consider a weekly donation to keep Health Care workers nourished. To guide in your donation, breakfast/lunch entrées and delivery costs are \$10-\$15/person, and dinner is \$15-\$20/person. This allows restaurants to still earn money to pay their employees as well as create healthy and delicious meals. Any donation is gratefully accepted. Sponsor opportunities available as well. FEDERAL, STATE, AND COUNTY UPDATES

- Presidential Guidelines on Reopening of Country President Trump proposed a phased approach for opening up America based on a number of factors that can be implemented statewide or county-by-county at each Governor's discretion. The President highlighted here specific types of employers in the President's plan in the order businesses can open. The full plan may be viewed at whitehouse.gov.
- U.S. Small Business Administration Loan Program Funds No Longer Available The Small Business Administration (SBA) Paycheck Protection Program and the Economic Injury Disaster Loan (EIDL) have utilized all funds that have been appropriated. Both programs were part of the Coronavirus Aid, Relief, and Economic Security (CARES) Act, a financial stimulus package designed to help small businesses stay afloat and offset the financial challenges created by the pandemic. - County Forecasts Decreased Revenue The County's economic outlook has taken a hard hit from the COVID-19 crisis. Officials forecast a \$1 billion decline in sales tax revenue this fiscal year; looking ahead, sales tax decline is expected to surpass \$2 billion through next fiscal year June 2021. County administrators are requesting assistance from Congress for federal relief.
- COVID-19 Homeless Response Information To better inform the public on how L.A. County is responding to COVID-19 in the homeless population, the Los Angeles Homeless Services Authority (LAHSA) has released a set of <u>Frequently Asked Questions and Responses</u> about Project Roomkey, the program to get people experiencing homelessness in interim housing in hotels and motels. - Same Day COVID-19 Tests Available Same-day tests and more locations are now available for all LA County residents who have symptoms of COVID-19. For more information go to covid19.lacounty.gov. Here is an instructional video to view prior to taking the test.
- COVID-19 LA County Daily Briefing Statistics The Los Angeles County Department of Public Health confirmed 40 new deaths and 567 new cases of COVID-19 in today's daily briefing. Testing capacity has increased, with testing results available for over 74,000 individuals. As of today, 3,014 people who tested positive for COVID-19 (26% of positive cases) have been hospitalized at some point during their illness. Thus far, 14% of those tested, were positive for COVID-19.
