# COVID-19 SITUATION REPORT APRIL 26, 2020

#### **CURRENT INITIATIVES AND UPDATES**

- Information on City's Eviction Moratorium Ordinance On March 17, 2020, the City Council adopted an urgency ordinance that provides temporary protection for commercial and residential tenants during the local emergency. Key aspects include:
  - Landlords cannot begin the eviction process for residential or commercial tenants for the tenant's failure to pay rent if that failure is related to COVID-19. Likewise, there can be no "no-fault" evictions, unless immediately necessary for health and safety of other tenants, neighbors, or the landlord. Health and safety does not include the presence of individuals who have COVID-19 or has been exposed to COVID-19;
  - o Tenants must notify landlords in writing (email or text is acceptable) within 30 days after the date that rent is due that they are unable to pay the full rent that was due as a result of financial impacts related to COVID-19; and
  - This does not absolve tenants from having to pay the rent due, however, the tenant must pay within six months of the expiration of the local emergency. Landlords may seek unpaid rent after the expiration of the local emergency, however, a landlord may not charge or collect a late fee for rent that is delayed for reasons stated above.

## FEDERAL, STATE, AND COUNTY UPDATES

• Funds to Support States and Localities COVID Response - The Department of Health and Human Services (HHS) announced the upcoming action by the Centers for Disease Control and Prevention (CDC) to provide additional resources to state and local jurisdictions in support of our nation's response to COVID-19. Using funds from the Coronavirus Aid, Relief, and Economic Security (CARES) Act of 2020, CDC is awarding \$631 million to 64 jurisdictions through the existing Epidemiology and Laboratory Capacity for Prevention and Control of

- Emerging Infectious Diseases (ELC) cooperative agreement. These funds, along with the previous support CDC has provided, will help states with their efforts to re-open America. Visit <a href="https://hhs.gov">hhs.gov</a> to view the funding California has received thus far.
- Poison Prevention HHS, awarded nearly \$5 million to Poison Control Centers across the country to improve their capacity to respond to increased calls due to the COVID-19 pandemic. In recently released CDC data, from January–March 2020, Poison Control Centers received 45,550 exposure calls related to cleaners (28,158) and disinfectants (17,392), representing overall increases of 20 percent and 16 percent from January–March 2019 (37,822) and January–March 2018 (39,122), respectively. - Garnishments Exempt The Governor issued an <u>executive order</u> that exempts garnishment for any individuals receiving federal, state or local government financial assistance in response to the COVID-19 pandemic.
- Latest COVIDView Surveillance Report The Center for Disease Control and Prevention
  (CDC) has released their weekly surveillance summary of United States COVID-19 activity for
  this week. The latest report summarized and interprets key national indicators. Download the

- New Orders Impact Healthcare Facilities LA County Public Health issued a new Health Order that all licensed healthcare facilities restrict all visitors, suspend all communal dining and activities to ensure physical distancing, and test all employees and residents for COVID-19. These measures are intended to reduce the transmission of COVID-19 in these facilities and to protect vulnerable residents, as well as staff.
- LA County Daily Briefing Statistics on COVID-19 The Los Angeles County Department of Public Health has confirmed 18 new deaths and 440 new cases of COVID-19 in today's daily briefing. Testing capacity continues to increase in LA County, with testing results available for over 117,000 individuals. As of today, 4,380 people who tested positive for COVID-19 (23% of positive cases) have been hospitalized at some point during their illness. Thus far, 14% of those tested were positive for COVID-19.
