COVID-19 SITUATION REPORT MAY 1, 2020

CURRENT INITIATIVES AND UPDATES

- Explore Your Neighborhood The City recognizes the importance the community places on physical exercise, especially during this time. We urge the community to utilize your local neighborhood where possible to exercise. Ocean Drive does not serve as a substitute to the Strand or Bike Path. During the Safer-at-home Order, residents are asked to stay home, go out for essential purposes and exercise in a responsible and safer manner, in their local neighborhoods.
- Farmers Market Reopens on May 12 The City of Manhattan Beach City Council approved the reopening of the Manhattan Beach Farmers Market, beginning May 12 under modified conditions and heightened safety protocols. The safety of the community, shoppers, farmers, and vendors will be held in the utmost regard and good practices of current operating Certified Farmers Markets will include: a maximum number of shoppers within the market at any one time, controlled entry/exit, heightened food handling & hygiene protocols, and additional safety measures.
- Manhattan Beach "Red House" Highlighted The city services and employee appreciation campaign continues. In an effort to #stayconnected to our past, enhancements are being made to the Manhattan Beach Historical Society 'Red House.' This includes installing an access point that extends the internet signal from the Manhattan Beach Arts Center across the street to the Historical Society facility so images can be archived in a digital solution going forward! Continue to follow the City on Facebook, Twitter, and Instagram to see employees behind the scenes, working from home, and around the City. Kudos to #TeamMB!
- Change in City Council Meeting Schedule Starting the week of May 4, 2020, City Council meetings will be held at 6:00 PM every Tuesday and at 8:00 AM every Thursday. Pursuant to Governor Newsom's Executive Orders No. N-25-20 and No. N-29-20, the City Council Chambers is not open to the public. However the public may view City meetings through Manhattan Beach Local Community Cable (Channel 8 on Spectrum and Channel 35 Frontier), and live streamed via the City's website. FEDERAL, STATE, AND COUNTY UPDATES

• Tips on Good Nutrition – With temporary disruptions in the food supply chain, there may be new or other items in your kitchen than usual. The U.S. Food and Drug Administration (FDA) issued a consumer update, Tips on Good Nutrition and Using the Updated Nutrition Facts

- <u>Label</u> during the coronavirus pandemic. The update provides helpful tips on how to use the updated label to learn more about the foods you have on hand or are purchasing online or in stores. Another useful FDA guide is <u>Food Planning during the Pandemic.</u>
- COVID-19 and Pets The FDA issued a consumer update, <u>Helpful Questions and Answers</u> about COVID-19 and Your Pets, that provides answers to frequently asked questions. Based on the limited information available to date, the risk of pets spreading the virus that causes COVID-19 in people is considered to be low. At this time, there is no evidence that animals play a significant role and there is a small number of animals around the world reported to be infected, mostly after having close contact with a person with COVID-19.
- Child Care Options Governor Newsom <u>announced</u> a new portal to help parents, essential workers, and vulnerable families, find safe, reliable and accessible child care options through MyChildCare.ca.gov. Licensed child care providers may add their service to the provider list. Visit ca.gov for more information.
- Marriages via Videoconference Governor Newsom signed an executive order in place for the next 60 days that allows adults to obtain marriage licenses and get married via videoconferencing rather than in person amidst the COVID-19 pandemic. Under the executive order, as long as both adults are located within the State, and at the discretion of their local county clerk, the adults can obtain a marriage license, through a videoconference. - LA County Daily Briefing Statistics on COVID-19 The Los Angeles County Department of Public Health has confirmed 62 new deaths and 1,065 new cases of COVID-19 in today's daily briefing. There is a total of 1,172 deaths; ninety-two percent of people who died had underlying health conditions. Testing capacity continues to increase in LA County, with testing results available for over 152,000 individuals. As of today, 4,880 people who tested positive for COVID-19 (21% of positive cases) have been hospitalized at some point during their illness. Thus far, 14% of those tested were positive for COVID-19.
