To the Honorable City Council of the City of Manhattan Beach,

This firm represents Coastal Defender, Don McPherson, and Jim Quilliam, appellants of the Planning Commission's March 11, 2020 determination to approve the MB Post expansion, which includes both a 49 percent expansion of patron serving premises, and an increase in operating hours until 1AM Thursday-Saturday nights.

The purpose of this letter is to advise the Council of the legal deficiencies in the Planning Commission's action under both the California Environmental Quality Act (CEQA) and the City of Manhattan Beach Municipal Code.

#### **California Environmental Quality Act**

The Planning Commission's approval relies upon a categorical exemption from the CEQA for a "negligible" expansion of use. This exemption is inappropriately applied to this significant expansion.

The proposed expansion will take an existing 3,283 square foot restaurant and expand it into an adjacent 1,447 square foot space, and additionally enclose a 148 square foot patio area, a 40 percent increase in service area. The expansion will convert an existing Subway restaurant into a dining establishment with a full liquor license, a significantly different type of use. For this reason, the expansion of use cannot be deemed to be negligible and the project does not fall within this categorical exemption. The staff's analysis of the exemption relies upon the fact that the restaurant will be taking over a former Subway restaurant, but the nature of the two businesses is significantly different. MB Post will have later operating hours and serve alcohol, both of which are sources of noise in the nearby the neighborhood. These material differences between the operations of Subway and MB Post are relevant factors that must be considered when reviewing the applicability of the categorical exemption for negligible expansion

Even if the categorical exemption applied, exceptions to the categorical exemption make the exemption improper. There are two relevant exceptions to the categorical exemption: cumulative impacts, and unusual circumstances.

First, the cumulative impacts of similar projects over time could be significant here. This section of the City contains numerous restaurants located near residences. There are at least 19 other restaurants with alcohol licenses in Manhattan Beach that have more limited hours than the requested 1AM closing time for MB Post. The cumulative impact, particularly as to noise, of the patrons of a number of additional restaurants closing at 1AM rather than at midnight will, over time, create significant impacts on the quiet nighttime environment. The seemingly one-off decision to grant additional hours to MB Post will have farther reaching consequences then the impact on one single business: it sets a precedent to which other owners will look to seek their own additional entitlements.

Secondly, the MB Post expansion presents unusual circumstances that are not typically found in similar projects subject to the exemption. There are two aspects of the MB Post expansion that are unusual and lead to environmental impacts not normally associated with restaurant expansion. First, the premises is significantly expanding relative to its current footprint, and second, the premises is seeking additional operating hours. These two factors both intensify the use of this site, and combine to create an unusual circumstance that takes this project from the category of "negligible expansion of use." These circumstances contribute to the additional noise impacts from MB Post.

The Council should grant the appeal, and request the staff to conduct a review under CEQA to determine whether there are either individual or cumulative environmental impacts from the expansion of square footage and hours for MB Post, in light of the analysis and information above and in the other submissions of Coastal Defender.

## Manhattan Beach Municipal Code

As the staff report and Planning Commission resolution recognize, the City must make certain findings to comply with the Municipal Code. It cannot make those findings here, because, as Coastal Defender's testimony demonstrates, the premises will not comply with the requirements of the Manhattan Beach noise ordinance (M.B.M.C. Chapter 5.48).

In order to grant a Use Permit Amendment, Council must make four findings, including that the operations "will not be detrimental to the public health, safety or welfare of persons residing or working on the proposed project site or in or adjacent to the neighborhood of such use; and will not be detrimental to properties or improvements in the vicinity." In addition, the Council must find that the "the proposed expanded use and expanded hours will comply with the provisions of the City's Planning and Zoning title, including any specific condition required for the proposed use in the district in which it would be located." Neither of these findings can be made for this Use Permit Amendment.

As set forth in the required findings, the Municipal Code requires that businesses operating under a use permit comply with the requirements of "Title 10" of the Code, Planning and Zoning. Manhattan Beach Municipal Code section 10.60.120, subdivision (a) provides that "All uses and activities shall comply with the provision of the Manhattan Beach Noise Regulations (Chapter 5.48 of this Code)." Chapter 5.48 explains that "[i]n order to control unnecessary, excessive, and annoying noise in the City of Manhattan Beach, it is hereby declared to be the policy of the City to prohibit such noise generated from or by all sources as specified in this ordinance." Moreover:

"It shall be the policy of the City to maintain and preserve the quiet atmosphere of the City, to implement programs aimed at retaining ambient noise levels throughout the City, and to mitigate noise conflicts. It is determined that certain noise levels are detrimental to the public health, welfare and safety, and are contrary to the public interest. Therefore, creating, maintaining, causing, or allowing to be created, caused, or maintained, any noise in a manner prohibited by the provisions of this chapter is a public nuisance and shall be punishable as such." (M.B.M.C. 5.48.010.)

The Municipal Code also prohibits the expansion of use for businesses that fail "to meet the performance standards of section 10.60.120," unless it can be shown that the enlargement will bring the business into compliance with those conditions. (M.B.M.C. 10.68.030.)

The control of noise, or unwanted sound, is thus a City-wide policy. The City's Noise Ordinance does not limit its regulation of noise to certain types of sound, but rather define noise broadly as "an unwanted sound which is generally random in nature." (M.B.M.C. 5.48.020.) A "noise disturbance," is "any noise which, as judged by a City employee or contractor that annoys or disturbs a reasonable person or exceeds the standard set forth in this chapter." (*Ibid.*) The City thus wisely uses these content neutral time, place, and manner regulations of both objective and subjective noise levels to ensure a quiet environment for residents, regardless of the source of noise.

Indeed, Condition #16 of the Planning Commission Resolution provides: "Noise emanating from the property line shall be within the limitation prescribed by the City Noise Ordinance and shall not create a nuisance to nearby property owners. Noise shall not be audible beyond the premises."

In spite of the requirements of the City Noise Ordinance, the provisions of the Municipal Code that require compliance with the Noise Ordinance, and the specific requirements of the Planning Commission Resolution, neither MB Post nor the City have provided any evidence that the operations will comply with the Noise Ordinance. The only statements in the staff report on this issue concern the limited buffer between residential uses and MB Post, without any quantitative analysis of noise whatsoever.

Appellants, however, have provided the analysis of Steve Rogers Acoustics, LLC (SRA), of the noise impacts of operations from the expanded MB Post. As SRA testifies, voice and music noise emanating from MB Post prior to 10PM, when the windows may remain open, will exceed the Noise Ordinance's exterior threshold by a significant margin. The voice and music noise will also exceed city loudness standards at the closest residence, diagonally across 12<sup>th</sup> Street. There is no contrary evidence in the record to date and the comments in support of the expansion do not address noise issues.

After 10 PM, when the windows closed, the noise impacts of the expanded operations can be addressed. For one, keeping the closing hours of the business at midnight would not introduce as much new, additional noise into the adjacent residential area. Second, requiring sound blocking windows and a double-door vestibule, as the city has required for other similar businesses, will make the premises compliant with the Noise Ordinance, once the windows are closed. Because the business will expand into a new premises and make substantial renovations, it is not unreasonable to require the use of materials that will mitigate the external impacts of the operations within the building.

For the above reasons, the Council should grant the appeal and limit the hours of operation to midnight.

# MB POST PROJECT VIOLATES THE CALFORNIA ENVIRONMENTAL QUALITY ACT

This report summaries the major impacts on both the MB Post neighborhood and other residential areas adjoining the Downtown:

- Patron's voices and amplified background music will substantially violate provisions in the noise ordinance, as determined by Steve Rogers Acoustics [SRA];
- Extension of closing hours from midnight to 1 AM opens the door for the 19 other Downtown alcohol-premises, which have midnight or earlier closing times, to apply for the same entitlement [Exhibit 1]; and,
- Without conducting a noise analysis, staff has dismissed city-standard mitigation measures, such as the double-door entrance vestibule for Shade Hotel and the sound-blocking windows for Strand House. [Exhibit 2]

To preclude some, but not all these impacts, the city council must impose the following conditions on the MB Post use permit:

1) Retain the existing closing times for MB Post, the city policy since 2002 [Exhibit 1];

2) Limit alcohol service to seated patrons within arm-reach of a table or the bar, consistent with a restaurant operation, as opposed to a bar or nightclub with many patrons standing;

3) Require a technical means, verifiable by code enforcement, that limits the loudness-level of background-music to inaudibility at fifty feet from the premises, a noise-ordinance requirement;

4) At the north entrance to the lounge area, provide a double-door vestibule, as the city required for the 2014 Shade Hotel use permit, and delete the south west-facing door. Additionally, provide noise-blocking west windows, as the city required for the 2011 Strand House use permit [Exhibit 2]; and,

5) As customary in city use permits, specify the occupancy as 99 persons, per Plans Sheet G100. This done for recent projects, such as Gelson's and 900 Club. The Fire Code requires it.

Per the SRA acoustics analysis in Exhibit 3, the vocal and music loudness levels with open windows will exceed external daytime standards in the noise ordinance, by over one-hundred times louder No way exists to mitigate these violations.

In her letter, attorney Beverly Palmer argues that the unusual circumstances and cumulative effects of noise impacts mandate environmental review, per the California Environmental Quality Act [CEQA], as opposed to the city claim of categorical exemption.

If the city council requires the above five conditions in the use permit, then Coastal Defender will accept the noise-ordinance violations, when windows open prior to 10 PM.

The following rebuts the staff response to the appeal filing by Coastal Defender.

## Extended Closing Hours [Exhibit 1].

Of the 35 alcohol-serving premises in the Downtown, 19 must close at midnight or earlier. The city has not increased closing times for alcohol service since 2002, when they did for Petros in Metlox, a 30-minute increase from midnight to 12:30 AM. [Exhibit 1, Item 23]

The staff report erroneously refutes these facts, by citing three examples: 1) BREWCO in 2009; 2) Strand House in 2011; and, 3) and Esperanza in 2019. None of these use permits extended closing hours. In fact, the Strand House use permit reduced its Thursday closing time, from 1 AM to midnight.

Per staff-report opening pages for the above three projects, at Exhibit 4 p.1, the BREWCO use-permit involved changing the alcohol license from a Type 75 to a Type 47, with no change in operating hours. As mentioned, the 2011 Strand House use permit reduced closing time on Thursday [Exhibit 4 p. 3] The 2019 Esperanza use-permit amendment addressed a major remodel currently underway, with no change to operating hours. [Exhibit 3 p. 4]

As result, the above three examples cited by Community Development have absolutely no relevance in consideration of the proposed extension for MB Post closing time.

City-council approval of MB Post closing-time from midnight to 1 AM will constitute a major policy change, which will result in an avalanche of applications for longer hours, from the 19 premises that now must close at midnight or earlier.

## Staff Rejection of City-Standard Noise-Mitigation Measures [Exhibit 2].

The staff report states, "Manhattan Beach Post <u>currently</u> has French doors that open onto Manhattan Avenue." [Emphasis added]

Per James Quilliam's Exhibit 5 declaration, when MB Post installed the rolling doors in or around 2012, he filed a complaint with the building department, which subsequently ordered the rolling doors welded shut. Since 2012, living just around the corner, Mr. Quilliam has passed by MB Post countless times, but not until last week, did he ever observe the doors open.

Staff correctly states that the doors <u>"currently"</u> open onto Manhattan Ave, but only because the welds unlawfully cut, violating the 2012 building permit. The proposed project will for the first time, legally permit the MB Post façade to open, facing residences to the west, creating substantial noise-ordinance violations that have no means for mitigation.

Regarding background music noise that can violate the 50-foot inaudibility requirement, as 900 Club does, staff states, "The applicant is not proposing amplified music."

Condition 17 in Resolution No. PC 20-01 states, "The restaurant management shall control the volume of any background music."

Staff argues that no amplified music exists to violate the noise ordinance. How can the management control the music volume, if it not amplified?

Regarding patron voice noise, staff states, "the floor plan shows no more than 25 seats that line the restaurant's western wall adjacent to Manhattan Avenue," and further argues, "It is unclear what noise, if any, is exceeding the Municipal Code standards."

No wonder that the violations unclear to staff, because they failed to conduct a noise analysis. Furthermore, per Sheet G100, the vocal noise source comprises 99 patrons, not 25, with loud voices and laughter, if Simmzy's any guide.

#### Conclusion.

In the 1990's, then Councilmember Napolitano campaigned in the streets to rescue the Downtown from the nightclub scene, one of his signature accomplishments. Please protect Mr. Napolitano's legacy and approve the five conditions listed above for the MB Post use permit.



Dear Don:

We have completed an evaluation of the likely noise impact of the proposed changes to the Manhattan Beach Post (MB Post) restaurant/bar, located at 1142 Manhattan Avenue in Manhattan Beach. Our work has been based on the information available to us at the time of writing this report.

#### BACKGROUND

- The applicant proposes to expand the MB Post into the adjacent property at 1144 Manhattan Avenue - a building that was previously a Subway sandwich restaurant. In addition, an existing exterior patio is to be enclosed, bringing the floor area of the expanded restaurant to 4,878 ft<sup>2</sup>.
- Extended operating hours are proposed for the expanded restaurant, starting at 6AM seven days a week (instead of 11AM Monday Friday and 7AM on Saturday and Sunday) and closing at 1AM Thursday Saturday (instead of 12AM).
- According to the Code Summary on architectural drawing sheet (G100) attached to the March 11, 2020 Staff Report, the proposed occupancy of the expanded restaurant is 99 patrons.
- The expanded restaurant would offer full alcohol service and the floorplans of the proposed project show a large bar area located prominently at the center of the expanded space.
- The project applicant proposes to have operable windows facing Manhattan Avenue. We understand that this is a change to the envelope of the restaurant building, according to the current building permit.
- According to Planning Commission Resolution PC 20-01, the windows on the Manhattan Avenue side shall be closed no later than 10PM every day (Condition #5).
- The expanded restaurant will be equipped with an amplified music system. According to PC 20-01, the playback level of the amplified music system is to be controlled by the restaurant management (Condition #17).
- Condition #16 of PC 20-01 states that:



"Noise emanating from the property line shall be within the limitation prescribed by the City Noise Ordinance and shall not create a nuisance to nearby property owners. Noise shall not be audible beyond he premises."

### MANHATTAN BEACH NOISE ORDINANCE

- Noise control requirements for the City of Manhattan Beach are detailed in Chapter 5.48 "Noise Regulations" of the Manhattan Beach Municipal Code (MBMC), also known as the City of Manhattan Beach Noise Ordinance.
- For continuous noise (i.e. occurring for more than 30-minutes in any hour) Table 1 in section 5.48.160 of MBMC prescribes the following Exterior Noise Standards:

Designated Land Use or Zoning Classification	Time of Day	Exterior A-Weighted Noise Level
Desidential	7:00 AM - 10:00 PM	50 dB
Residential	10:00 PM - 7:00 AM	45 dB
Commercial	7:00 AM - 10:00 PM	65 dB
Commercial	10:00 PM - 7:00 AM	60 dB

• Paragraph 5.48.160 E. of the MBMC states:

Correction for Character of Sound. For any source of noise which emits a pure tone or contains impulsive noise, the noise standards as set forth in this section shall be reduced by five (5) dB. Examples of impulsive noise include fire alarms, hammering operations, impact wrenches, and other mechanical devices that produce noise levels with a quick onset and delay. Examples of pure tone noises include whistles, bells, and other mechanical devices that emit a tone that is distinguishable by the City employee or contractor.

Noise emanating from the expanded MB Post will include amplified music containing pure tones (musical notes) and impulsive sounds (drumbeat), so the 5 dB correction would apply in this case, as follows:

• Per MBMC section 5.48.160, in the event that ambient noise level at the receiver location (i.e. in the absence of noise from the restaurant) exceeds any of the prescribed Exterior

Noise Standards, the measured ambient noise level shall become the Exterior Noise Standard. However, without an opportunity to make realistic ambient noise measurements (which is not possible at the time of writing because of safer-at-home orders) we have no way of knowing whether actual ambient noise levels exceed the stated Exterior Noise Standards.

• In addition to the Exterior Noise Standards, the MBMC includes specific requirements for control of amplified music. Paragraph 5.48.120 the Code reads:

Amplified sounds - Electronic devices.

It is prohibited for any person to permit the transmission of, or cause to be transmitted, any amplified sound on any public street, sidewalk, alley, right-of-way, park, or any other public place or property which sound is audible at fifty feet (50'). This section shall not apply to any noncommercial public speaking, public assembly, or other activity for which a permit has been issued.

### **OPERATIONAL NOISE IMPACT ANALYSIS**

Amplified Music + Speech Sounds

- We have calculated exterior noise levels resulting from expanded MB Post operations, based on past experience of amplified music playback and patron (speech) noise levels in restaurants with a full bar and with similar density of occupancy to that proposed.
- We have focused on evening operations (before 10PM), when the windows in the Manhattan Avenue façade will be open.
- We find as follows:

#### Speech Sounds Only

- By subtracting the expected levels of amplified music playback from the analysis above, we can calculate exterior noise levels due to MB Post operations that are attributable to speech sounds produced by patrons.
- For evening operations (before 10PM), when the windows in the Manhattan Avenue façade will be open, we find as follows:

#### CONCLUSIONS

- Predicted noise levels at the property line (i.e. on the sidewalk on Manhattan Avenue in front of the open windows of MB Post) are in significant breach of the City Noise Ordinance. This is true for both the amplified music and speech components of the operational noise.
- Across the street, at a distance of 50-feet from the open windows of MB Post, we predict an exterior noise level of 63 dBA (amplified music + speech). This is significantly higher than the evening Exterior Noise Standard of 55 dBA, which applies to the commercial receivers opposite MB Post on Manhattan Avenue. It also confirms that amplified music from MB Post would be plainly audible at a distance of 50-feet another clear violation of the City Noise Ordinance.
- Predicted speech-only noise levels at a distance of 50-feet are below the evening noise limit but would still likely be audible in the context of prevailing ambient noise levels on Manhattan Avenue.
- At the closest residential receivers on 12<sup>th</sup> Street, we predict a restaurant operational noise (amplified music + speech) level of 48 dBA, which exceeds the evening Exterior Noise

Standard of 45 dBA. We also expect the noise of amplified music from MB Post to be plainly audible at the closest residential receivers on 12<sup>th</sup> Street.

On all counts, we conclude that operational noise (amplified music + speech) from the
restaurant would very likely be in clear violation of the noise regulations in the MBMC and
would therefore constitute a significant impact on the surrounding uses. We also find that
the "speech only" component of the likely operational noise levels would exceed the
applicable MBMC noise limit during the evening when windows to the bar and restaurant
are open.

## **RECOMMENDATION:**

Staff recommends that the City Council uphold the decision of the Planning Commission approving the request, and consider the request for an Encroachment Permit for outdoor dining above the public sidewalk.

## **FISCAL IMPLICATION:**

There are no fiscal implications associated with the recommended action.

## **DISCUSSION:**

The Planning Commission, at its regular meeting of March 9, 2011, approved (4-0 vote, 1 abstention) a request to remodel an existing 6,750 square foot restaurant building with some business operational changes. The existing building was constructed near the 26-foot height limit, and at the 1.5 floor area ratio limit, with 4 on-site parking spaces.

The proposal is for the building's existing 4 floor levels to be modified, and the addition of a new partial basement level for wine storage, rear employee restroom and locker facilities, and two new upper level dining balconies over Manhattan Beach Boulevard. Substantial upgrades are proposed for kitchen capacity, health codes, building codes, utilities, disabled access, ventilation, sound containment, and trash storage. Additional changes to the building include recessions of the front walls to provide outdoor dining, waiting, and entry areas; and the retractable windows to allow the restaurant to open to Manhattan Beach Boulevard during good weather. The applicant also proposes modifying the restaurant's hours of operation, entertainment and dancing.

Use Permit Amendment approval is required for the applicant's proposals to create outdoor dining/seating, change hours of operation, allow additional nights of dancing, relocate/modify the dance floor, and to install retractable walls/windows at the building frontage.

The Planning Commission received letters and testimony from neighbors stating concerns for noise and other disruptions that could occur from modified hours, dancing, and openness of the building. The Commission also had concerns for these issues, requesting additional information from the applicant and suggesting possible ongoing review of sensitive aspects of the business. The applicant subsequently eliminated the retractable window design from the uppermost level of the building opening onto the outdoor dining patio; and provided a formal noise analysis and further explanations of sound mitigating materials to be used in the building remodel. Staff recommended conditions extending the authority of the restaurant's required annual Entertainment Permit to regulate the noise caused by the openings, and to reduce entertainment and dancing if needed. At the continued public hearing the Planning Commission generally accepted these conditions, and accepted an agreement between the applicant and neighbor representatives regarding hours and dancing. The final approved resolution (Exhibit A) included the following changes to the existing Use Permit:

- **Dancing** was added for Thursdays and Sundays with the restriction that it end by 11:30pm on those nights. The current Use Permit only allows entertainment without dancing, with hours until 1:00am on Sunday and 11:30pm on Thursday.
- **Closing times** for Sunday Thursday were reduced from 1am to midnight to compensate for the added dancing as agreed upon with neighbor representatives.
- **Opening times** for holidays were extended from 10am to 8am to allow breakfast service similar to existing weekend entitlements.
- **Delivery hours** were restricted to 8am to 10pm to compensate for the added breakfast hours. Currently there are no restrictions.
- Noise at non-entertainment times (when windows/walls are permitted to be kept open) was made subject to an annual entertainment permit when windows/walls can be opened.
- Noise at all times was prohibited from being audible more than 75 feet away from the restaurant as recommended by the Police Department.
- **Encroachments** of 18-inch deep architectural "false balcony" features over the Manhattan Beach Boulevard right-of-way, instead of the originally requested dining balconies over the sidewalk were proposed by the applicant. The Commission does not have authority to approve a balcony encroachment, and could not reach a consensus recommendation on this issue.
- Updated/miscellaneous Use Permit conditions were imposed regarding utilities, use of rear roof area, and supervising the surrounding area.

Applications appealing the Planning Commission's decision were received from the project applicant, and a resident who participated in the public hearing. The attached applicant appeal request is to permit 5-foot wide balcony dining encroachments over the sidewalk with 200 square feet of area, and 24 seats. The resident appeal opposes expansion of "nightclub" aspects of the business.

The applicant had proposed two balconies partially cantilevering over the public sidewalk. Commercial encroachments over sidewalks are limited to canopies, signs, eaves, and awnings with

#### BACKGROUND

On October 15, 2018, the Community Development Department received an application requesting an amendment to an existing Use Permit to allow for a major remodel to an existing restaurant space (Shark's Cove) in conjunction with a new restaurant tenant (Esperanza), located at 309 Manhattan Beach Boulevard. The applicant is not proposing to change the operating hours, full alcohol service, or live entertainment hours. The subject restaurant is located in the "CD" (Downtown Commercial) zoning district in Area District III. A public hearing was scheduled for the January 23, 2019 Planning Commission meeting, and was continued to the March 27, 2019 Planning Commission meeting without discussion.

The subject site has a two-story building originally constructed in 1941 located on the northern side of the 300 block of Manhattan Beach Boulevard. City records indicate the building's second floor was permitted as two residential dwelling units, with the restaurant tenant occupying the entire first floor. After speaking with the applicant and conducting an inspection of the second story, Staff has determined that the second story is being used as an office use with storage facilities related to the downstairs restaurant use. The applicant has agreed to restore the upstairs to a residential use.

#### **EXHIBIT 5. DECLARATION BY JAMES QUILLIAM**

I, James Quilliam, hereby declare:

On or around 2012 and before MB Post opened and they were in the designing phase of the remodel to the building, I noticed they had installed large exterior doors that looked to be on rollers. I inquired with the MB inspector at the time and he was as surprised as I was that they had designed the doors to be fully openable as he indicated that they were to be closed. It was my understanding at that time that the city had ordered that the doors be welded shut. Since 2012, living just around the corner from MB Post, I have passed the building countless times and never saw the sliding doors open. Most recently, however, for the first time, I noticed that the MB Post full frontage completely open.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct.

I am a mother of two children, ages 5 and 7. Since March 13th, I have been asked, like all parents in California, to homeschool my children. This is a huge undertaking, and an enormous responsibility. Parents are taking this seriously, as they are also taking seriously, the safety of our children. My children have learned about appropriate social distancing, when, where and how to sneeze, and when a mask is required. I would argue that they understood this before the shutdown, but for the purposes of this petition, they understand this more than ever now. They deserve the opportunity to put these practices into action. It is possible, as we have seen in many of our surrounding communities, to open public space and people will self-regulate. If parents are capable of carrying out the lesson plans, are we not also capable of self-regulation at a park or a beach?

Denied the opportunity to self-regulate breeds dependence.

The current landscape in Manhattan Beach is uninviting and oppressive. While the thought may be to deter 'outsiders', it also feels punishing to law abiding residents. There are also areas in town closed off in ways that are simply unreasonable. A few examples are the passageways around town at Bell, and through Live Oak Park at 17th and 19th. Residents are utilizing parks in neighboring towns like Hermosa Beach, and making day trips to open beaches and lakes. It is unfair to put the burden on our neighbors. We should be partnering with them, and allowing our own residents places to unwind locally. In many ways, this further endangers our community. My point is - that closing our open spaces has only pushed people away. They travel out, and come back. They are doing this because it make them feel free - and healthy mentally.

I have noted a dramatic shift in enthusiasm from my children lately. Recently, the after-school activities that they participated in - soccer, softball, baseball, acting, religion, etc., have one by one, shut down. Even the online classes that were put in place to fill the void, have ended. We have visited the park at Polliwog, and I refuse to take my children there. It resembles something out of a Hunger Games movie - it is depressing. Police vehicles positioned in the park, metal barriers around picnic benches, closed restrooms and mandatory masks? My children have done nothing wrong.

The Greenbelt - the only open space that has remained open, has recently added some sort of patrol vehicle over the past few days. My daughter, on Thursday, was almost hit by this truck, as it passed us twice in the course of 15 minutes. I am unclear as to the purpose of this, as it did not appear it was a maintenance issue. It is however, dangerous.

While I could also make a case that business owners are capable of regulating their own business, I realize that the current debate is whether to open public spaces. May is Mental Health Awareness Month. Please open public space.

The desire to protect the ambiance of the Downtown -- both the marketability of the commercial establishments as well as desirability for residents living in or near our Downtown -- is not for the fainthearted. The Simms family has shown themselves to be excellent restauranteurs, and friendly, philanthropic neighbors. I am a Manhattan Beach resident for the past 13 years. My wife and I are raising a 12 year old girl and an 11 year old boy. They have lived their entire lives in Manhattan Beach.

This missive is regarding the reopening of our beaches. I am in no way unhappy with the policies of the State of California or the City of Los Angeles. And I am extremely appreciative of the efforts of our Manhattan Beach Council. In listening to the City Council's meetings and statements it sounds like there is an emerging plan to reopen the beaches on May 18<sup>th</sup>. This plan has been referred to as a multiphase plan. Phase one would allow for ocean activities, swimming, paddle board and surfing. Phase one would allow for social distance running and walking on the beach. And phase one would not allow for sunbathing and volleyball.

I am excited for phase one to begin on May 18<sup>th</sup> and our family can certainly wait another 16 days.

# But not everyone shares the same opinion and we are starting to see small, peaceful demonstrations at the beach.

To avoid further and louder protests that could divide our community, I make the following proposal, <u>Open the beaches</u> on Monday May 11<sup>th</sup> from 6am to 10am until Friday May 15th.

Specifically, when our Manhattan Beach City Council meets of Tuesday night 6pm, they should propose the opening of the beaches on May 11<sup>th</sup> to May 15<sup>th</sup> from 6am to 10am using the previously proposed phase one guidelines. The beaches should be reclosed on weekend of May 16<sup>th</sup>. With the assurance the beaches reopen on Monday, May 18<sup>th</sup> and the official phase one begins. At the Thursday Council meeting this proposal should be passed.

What does this accomplish?

- 1. It throws a bone to the demonstrators and petition signers. For 5 days and a total of 20 hours the beach will be opened.
- 2. The phase one beach opening plans objectives will be test.
- 3. The legislators look responsive to the peoples requests
- 4. The residents have specific dates and guidelines regarding beach openings

This plan is a bridge from now until May 18<sup>th</sup>. I believe our resident's would be very favorable to this idea.

#### Dear City Council Members,

I am writing to set forth **objections to amending the Use Permit for MBPost** to extend the operating hours of MBPost from midnight to 1 am. Historically, the City of Manhattan Beach has done an effective job of balancing the needs of local businesses with those of the residents, resulting in an amicable co-existence. This has resulted in the unique character that makes Manhattan Beach the most desirable community in the South Bay with the highest property values.

The **concerns** with this proposed amendment are numerous.

The proposed **expanded operating hours, coupled with the expanded frontage of MBPost and the "live entertainment" component,** will create a major change in Manhattan Beach living. If this was a game show question: What do you call an establishment that serves food, has a large full bar, has large open frontage to the street, has live music, and is open to 1 am? Correct answer: Restaurant-Bar-Hangout-Nightclub! And how many people eat dinner in Manhattan Beach between midnight and 1 am?

Although Mike Sims stated that his 'goal is not to have a bar with a late night crowd off to the side' (see transcript of MBPost Hearing on March11 at 9:15pm), **common sense tells us that will not be the outcome.** The Simmzy's restaurant at 229 Manhattan Beach Boulevard (which I enjoy) is a constant source of noise and congestion - but the difference is that it is not in the same proximity as MBPost to residences.

If this amendment is allowed, the changes will significantly and **negatively impact the ability of the local residents to comfortably live in their homes**. The increased noise level will impact such basic rights as being able to sleep comfortably in one's own home - not only for children, but for adults as well; there will be increased trash in the street; increased loitering; etc. And it should not be the burden of the distressed residents to have to complain "after the fact" to try and get a remedy or a change to the Use Permit, especially when **the consequences of the impact of allowing the amendment are now known**.

The available research supported by factual data makes it crystal clear that extending closing times for bars is associated with increased crime, vandalism, alcohol-related violence, and drunk driving. Our MBPD has been working tirelessly to reduce the amount of crime in our city and is already stretched too thin. Increasing the hours that a bar (especially with live music) can serve alcohol will negatively impact the safety of our city. While we all want our local businesses to thrive, we should not prioritize one extra hour of liquor tabs over public safety, or prioritize the desire for more profit by a small group of individuals over the legitimate needs of our very many tax paying individuals.

Allowing MBPost to extend their hours **sets a precedent** for all other bars and restaurants in Manhattan Beach to do the same. Why should one operator be benefited more than the others? Increasing bar hours to 1am is a major change to the character and livability of our city, not to mention the negative impact on our property

values. If people want to party and drink after midnight, they can do so in Hermosa or elsewhere. There is simply no justification for this.

Finally, the decision to hold this "public" hearing in the midst of a quarantine **excludes the community from fully and adequately participating** and having their objections heard. While many members of our community are comfortable with videoconferencing, many others, especially senior citizens, lack the technological expertise to participate in this hearing. Elected officials are public servants and transparency in government is the hallmark of our democracy. Although a zoom meeting may be legally permissible, but for such a major proposed change to our way of life - is it right?

# For all the above reasons, and for all the reasons set forth by other residents, I respectfully request that you deny this amendment to the Use permit for MBPost.

I am writing to share my thoughts about the MB Post expanding into the former Subway location, remodeling with a more open floor plan and increasing its hours until 1 a.m. in the morning.

When the Planning Commission voted to approve the MB Post request to expand, remodel in a way that would increase the outdoor noise level and lengthen the hours until 1 a.m., I was not happy about their decision. I feel that the Council should overrule the Planning Commission decision.

In this new daily ever changing world and city that we live in, it is truly a matter of priorities. Chief Abell explained at the town hall meeting after the rape a year or two ago that it is not possible to simply hire and train enough officers to prevent our existing crime. Subject: Reduction and Simplification of Required Conditions, MB Post Use Permit

In preparing testimony, we have reduced the number of conditions from five to four, by simplifying the language for Condition 2. Occupancy, as follows:

1) Retain the existing closing times for MB Post, the city policy since 2002 [Exhibit 1];

2) Specify the 99 occupancy in the use permit and require at least that number of chairs within reach of a table or the bar. Prohibit alcohol service to standing patrons;

3) Require a technical means, verifiable by code enforcement, that limits the loudness-level of backgroundmusic to inaudibility at fifty feet from the premises, a noise-ordinance requirement; and,

4) At the north entrance to the lounge area, provide a double-door vestibule, as the city required for the 2014 Shade Hotel use permit, and delete the south west-facing door. Additionally, provide noise-blocking west windows, as the city required for the 2011 Strand House use permit [Exhibit 2]

I have verified that Shade Hotel has a double-door vestibule.

We still do not know how much time the city will allot for testimony.

Apologies for the lateness of this report, but we did not receive complete copies of the project plans for MB Post or the list of Downtown alcohol premises until late last Thursday.

We worked over the weekend and early this morning, to prepare the expert analyses that support our conclusions.

The report comprises only two pages, so should not take much time to peruse.

Thanks for your consideration

Jim Quilliam Vice President Coastal Defender Don McPherson President, Coastal Defender Don McPherson, a co-appellant with Jim Quilliam. We own residential rental property just inside the Downtown commercial zone. The one-hour closing-time extension for MB Post will lead to many alcohol premises having later closing times, increasing existing impacts from noise and disturbances.

For over 30 years, I have worked to reduce those impacts, using available mitigation methods, which we want required for MB Post. It took five years and over 20 public hearings for the city to condition Shade Hotel properly. Strand House, the 900 Club top floor and Gelson's only required appeal hearings, which should be unnecessary by now. Unfortunately, staff failed to apply these painful lessons-learned to the MB Post application. So, here we are again, in an unnecessary appeal.

We understand the desire for dining that opens to the outside, which cannot possibly comply with the noise ordinance, as evidenced by Steve Roger's acoustics analysis. Let's trade an entitlement for open-window dining until 10 PM, for a noise-attenuation design after 10 PM. The mitigation must guarantee that the premises will comply with the noise ordinance and use-permit Condition 16, which requires noise not audible beyond the premises.

This will require two proven noise mitigations methods that the city has imposed on Shade Hotel and Strand House. First, a double-door vestibule at the north entrance, which faces south, providing for an easy entrance into the lounge. The south door on the plans requires deletion because it faces the residential area. The two doors in the west façade cannot both serve as fire exits, because they discharge into the same public way, Manhattan Avenue

For the second attenuation method, all windows and the door on the west façade must have sound-blocking glass. The glass must reduce noise by a factor of a thousand, or 30 decibels, the standard used for Shade and Strand House.

Because MB Post will get gutted for the renovation, adding these two mitigation measures will cost relatively little.

Our other mitigation methods reduce noise by quieting the patrons. First, MB Post must provide chairs for the 99 occupants, within reach of a table or the bar. Patron's standing may not have alcohol service. This seating corresponds to a restaurant, as opposed to a nightclub. Secondly, as Jim Quilliam testified, the music volume needs a fixed setting, at the level where it inaudible fifty feet from the premises. These quieting measures have no impact on the applicant.

Finally, denying the one-hour closing time simply means that MB Post will remain one of the 20 out of 35 alcohol premises that close at midnight. Approval will constitute a major policy change for the Downtown.

Dear Manhattan Beach City Council Members,

We are writing to you about our concerns with the Application by the Simms Restaurant Group for the Manhattan Beach Post (MBPost) that is on the Council's agenda for May 5<sup>th</sup>. My wife Kelly and I live just down the street from the MBPost at 1300 Manhattan Ave and are concerned with the changes that are being made to the Use Permit which will allow the MBPost to have a late night bar component to it. Our neighbors and we believe we have a special neighborhood within Manhattan Beach and do not wish it to be negatively impacted by late night bar activity within 100 feet of our homes. The more family oriented aspect of Manhattan Beach was one of the key draws to us when we bought our home here.

Firstly, however, I would like to thank you all for the work that you do for our city and community and especially for the commitment you have shown during recent events

We are requesting that the Council Members retain the key provisions in the MBPost's current Use Permit that restrict bar activities of the restaurant. Key provisions of this current Use Permit have been eliminated or substantially weakened in the Application recently passed by the Planning Commission. I attended that Planning Commission meeting and do not believe that the Commissioners were aware, outside of the extension in operating hours, of key changes being made to the Use Permit.

The Applicant is requesting operating hours to be extended to 1am which is not consistent with the maximum approved hours of the other restaurants on Manhattan Ave north of Manhattan Beach Blvd., nor is it consistent to their current operating practice. The MBPost, Slay's, Fishing with Dynamite and Little Sister all have maximum approved hours of 12 am and currently are not open past 10:30 in the evening, presumably, as there is not enough restaurant traffic to support later open hours. The recently approved Tacolicious, while not as yet open, has maximum approved hours of 12am as well. There is nowhere in the Application material as to why a later operating time for primarily a restaurant is required or justified.

In addition to the increased hours of late night operation, the key provisions that are being eliminated or weakened which will lead to a late night bar are outlined in Attachment 1. In essence, the restrictions of service of alcohol strictly to patrons consuming food at tables, limiting retail bar area to 9 barstools and, that alcohol shall be served only in conjunction with full menu food service, have been eliminated and replaced by alcohol service only in conjunction with food service.

The lifting of these clear, measurable and enforceable restraints on the bar characteristics of the MBPost, will lead to the development of late night bar traffic at this location. In fact, the operator's plans, as outlined in their proposal to the City demonstrate this. While the total square footage of the expansion equates to almost 50%, the size of the bar seating increases by close to 100% (9 seats to 17 seats), and bar and lounge seating, where soon alcohol may be served with only limited food service, increases by approximately 290%. Conversely, the areas with table service increases by

only 34% and the kitchen area is not increased at all (Attachment2). The later maximum approved hours requested in the Application also indicate a more bar oriented business.

We acknowledge the excellent reputation and long standing experience and contribution to the community of the Simms Group. However, their plans are to increase bar traffic in our neighborhood and at later hours. There will be an increased impact in our neighborhood. Additionally, different future operators working under these loosened Use restrictions could further exacerbate the issue.

Allowing the MBPost to extend their hours to 1 am and to have increased bar activity will also set a precedent for the other restaurants in our neighborhood. Please note that the MBPost is currently operating under a Use permit from 1999 with a different operator. This Use Permit from 1999 states that the hours of this new permit were being extended to 12am to be consistent with other similarly approved restaurants. The four other restaurants in our neighborhood all have closing times of 12am and, by granting new concessions to the MBPost, would now have a good argument for extending their hours and loosening bar constraints.

Since we have been living on Manhattan Ave (since 2009) our neighbor restaurants have been just that, neighbors, distinctive from the later hours and higher activity along Manhattan Beach Blvd. We would like to retain this aspect of our neighborhood and not to be subjected to an increased activity level at night. Allowing this increased bar aspect of the MBPost and the extended hours is not consistent within our neighborhood and will negatively impact it . This impact is currently felt through late night movement through our neighborhood for those leaving late night establishments as they return to their parked cars, as there is public parking within and adjacent to our neighborhood

We would request that the Manhattan Beach City Council not approve the Application as presently presented, to limit the operating hours to only 12am ,and to maintain the current Use restrictions that limit the bar aspect of the expansion.

We support the eventual expansion of the MBPost in our neighborhood. We wish to ensure, however, that the present character of our high scale neighboring restaurants do not also take on late night bar characteristics.

Thank you for your consideration to our concerns.

City Council members:

Consistent with Governor Newsom's order, I request you to reopen the city batting cages. Pitching and hitting in the cages is similar to, or no more dangerous than, many of the other activities Governor Newsom has specifically approved of, such as singles badminton, throwing a baseball/softball, hiking, table tennis, throwing a football, kicking a soccer ball, and volleyball. The Governor's list was not meant to strictly limit the range of activities permitted, as he included "athletics" generally if it could be accomplished with social distancing.

Using a batting cage is an activity that is ideal for social distancing as the participants need to be (more than) six feet apart to use it. It is also generally used within families, mostly commonly by parents and their children. Opening up the batting cages would provide a safe outlet for healthful physical activity.
