## **COVID-19 SITUATION REPORT**

**JUNE 2, 2020**

### **CURRENT INITIATIVES AND UPDATES**

- **Continuity of COVID-19 Updates on Weekly Basis**– The City of Manhattan Beach remains committed to providing the community with critical information and updates on the COVID-19 pandemic, despite a second countywide emergency order related to civil unrest. Starting this week, the daily COVID-19 Situation Report will be weekdays only, Monday through Friday. Should any COVID-19 or civil unrest developments happen over the weekend, the City will release timely information using platforms that include: [Nixle](#) Public Safety Alerts, [Facebook](#), [Twitter](#), [Nextdoor](#), [Instagram](#), and post content on the City's [website](#).
- **City to Re-Open Dog Run, Batting Cages and Ping Pong Tables** – Following City Council discussion tonight, Council directed staff to continue with the phase 2, parks re-opening plan and begin to re-open dog runs, batting cages and ping pong tables at various parks. The Parks and Recreation will announce the re-opening dates for each amenity in a future announcement.
- **City Council to Discuss Budget, Outdoor Dining, Retail Shopping and Additional COVID-19 Measures Thursday, June 4, 12:00 PM** – At Thursday's City Council meeting, Council will discuss the Fiscal Year 2020-2021 budget, as well as outdoor dining and retail options on the public right-of-way (sidewalks or parking spaces) and private property for restaurants and businesses to accommodate social distancing measures required by state and county protocols to limit the spread of COVID-19. ### **FEDERAL, STATE, AND COUNTY UPDATES**

- **COVID-19 Testing** – As we continue to fight the spread of coronavirus, L.A. County residents, especially people potentially exposed in a crowd, are strongly encouraged to [test for COVID-19](#). Due to the current State of Emergency in the County, the [operations of some testing sites, including South Bay Galleria, were closed today](#). All patients who registered for appointments were notified by email or phone to reschedule. - **CDC Recovery Resources** – The Centers for Disease Control and Prevention (CDC) developed the [Resuming Business Toolkit](#) to guide employers as they try to resume normal or phased operations. The Toolkit is based on the CDC's [Interim Guidance for Businesses and Employers](#)

- **Staying Connected While Keeping Apart** - The Department of Mental Health in L.A. County, in partnership with Temple University Collaborative, is hosting a learning session on Thursday, June 4, at 11:00 AM. The learning session is titled "[Staying Connected While Keeping Apart: an L.A. County Conversation About Connection and Meaningful Activity in the Era of COVID-19.](#)" The session is an opportunity to come together, discuss, and share. The conversation will cover how the mental health community has been supporting people in maintaining social connections and engaging in meaningful activities while physically distancing. Community members are invited to learn from others, share what you are doing, and ask questions. [Registration is limited to 500 attendees.](#)
- **Support for Victims of Domestic Violence** - Governor Newsom announced an [Executive Order](#) and a [series of initiatives to support victims of domestic violence](#) amidst the COVID-19 pandemic. Initiatives include \$9 million in state and federal funding for service providers of victims and survivors of domestic violence and \$42 million in private partnership funds. A relationship with the California Partnership to End Domestic Violence (CPEDV), Airbnb, and Uber will provide accommodations and free transportation to victims of domestic violence. - **L.A. County Daily Briefing Statistics on COVID-19** - DPH has confirmed 60 new deaths and 1,202 new cases of COVID-19 in today's daily briefing. There are a total of 2,443 deaths; ninety-three percent of people who died had underlying health conditions. Testing capacity continues to increase in L.A. County, with testing results available for over 633,000 individuals and 8% of people testing positive. 6,638 people who tested positive for COVID-19 have been hospitalized (12% of positive cases) at some point during their illness.
