I want to comment about the City Budget. I participated in the budget survey you guys did a couple months ago and submitted comments that are pretty similar to what I'd like to say today. The fact that we spend 38% of our budget on police, is just too much. That is more than Public Works, Parks and Rec, Community Development combined! Departments which improve the quality of life and community for our city.

Looking at the Pie Chart and seeing that 58% of goes to fire and PD is shocking. We are a small city, it seems wasteful to spend so much money for emergency services in a community that is not prone to wildfires, building fires, does not have a challenging bar scene, extreme amounts of crime, etc.

Studies have shown time and time again that investing in community resources builds city morale and encourages people to take care of their city. While we live in a beautiful community a lot of our parks are severely outdated and there are numerous public works projects that need to be completed.

I strongly oppose the police departments request for an additional million dollars. To request that much money while already receiving 38% of the budget is appalling. How does it cost a million dollars to hire two additional staff? Thats not a one time cost, that's a permanent addition to our budget. Frankly I think the police department is taking advantage of the current unrest to increase their budget.

I would like to propose moving that million dollars towards funding for our parks and rec and public works. While playgrounds are closed, let's finally build Manhattan Bech a real aquatics center, let's finally replace the playground equipment at Polliwog. Let's use this reduced time to invest in city projects.


I apologize to Richard and Bob for receiving this twice, but I realized my previous response did not distribute to the entire group.


This is the first I'm hearing from Bob about this particular spot. Bob, as I've said to you before, it would be so much easier if we talked about this kind of thing in person.

I am attaching the parking meter map Erik Zandvliet (City Traffic Engineer) created with the parking spots that are eligible for outdoor dining applications. Originally, Rock'N Fish and Brewco combined asked for three spaces; yesterday, Mangiamo applied for another two. That would indeed take five parking spaces, including the one in front of Shellback's.

Bob, I would mention that Shellback is one of the only places directly adjacent to large parking lots in Downtown Manhattan Beach, and it would be nice to allow your neighboring businesses the opportunity to try to regain some additional capacity for dining while their indoor dining spaces are halved due to social distancing. This is not a cheap endeavor for them and we're all crossing our fingers that this increase in capacity will help them catch up, not get ahead. As a 25-year resident myself, I am most interested in keeping as many businesses Downtown open as possible; this isn't about growing their businesses to outsiders or tourists who aren't even traveling; this is about keeping our friends and neighbors employed.

Dear Mark, Jessica and Esteemed City Council,

May I please make an appeal to open our city tennis courts to allow doubles play?

Playing doubles affords adequate social distance all the time. I speak as a somewhat humble expert as my tennis partner and I are the 3.5 Doubles Champion in 2008, 2009 and as recently as 2018. (Additionally, I'm proud to state that the combined ages of the three pairs of opponents we played in 2018 were far less than only my age! At my age with so few trophies I take any occasion to talk about past victories...)

Playing doubles is all about a team spacing out to each cover as much of their side of the court as possible. This would naturally preclude a team on one side of the court from staying close together. As you can see on the attached diagram of a tennis court, a doubles team when serving would be approximately 36 feet apart with one player serving behind the service line and the other would be positioned at the net on the adjacent service box.

In fact, it would be even further apart as they would be on the hypotenuse of the right triangle formed by the service line and the middle of the service court. Thanks to the Scarecrow from the Wizard of Oz, everyone knows, "The sum of the square root of any two sides of an isosceles triangle is equal to the square root of the third side." In our case, the actual distance would be, well, ummm, er... anyway, it's longer than 6 feet.

The opponents on the opposite side of the court, facing the same court coverage challenge, are equally spread apart. On the rare occasion when feeling particularly frisky (and after the Advil has kicked in), both members of the team are at the net, the width of the court they have to cover is 36 feet, again, allowing for ample social distancing.

On the rare occasion when a team manages to eke out spectacular, extraordinary shots to win a point (we refer to them as "Sports Center" moments) we will certainly refrain from giving each other a requisite pre-COVID high five. Belittling and mocking our opponents, however, will continue in fine tradition.

From a mental health perspective, we all miss our time together on the court which is a high point in our week. Our spouses would appreciate our time out of the home. We are too physically and conditionally challenged to play singles with any enjoyment and I would bet that there are more doubles players than singles player who have traditionally played at Live Oak. By an informal poll, most of us who played before would assess the risk of playing now and opt to play. (This will allow us to talk about the non-players behind their backs which is another favorite pastime.)

As the City Council creatively found the solution for the retailers to open, we are confident you can find a way to make a decision locally to create a carve out allowing so many residents to return to a healthy activity which gives them so much joy.


