

This is a good summary of why known BLM supporters speaking to our police Chief is nothing more than setting up irrational bantering. The panel should have an equal number of pro-police members to counter the BLM supporters, as well as more moderate faith leaders from our community that can take into account the perspectives of police officers and victims of crimes. Besides, giving voice to a group that encourages violence, desires to kill cops, has Marxist roots, and the fact we have had no incidents of inappropriate use of force in MBPD towards people of any color is silly.

Questions for our panelists if they agree:



And it's true, the typical annual average for "unarmed black men" being killed by cops where it's not justified is about 1-2, and the cops do get fired and/or prosecuted in those rare instances. That's out of 300+ million police contacts with civilians per year of which most are conflicts police are called to resolve and do so effectively. Accidental deaths at the hands of doctors is about 100-250k per year depending on how they define it, but we aren't having town halls about that are we?

You can not detach BLM supporters from their politics so yes this is a politically motivated panel. I request council bring up the following FACTS to these panelists for their comments.

A black man is more likely to be struck by lightning than shot by a cop. And a cop is 18.5 times more likely to be killed by a black man than vice versa. And you're more likely to be shot by the cops if you're white, despite black males committing a disproportionate amount of the serious crimes in this country.

Plenty of DOJ data and even liberal academics have done multiple studies that conclude there is no racial bias in police use of force.

And what about the "Ferguson effect" (higher crime, including more innocent blacks dying) in full swing across the country right now, because of the influence of BLM stirring up violence and deterring cops from Doing their jobs for fear of being charged or fired for simply defending themselves in this hostile political climate.

This panel certainly isn't concerned with the impact it has on MBPD morale, and right now every cop in the country is feeling this negativity. The anti-cop culture was already bad prior to Covid and Floyd, as was police rates of stress related health problems, depression, anxiety, PTSD, Substance issues from self-medicating, and suicide. Has any of city council for a second considered the well being of our officers and what this town hall could mean to them on top of all the national hatred? I know you keep saying the Chief wanted this, but council could have set it up to be way more productive rather than political and divisive with its selection of panel members. Why not do an anonymous survey of the morale in MBPD, including whether they feel backed by council or the community? I've seen some pretty ugly surveys from various police agencies across the country recently.

If we want MBPD To better handle potential uses of force, we need to increase the budget for more defensive tactics/arrest and control, regular scenario based training, more tactical firearms training (not just qualifications on paper targets with zero stress), fitness workouts allowed on duty, stress management training such as mindfulness or yoga, and confidential counseling services available that have no ties to fit for duty.

If any of you REALLY CARE about understanding police training issues as well as what happened in Minneapolis- listen to this 30 segment of a podcast that the mainstream media, politicians and BLM are entirely ignoring.

So let's ask: what would it take to make that data equitable—how many Black people would have to visit Manhattan Beach on average each day to make the population percentage match the arrest rate? We know from tourism data that Manhattan Beach receives an average of 10,400 visitors per day. For the arrest rate to be equitable, we would have to have 21,025 Black people visit Manhattan Beach on average per day—over twice as many people of all races who visit Manhattan Beach on any given day.
  - 4. I have attached a document that shows the data, sources, and calculations for the above statistics.
- 2. Why does Manhattan Beach practice community policing? What data do you have that demonstrates that community policing works?
  - 1. Particularly, I would like the point made in <u>this testimonial</u> from someone who has experienced its effects to be addressed: "Proponents of community policing argue that embedding police, particularly in Black communities, can build trust and partnerships that would have changed my calculus [when in crisis], to call [the police]. But the strategy is flawed and has drawn resources away from communities that need it and instead directed them toward policing. Time has shown that community policing is merely an expensive attempt at public relations, after a long history of racialized police violence and injustice, and does little to reduce crime or police violence."
- 3. Why are police in Manhattan Beach involved in addressing people experiencing homelessness, and what training do they have to undertake that work? In <u>a survey conducted in Portland</u>, people experiencing homelessness suggested that they would want first responders to be: mental health professionals (88%), peer support (74%), social workers (69%), EMTs (54%), conflict resolution counselors (54%), nurses (52%), and firefighters (42%). Police officers do not make the list. Why are police included in our list of first responders, even under the homelessness initiative created by the city?
