

Hi,

In addition to questions I submitted to be asked if the panelists that are Mira Costa alumni and clergy (which I sincerely hope get asked), I have these comments and questions for the Chief:

Being a former police officer and having trained thousands of police officers in scenarios, fitness and combatives, as well as studying police issues in multiple graduate degrees, it is my opinion and that of many nationally recognized law enforcement instructors That most police officers do not get sufficient training from their agencies to be effective in worst-case violent encounters.

Had the officers in Minneapolis been super fit, well trained in martial arts, and had regular stress inoculation scenario training – it is likely we would never have heard of George Floyd. Police officers that are highly trained in fitness, firearms, defensive tactics and get regular scenario training are far more effective at de-escalation, and remain calm Making better decisions even when fatigued or highly stressed.

- 1) how many hours per year of defensive tactics/arrest and control do MBPD officers get?
- 2) how many hours of firearms training per year does MBPD get, and is it just mandatory qualifications on paper targets, or regular tactical shooting training in adverse conditions such as low light, shooting while moving, shooting moving targets, and shooting reactive targets that give visual and auditory feedback instantly?
- 3) how many hours per year does a MBPD patrol officer get in stress inoculation scenario training that includes force on force with Simmunitions or equivalent, as well as hands on full contact fighting a resistive subject?
- 4) do patrol officers get time on duty to do fitness workouts? many experts to include Dr kevin gilmartin advocate this is essential for performance on the job as well as for stress management to Mitigate the Hormonal issues from this kind of work, that lead to a host of higher rates of disease, medical conditions and shorter lifespans for officers. Many departments do allow on duty fitness.
- 5) are there any ongoing fitness standards for MBPD officers after the academy?
- 6) does MBPD provide any sort of stress management or self regulation training such as yoga or mindfulness for officers.
- 7) does MBPD provide free therapy services that are anonymous and totally confidential for officers and their families to utilize where the department doesn't even know who took advantage of them nor do they ever see the notes, taking away the stigma of seeing a therapist, like Santa Monica PD does.

Now consider whatever few hours most likely that a police officer in Manhattan beach gets annually for defensive tactics or firearms, and compare that to the weekly hours of sports practice youth or high school athletes get. It is very likely

that a high school athlete trains more hours in a week then A Manhattan Beach police officer trains per year in skills that could mean life or death for the officer. That's a problem.

Do you believe that MBPD officers would benefit from further training in the above areas if the city were to provide more money for training?

One of the members of city Council told me that there was no need for more training in MBPD. Unfortunately from my perspective, and still speaking with police officers across the country seven days a week, I do not know a single police officer in the United States of America that does not think they could benefit from more fitness, firearms, defensive tactics, and scenario training.

The lack of training as well as resources for stress management and mental health, are conversations that the media and politicians have completely ignored in the last month of chaos in this country.

When the public sees things that look ugly, first of all there is no way to get a resistive subject into custody and make it look nice. Second, if you see something that is blatantly dumb that an officer does, it is not racism it is usually failure to train and because an officer is overwhelmed and in over their head.

Implicit bias training is an absolute waste of money. They are usually expensive consultants that have no credibility with law-enforcement, and do death by PowerPoint lecturing police officers about racism from a narrow point of view. It goes in one ear and out the other. If you hired a racist you will not be able to lecture it out of them. Take whatever money you might consider spending on PowerPoint training that is ineffective, and invest in regular defensive tactics and scenario training along with more tactical firearms training for the officers in MBPD.

If these comments cannot be read to the chief or the questions answered in the meeting, I would like them documented within the notes for the Town hall discussion and and brought up for further discussion as another agenda item in the future.


I don't think I will be able to attend the meeting today, but I would like to bring a couple of questions and comments to the table.

- 1) I would like that the city of MB require the Police Department to post Nixel alerts whenever there is police activity. This weekend the police were handling a car robbery on my street. We found this out after the fact on social media, but it would have been appropriate to be notified as it was going on. If the police have time to get a chopper to hover our neighborhood then we should be given a simple notification.
- 2) When we receive nixel community alerts I would request that the city of MB require them to say more than "police activity." I want to know if I should be staying inside with the doors closed because there is an armed robbery or if we are talking about a car accident. I often hear city officials complain about rumors being started on next-door, but rumors are often the result of a lack of transparency.
- 3) This might exist already, but if it does it is not easily found. I would like to be able to see a report that lists the police activity in the community. I live in the tree section and we often have a lot of crime because we are close to Sepulveda and Target. I would like to be able to see that report and find out what our police are often responding too. Not only should this be available for residents, Manhattan Beach should have a community oversight committee that looks at these reports and suggests policies. I greatly recommend the resources from this page.
- 4) About 15 years ago there was a big push on making sure that people were not speeding and rolling through stop signs. I think it might be time do something like that again. The amount of speeding going on through our neighborhoods is getting out of hand, a the beginning of COVID it was better since people were staying home, but, now that people are out and about again the amount of speeding going on is quite dangerous. I take my kids on walks everyday and everyday I see people speeding and just driving straight through stop signs.
- 5) I complained over social media this weekend to the fact that I had cops speeding down our street, our road closed off, helicopter overheard, and we received no nixel alert. I have to say I am pretty disappointed with the first response. That first response is passive aggressive and dismissive, which I would hope is not a part of our Police Departments values.
- 6) Last thing! I would like to inquire on the Manhattan Beach's practices for chokeholds, de-escalation training, body cameras, etc. I think it is imperative that we look at resources like Campaign Zero for guidance. They have
