This communication is in respect to your agenda item on amending the MuniCode regarding trees and right of way on tonight's agenda.

I believe you need to devote more attention to directing effective enforcement and education. I see in tonight's Staff Report that per the July 7, 2020 meeting, the following of substance was directed to Public Works: "However, based on City Council direction provided on July 7, 2020, staff will develop an outreach plan to better inform homeowners of their responsibilities relative to the adjacent public right-of-way."

Yet, as can be read from the "resolution" of my tree trimming complaint logged 7/13/20 (from a May 29 complaint), and my reply message to Ernest Area below, a "resolution" of merely contacting the offending tree trimmer without any notification to the property owner and with no fines assessed against a knowledgeable tree trimming provider hardly seems to meet my expectations, the council's directive, or the spirit of the ordinance.

This is important to address now, because Council history is that you aren't going to address tree issues again for the next 10 years.

P.S.: You might take a look at the proposed ordinance reference to California "Government Code, Title 24" as per Ord 20-0010, Section 8. My specialty is the Revenue and Taxation Code, but the way I read it, California Government Code, Title 24 deals with "Minimum Essential Coverage Individual Mandate," not sidewalks or clearance. Were the reference instead to the California Building Standards Code, California Code of Regulations, Title 24, Part 2, Volume 1 of 2, Sec. 1113A (Walks and Sidewalks on an Accessible Route) and 1116A (Hazards on Accessible Routes), then that would make more sense to me and would be more "accessible" to a reader/resident. I would also suggest, as I have before, when there is a reference to a source outside the MuniCode, a copy of the actual reference should be included with the Staff Report.

Just want to provide feedback that this "resolution" doesn't seem sufficient to me.

Travers has been a long-term, well-funded, well-known provider of tree services to Manhattan Beach. One would have thought that they, as well as other selection and identified similarly-situated tree companies serving our community would have already been apprised of our rules, at least on an annual basis.

Further, I find them unprofessional in their own right as to (1) not following ANSI standards or (2) not having researched M.B. tree ordinances under their own due diligence. Nor do I see any attempt on your part to obtain an invoice or work order from Travers to determine what was requested by the client vs. what was provided by the provider.

In my opinion, the situation deserves a fine. As with any fine, they can appeal.

I also do not see anything in your "resolution" where the resident was apprised that they were serviced on a substandard, illegal basis, and could as well be found subject to a fine.

I went out of my way to alert the city to this problem. I expected the city to do more than me in this situation.

The \$100 fine was a much needed jolt to our residents showing that our community leaders are serious about trying to defeat this.

I have a suggestion. My family on my dad's side lives in the town of Warrensburg, Missouri. I wanted to see how their battle with Covid was going. I immediately found statistics for their whole city, how many cases, how many cases in each age group, how many hospitalized, how many on ventilators, what neighborhoods most affected, etc. I can't find any of those stats for MB (for LA County, but not specifically for MB). I think it would be helpful for all of us to know how we went from 74 cases on May 20, to 80 cases on June 1, to 121 cases on June 27, and today 228 cases!!!! What age group is spreading and being infected by this virus? I think everyone in MB has been thinking it's only the elderly, only the sick, and it doesn't affect them or their family, or their kids, so why wear masks? Why social distance? We understand that the recently enacted mask ordinance will be coming back to Council on Tuesday .

We do **not** support the City ordinance/executive order in its current form.

We believe that the City should utilize the expertise of the Public health division of both the State and the County and keep the social distance requirement (mask if closer than 6') that has been in effect for at least three months.

We would however, support the addition of a fining mechanism to be added to these existing guidelines for a period of time-(For example- when unable to attain social distance of 6', a mask is required except when seated at a restaurant). There is no scientific reason to be more stringent and hold us to a higher standard in distancing than the State and County.

If you want to use enforcement, then simply add the fine to the Statewide standard for a defined period of time and then reevaluate.

We have previously sent examples where this more stringent than the State and County order/ ordinance - to be masked at all times does not make sense:

It is extremely rare to see anyone walking down our street.

That definition seems to exclude all disposable masks which includes most medical masks and virtually all disposable masks available to the public and used by most people. As a matter of fact, I've seen police officers wearing this type of mask. I also suspect that most people in Manhattan Beach are using these disposable (non-cloth) masks and I suspect they don't even dispose of their disposable masks after each us.

I can't help but question the focus on Cloth Face Coverings instead of social distancing as the primary goal. It has been proven that social distancing is a much better solution than "face masks". Public Works Maintenance Supervisor Price stated that there are a total of 75 carrot wood trees and that even with the severe pruning taking place; these trees will double in size over the next ten years.

Discussion

Commissioner Seville-Jones stated that although she is sympathetic to the residents concerns, she has to question how the City can deal with these four trees and not the rest. She stated that she is leaning toward the short term measure of pruning the trees as much as possible in hopes that the City Council will address the long term solution of replacing the trees.

Commissioner Osterhout agreed, commenting that he does not find reason to overturn staff's recommendation, noting the past decision of the City Council to retain the trees.

Commissioner Donahue pointed out that the trees have been cut back since the pictures were taken for the Power Point, and that he believes the 8th Street residents have a great view. Commissioner Donahue stated that it is best to address the situation of the trees together, versus a piecemeal approach, and that he will support staff's recommendation.

Commissioner Paralusz noted her agreement with Commissioner Seville-Jones, stating that she too is sympathetic to the residents' concerns, however will support staff's recommendation as removal of the trees is not justified under the City's Code.

XI'milly

Chairperson Lang voiced his support of pruning the trees as an interim measure until the City is able to address the long term solution. He also questioned why a Downtown beautification plan includes the planting of trees which can block the very ocean that makes the area so beautiful to begin with.

Action

A motion was MADE and SECONDED (Seville-Jones/Paralusz) to deny the appeal of existing policy prohibiting removal of streetscape trees for view enhancement - 8th Street and Manhattan Avenue; instruct staff to prune the trees more often; and request that the City Council address the trees in Downtown Streetscape in light of the future damage they can cause.








8th Street – trees 15 to 20 ft tall...



To City Council Members

I understand the city council will again be discussing masks, I assume in light of your decision last week to install fines for violation of the mask order instituted by the state and county.

I am supportive of the institution of fines and enforcement, but believe the Council should do several things to help make wearing masks more universal within the City.

I understand this is a very difficult mandate to enforce, for many reasons, including that we have many visitors, from all over LA county and beyond, and its unfortunate politicization. However, we must do our part to help stop the spread of COVID, and we know masks greatly assist in that task.

So:

-Make clear that the ENTIRE City Council supports the wearing of masks when out in public and keeping 6 feet of social distance, and will enforce the mask mandate. This support should extend to all City Council member communications, including that on social media, which tends to be where most citizens are seeing the message. Currently, there seems to be a mixed message in that area, with certain council members casting doubt on our approach. It is extremely damaging to getting more mask wearing support.

-Lets clarify our enforcement to stress we will focus on enforcement in areas where it is difficult, if not impossible, to remain more than 6 feet from others for more than a minute or two. That is in Downtown MB and the Strand (and perhaps the North End business district). Making clear we will engage in common sense enforcement will go a long ways to getting widespread public support.

-Get leaders in the business community to publicly support this approach, using the logic it increases the likelihood their businesses will succeed and stay open. Seeing this in social media, local newspapers, and perhaps even in signs and banners would be helpful.

-Overall, more signs/banners are necessary. I know sign pollution is a concern overall, but this issue requires us to put that aside during this very dangerous time.

It is distressing that mask wearing is such a difficult issue for our MB citizens and those of other communities to get behind, when the science is clear it can help. I believe these very doable suggestions can go a long way to making MB more safe and a good example to our neighboring communities.

Thanks for all you are doing during this very difficult time.

I write to comment on the new order requiring that masks be worn outdoors in the city except while eating and drinking in outdoor dining establishments and with certain other exceptions. I would like to state my objection to the mandatory mask edict by the Manhattan Beach City Council. Since there are many premises upon which I could make my objection, I would like instead, to review the science behind the futility of cloth masks. Attached is the most comprehensive scientific study I could find regarding the effectiveness of masks in preventing the transmission of influenza and coronavirus. The study was conducted by the National Institute of Hygiene and Epidemiology in 2015. It included 1607 hospital healthcare workers in Hanoi, Vietnam over the age of 18. The participants were full time healthcare employees assigned to high risk wards. The study concluded that cloth masks were not effective in containing viral spread when exposed to sick patients. Even our CDC along with Dr. Fauci stated in March that masks were ineffective and unnecessary for the general public. Folks,

I am not against mask usage and agree with a practical usage requirement. In fact, if anything, I have been opposed to the City's lax approach to masking and distancing, and have always argued that signage doesn't work.

However, I am also dismayed by "mixed messages" from government at all levels, that some government bans make no sense (such as preventing people walking across the Sand Dune greenbelt), and that many residents use these "mixed messages" as an excuse to avoid responsibility altogether.

That said, I cannot see why the CM's emergency order is more restrictive than the County's.

For reference, the CM's order is that "All persons shall wear a face covering over both the nose and mouth whenever leaving their residence." Period.

The County's order is to "wear a cloth face covering over both the nose and mouth whenever they leave their place of residence **and are or can be in contact with or walking near or past others who are non-household members** in both public and private places, whether indoors or outdoors" (the "Face Covering Requirement")."

Or, from the County's non-regulatory guidance: Los Angeles County Department of Public Health - Guidance for Cloth Face Coverings. When should I wear a cloth face covering? You are asked to wear a cloth face covering over your nose and mouth when you must be in public and there are others nearby. If you are in a solitary area you do not need to wear a face covering. Wearing a cloth face covering does not eliminate the need to physically distance yourself from others and to wash your hands frequently. Please see the various guidance documents on the public health webpage to know when face coverings might be required in specific

places. http://publichealth.lacounty.gov/media/Coronavirus/docs/protection/GuidanceClothFaceCoverings.pdf

Of course, as I have pointed out numerous times, language precision in many City reports and releases have a lot to be desired even when flush, noncontradictory language is available. But the CM's order is also in line with what I have pointed out numerous times: that the City's lax approach and ignoral of existential violations never seems to be to anyone's benefit and always seems to result in an overreaction when things have gotten so bad that the City can't avoid remediation.

And City Staff will continue such practices until the Council directs them to the more reasonable approach.

Current Initiatives and Updates

- Our Community, Our Health, and Our Responsibility Los Angeles County hit concerning milestones this week, reporting the most cases in a single day, the most hospitalizations (young adults are making up 20% of the COVID-19 patients currently hospitalized), and tragically high death numbers. Without aggressive action on everyone's part, we will not get back to slowing the spread. We each must keep others and ourselves safe by using face coverings in public and maintaining a physical distance. At all times, wearing a face covering over both the nose and mouth lowers the risk of person-person contact for yourself and others. It is our community, our health, and our responsibility. Wear a face covering!
- Wear a Face Covering When Leaving Home Or Pay a Fine The City Manager issued a restrictive <u>Emergency</u> <u>Order</u> strengthening the requirement for face coverings. The time for warnings is over. All persons shall wear a face covering over both the nose and mouth whenever leaving their residence except for:
 - Persons under two years old;
 - Persons with a medical condition, mental condition or disability that prevents wearing a face covering;
 - Persons who are hearing impaired where the ability to see the mouth is essential for communication; and
 - o Persons who are swimming or engaged in other water-based activities.

Citations for failing to wear a face covering will be issued with fines starting at \$100 for the first violation, \$200 for a second violation, and \$350 for each subsequent offense after that. The Emergency Order went into effect on July 15 with limited exceptions. View the <u>press release</u> for more information.

- State and County Close Indoor Operations in More Business Sectors L.A. County Department of Public Health (DPH) issued a <u>Revised Public Health Order</u> following <u>Governor Newsom's July 13 announcement</u> to shut down indoor operations in select business sectors due to surging Coronavirus cases. The staff continue to monitor and speak with the health experts at Los Angeles County Department of Public Health (LACDPH), Department of Public Health (CDPH) and the Centers for Disease Control (CDC). Their health expertise and guidance are critical to the City's planning and response to the coronavirus.

The Manhattan Beach Chamber of Commerce takes our role in the business community seriously and strives to bring together the business, residential, education, and philanthropic and civic groups in the city. We take pride in our role and constantly work towards upholding the goals (Article 1, Section 3) set forth in the MBCC bylaws. The staff and the Board of Directors act in accordance with the highest level of ethics and professionalism. The membership is dynamic and rich with depth, diversity and complexity and spans most all sectors and sizes of business.

Manhattan Beach Chamber of Commerce Bylaws

Article 1, Section 3 reads as follows:

This Chamber is organized to promote Manhattan Beach as a better city in which to live and in which to do business; to advocate the advantages of living and doing business in Manhattan Beach; to bring about a more enlightened understanding of community problems and community issues as well as city, county, state, and national affairs; to encourage the growth of existing industries and businesses while giving assistance to any new firms or individuals seeking to locate in the area and to provide a resource to members in the community.

In light of the recent statements made by Mayor pro tem Suzanne Hadley, the Board of Directors of the MBCC is respectfully requesting that Mrs. Hadley be relieved of her assignment as the City Council Representative to the MBCC. We are aware of her tweet posted on November 16, 2013 in which she reposted a tweet from Dennis Miller that reads; *Somebody in Ad Land is missing a great opportunity by not drawing Obama's face on an icy pitcher of Kool-Aid*. Upon learning of this tweet, Mrs. Hadley was immediately contacted by the Chamber to discuss this matter. Subsequently, we have had several MBCC members and residents of the community call the MBCC to bring this to our attention. In addition, several of these callers also stated that they had reached out to Mrs. Hadley via email and phone to also have a one-to-one conversation regarding the tweet.

The Chamber and many of the mentioned inquisitors have also attempted to understand her insensitive comments made during the MSNBC interview on Tuesday, June 30, 2020. Later that day, and during the City Council meeting that began at 6 PM that evening, Mrs. Hadley also referred to the KKK during a discussion regarding the use of public facilities for campaign or political use. During the Council discussion and at approximately 3:22:00 – 3:22:30 in the recording she used the KKK as an example of a group that may or may not be able to use the facilities. Of all the comparisons, she chose one of the most highly controversial racial affiliations to use in her comments.

We feel her repeated insensitive comments and lack of public apology have had a negative impact on the business community and the reputation of Manhattan Beach as a whole. The comments that we have received have been submitted by the local community, Southern California residents, and as far away as the East Coast neighborhoods.

We request an explanation of how the City of Manhattan Beach is officially addressing this very unfortunate series of actions by Mrs. Hadley. Her statements, and particularly the aforementioned tweet, have repeatedly been stated at City Council meetings during public comments, since June 30,2020 and also during the Community Forum held on July 9, 2020. We are not aware of any official apology made by Mrs. Hadley or a statement made by The City of Manhattan Beach, further angering the community and casting an unfavorable image of racism and bias in the city.

Thank you for considering this request. If there is not a timely reorganization of the City Council assignments, we kindly ask that her name be removed immediately from all official documents listing her as the City Council Representative to the MBCC.

We feel it is in the best interest of the Chamber of Commerce and the business community to address this matter out of the public spotlight. We have no intent of requesting this in a public forum or during a City Council meeting. We hope that this will be handled with heightened discretion. I've just read the article in the Beach Reporter about citations and fines for individuals who are in "public" and not wearing a face covering.

I am concerned.

What is meant by in public? If I walk outside my house without a face covering am I required to be wearing a face mask? What if I'm on my PRIVATE property but outside the structure? What if I'm on the sidewalk in the front of my house?

It seems as if "in public" is way too vague. What about 6 year old children playing in their yards or on the sidewalks in front of their house? Or in the family driveway?

It also seems to me that the rule should be codified and put through some approval process beyond 5 City Council members. What about a formal notification to all city residents regarding a City Council meeting that plans to address this unwritten code?

Had I not picked up the Beach Reporter I would not even have known that walking around in public (maybe even on my own property) would lead to a citation by someone.

You may recognize my name and email address as the person who voiced my view that our police department is essential. I still believe that. But there is no reason that they should be wasting their time and good will writing citations for this "rule". I suspect that this rule should be extremely well defined and publicized before going that far.

I have recently read the new dictates coming down from the City of MB regarding how we are allowed to spend our time outdoors. Let me just say, that when appropriate I always wear a mask out of concern for others. This would be in a store or any place where I am in a confined space. I have not put myself in a position to be in large groups. I firmly believe that it's our duty to do wear a mask in these situations.

That being said, I do not agree with your stance that all people, with a few minor exceptions, are to wear a mask when outdoors. I listened to the recent City Council meeting at which new actions to stop the sharp increase in confirmed COVID19 cases were discussed and agreed.

But I still wonder <u>who will be designated to enforce the new emergency order and issue the</u> <u>"administrative citations"?</u> <u>And how soon?</u> That was not clear at the meeting and it remains unclear from the current order.

1. The city has been reluctant (a carefully chosen word) to ask its police department to take on this task

2. City Manager Moe indicates that "that the city's code enforcement officers are already busy to capacity."

3. Community Service Officers (CSOs), non-sworn staff under the jurisdiction of the police department, however, CSOs do not have requisite training or experience.

4. The order authorizes the city to "deputize additional persons to issue administrative citations."

a. Who is responsible for identifying who should be deputized?

b. What credentials and training will be requirements for target "deputies". c. What date is targeted for hiring? (It goes without saying that enforcement will be minimal, at best, until "additional persons" are hired.)

Until there is an actionable -- and actioned -- plan to address the above questions, the "emergency" order doesn't seem like much of an emergency.

Finally -- I hope the part of Manhattan Beach east of Sepulveda will be included in enforcement. I heard absolutely no discussion of Polliwog Park, Marine Park, Manhattan Heights during the last council meeting. Manhattan Village was only briefly mentioned "in passing".

I walked through Polliwog Park & Manhattan Heights areas last night. About 20% of the people are wearing masks. Most of the people walking their dogs in the evening do NOT wear masks. One man had a mask on his young daughter, but did not wear one himself. The others are maskless, especially those by the pond in Polliwog Park.

I wanted to point out that the virus circulates east of Sepulveda also.

- The state of California website (<u>https://covid19.ca.gov/masks-and-ppe/</u>) states that you can take off your mask "When outdoors in public and can stay six feet from others".
- The Los Angeles County Public Health website (<u>http://publichealth.lacounty.gov/media/Coronavirus/docs/protection/GuidanceClothFaceCoverings.pdf</u>) states "You are asked to wear a cloth face covering over your nose and mouth when you must be in public and there are others nearby. If you are in a solitary area you do not need to wear a face covering".

From my understanding, I can still run outside as long as I stay at least six feet from others. I always carry a face covering but try to go out very early when there are not many people outside. I would appreciate further clarification on the Manhattan Beach city face coverings requirements when exercising outdoors.

4) Why doesn't your "CIP" two-year budget mention anything about Prop A or Measure A and availability of such parks funding (outside of the brief abbreviation of Prop A on p. 311)? One would think that the abbreviation on p. 311 to "Prop A" refers to transportation funds.

5) Why doesn't the staff presentation to P&R even discuss the reasons for the escalation? Fear of identifying who screwed up?

Dr. Nichole Quick Orange County Health Officer resigned after weeks of attacks — and a death threat — over her mandatory mask rules. . Her replacement Dr. Clayton Chau rescinded the rules amid intense pressure from the Board of Supervisors. Instead, Orange County "strongly recommends" wearing masks in public settings.

There's a common refrain that masks don't protect you; they protect other people from your own germs.

But now, there's mounting evidence that masks also protect you. If you're unlucky enough to encounter an infectious person, wearing any kind of face covering will reduce the amount of virus that your body will take in.

As it turns out, that's pretty important. Breathing in a small amount of virus may lead to no disease or far more mild infection. But inhaling a huge volume of virus particles can result in serious disease or death.

There is this theory that facial masking reduces the [amount of virus you get exposed to] and disease severity.

Experts say masks are essential for people to wear when they go out in public, such as to shop or go to medical appointments, and when close to other people at the beach or park.

The idea of requiring mask-wearing in public has become an increasingly pressing and politicized issue as California. But there remains resistance to the government mandating wearing masks in some corners of the state, including Orange County.

Orange County Board of Education - a <u>document</u> stated that "requiring children to wear masks during school is not only difficult — if not impossible to implement — but [is] not based on science. It may even be harmful." "This anti-mask rhetoric is mind-blowing, dangerous, deadly and polarizing," said Dr. Peter Chin-Hong, professor of medicine and an infectious diseases specialist at UC San Francisco. "There is no evidence that it is dangerous."

In fact, wearing masks can help prevent children from being infected and suffering serious consequences of infection, such as <u>multisystem inflammatory syndrome</u>, a rare condition that has been seen in children who have been infected with the coronavirus. "Kids not only transmit, but they can get sick as well," Chin-Hong said.

While children are less likely to develop severe illness from the coronavirus than adults, they can still be infected, be contagious and transmit the virus to other people.

Wearing a mask at school would not only reduce their ability to transmit the virus to other classmates, teachers and administrators, but also protect the students from getting infected with a large dose of virus from infected people.

And even if a person wearing a mask gets infected, the mask - by filtering out most of the viral particles exhaled by the infected person — probably leads to less severe disease.

The protective effects are also seen in countries where masks are universally accepted for years, such as Taiwan, Thailand, South Korea and Singapore. They have all seen cases as they opened ... but not deaths.

Yes I have transitioned many to online especially for those who are at higher risk. BUT Equipment is key to provide proper rehabilitation which is 99% of clientele that are worked with individually... As mentioned, most of the clients whom i work with (and many of my colleagues) have some form for rehabilitation as a part of their sessions.

The boutique studio PISC I work with has gone beyond covid guidelines, providing a very safe atmosphere.. we have good air-flow / ventilation, beyond 6 ft apart of clients/teacher masks are worn, temperature is taken, hand washing is complete. We schedule our clients, know who is coming in and out, we space out the schedule so there is no collision at door fronts either. Up to this point the clientele coming into the studio had been down by 80% so even our small boutique has even gotten smaller keeping extreme safety for all. In addition to keeping the health (physical and mental) of our clientele. This obviously continues to cause a detrimental effect on the business income.

The regulations issued are a one size fits all and the studio i'm specifically i'm speaking to (as well as i know many others) do not fit under that one size. We are not a gym but a professional trade service that provide health, functional movement that support many rehab types of needs that are mostly personal sessions with under 8 individuals total in the studio at the same time and beyond 6ft distancing and with masks. so have very safe protocols in place.

I'm petitioning that Pilates Institute of Southern CA at 120 S. Sepulveda Suite A MB 90266 can be re-open by providing (again) the covid guidelines we are practicing that keep everyone coming and going very safe. I'm petitioning to please support your businesses.



Councilmember Nancy Hersman – "She and her colleagues should discuss restitution (REPARATIONS) for the descendants of an African American couple that had Bruce's Beach, a resort for and owned by Black people, legally stripped from them in the 1920s."

REPARATIONS – How much money is the City willing to pay for Reparations and will the residents have a vote on how their money is being spent?

\$50,000, \$500,000, \$1,000,000, \$10,000,000 or \$100,000,000

UN panel declared that the U.S. owed black Americans reparations because of slavery and its link to injustices today in America. Potential costs of reparations — and by Yahoo Finance estimates, these could reach as high as \$17.1 trillion.
