Hello Manhattan Beach City Council -

I wanted to provide input as the council and a committee "evaluate" the Bruce's Beach situation. For context, I have been a resident and home owner here since 1990. I have witnessed the racism of our city, as my long time nanny (who really became a member of our family) was black. In the mid 1990s the MB police routinely followed her car from Rosecrans to our house in the tree section. After weeks of this type of harassment I phoned the police station and put an end to it. However, I learned that our practically all white community has a bias of being suspicious of black people who are assumed to be outsiders.

That said, the Bruce's Beach situation is hysteria gone wild. This is an attempt (potentially driven / motivated by people outside of our community) to impose 2020 standards on what was a unfortunate, but not overly uncommon, occurrence of eminent domain abuse. If the history needs a retelling, or if there needs to be a mechanism for greater community awareness, by all means tell the history. However, anything beyond that MUST consider the best interests of our community today, not the "victims" (or their descendants) of the historic wrong. The members of the MB City Council have a duty to our city and our residents as we exist today. While I am not an attorney, I suspect that there is no legal basis for the council to provide either the actual property (which I understand is owned by the county) or city funds to any individual as reparations; and demonstrating that such reparations is in the best interests of our community today would be impossible and open the city to extensive litigation. In short, an attempt to monetarily right a wrong that occurred (and was finally litigated) more than 100 years ago through reparations is likely illegal, and thus impractical. Moreover, and, perhaps most importantly, land or financial reparations are morally wrong to the current residents who have invested heavily in this community as it is today and has been for all of our lifetimes. You can't right a wrong with another wrong.

I believe that the city and council would be well served by quickly getting strong legal advice to allow a public comment that ANY reparations in the form of financial consideration or return of property is illegal and therefore off the table. If the Bruce family (or their group/representatives) want to go to court for reparations then the city certainly can't stop that; (though I doubt any lawyer would waste time or energy trying as the actual legal case has no merit). However, by getting financial and property reparations off the table, it will allow a much more productive conversation about what can be on the table. Obviously, signage, story telling, formal apologies, and similar actions are appropriate to consider. Moreover, we can offer other things to welcome the Bruce family as "residents." Our public school could be open for their family to attend. Perhaps they can utilize a small portion of the public Bruce's Beach for some type of commerce that doesn't require extensive or permanent development (a Bruce Family snack shack, food truck, etc.). I strongly believe that our community can do much more to welcome people of color; however, we must accept the past, stay within the legal bounds of today, and not waste resources and time trying to do something we can't. Let's focus on what we can do to improve our community now and looking forward. For better or worse we can't fix what was done 100 years ago.

I welcome your feedback.

Nancy/Suzanne:

I recall you two volunteered to form a review subcommittee in respect to street sign/banner placement. I hope this is still progressing (although unless the results are to make placements more restrictive, I'm fine with the current rules, with enforcement and compliance).

In your evaluation, I would point to a current hanging of the White Light, White Night banner over MBB, replacing a mask-awareness banner.

The way I see it, there isn't much more important today than mask awareness, especially downtown, and certainly not a fundraiser (without arguing the relative merits of Walk with Sally).

I have posited in the past that community polls show that less than 2% of people get their information from street banners (and that response metric does not exclude the same people from indicating they also get their information from other sources). Thus, it is not essential to the success of a program to have a street banner, and for the most part I've asserted that the significance of a banner is generally for the benefit of the ego of the event planners.

This is not to say that certain banners don't have their uses to augment vital, essential programs of significant benefit and broad interest to the entire community. In that short-list category, I would place in the community benefit basket an encouragement to vote at election time or to alert to mask enforcement. In another basket I would put those placed for enthusiasm broad-interest events as the Hometown Fair or International Surf Festival, where the purpose is to arouse spirit and excitement rather than provide advertising for ticket sales.

In the instance of White Light overriding Mask Awareness, you are either saying that it is not important to have mask awareness, or that the banner isn't all that essential for mask awareness, or that masking really isn't all that important. In which case, it can't be all that important for White Light, either.

On the other hand, you folks have a 100%-everywhere mask-wearing enforcement policy.

So the logic escapes me.

Eminent domain is a process that allows a community to purchase property wanted for a given reason. The property is not stolen. The property owners are reimbursed a market value for the property. They are displaced but with capital to reinvest/use in any way that they choose. Again, the eminent domain process is not theft.

Are all eminent domain actions virtuous and good for all involved? No, in some or many instances they are forced sales but still they are not thefts. In the case of the Bruce family (and others) and MB, some believe it was racially motivated. That may be true, however, their property was not burned in the middle of the night with the owners inside/out. The owners were not tarred-and-feathered and throw out of town. No, the legal process of eminent domain forced the sale.

Are property owners always in favor of the sale of their property via eminent domain? No, and in most cases the owners did not request the sale. However, the process is a sale, not a theft.

Did eminent domain rob the owners of "generational wealth"? No. A family's future wealth following eminent domain depends upon how the family reinvested/used the money received via the sale. If a family invested funds wisely or spent funds wastefully determines the "generational wealth" of that family. The eminent domain sale "forced" them to liquidate an asset but not their wealth. What if they reinvested their funds into other good property or in General Motors, or Disneyland or Apple company stock many years ago (that surprisingly witnessed great appreciation many years later)? Their "generational wealth" would be huge today. Would they owe MB money based upon the family's current wealth? No, and the converse is true if they did not invest their funds wisely.

Also, the idea of returning the property sold via eminent domain makes no sense, — unless — the City wishes to kowtow foolishly to the "politically correct" crowd. It was a sale, not a theft.

Heck, most of California, and even much of the Southwestern USA and more was owned/occupied by the Spanish/Mexicans and Native Americans before it became part of the USA. Maybe the USA should return that land to its previous owners/occupiers.

If you wish to right every "bad race deal", I can, but will not, enumerate a multitude of efforts/actions by our country/government over the past 50+ years to address issues of race. Remember, eminent domain by MB did not make them rich. How the families used their funds from the sale 100+ years ago determined their "generational wealth".

Similarly, no action is needed for those families who do not own MB property today and did not put their eminent domain funds to good/appreciating use. We can feel sad that eminent domain has been and can be used for less than virtuous reasons. However, MB is not responsible for how the families used their money nor their resulting "generational wealth", rich or not.



Trump's Payroll Tax – Social Security & Medicare

President Trump's executive order purportedly aimed at relieving Americans of the burdens of the coronavirus <u>concerns the payroll tax</u>, which funds Social Security and part of Medicare. Executive order poses a mortal threat to the 64 million Americans who currently receive Social Security benefits and the hundreds of millions more who will receive benefits in coming decades.

If he's reelected, Trump said, he will "terminate" the payroll tax. Make no mistake: He's talking about bankrupting Social Security.

That cutting or deferring the payroll tax <u>does almost nothing for the vast</u> <u>majority of working Americans</u>, not to mention those out of work; would overwhelmingly benefit the rich; and would knock the key source of financing out from under Social Security while opening the door to massive benefit cuts.

As a foundation, keep in mind that the payroll tax comes to 12.4% of wage income up to an inflation-adjusted cap — this year, \$137,700. The tax is evenly split between employees and employers, who must pay their 6.2% share and

also withhold the employee share from their paychecks and pay it over to the Treasury.

Another 2.9% of payroll, uncapped, is also shared between employer and worker to fund part of Medicare.

The centerpiece of the executive order is an interest- and penalty-free deferral of payroll taxes for four months, from Sept. 1 through Dec. 31. This is tantamount to an interest-free loan to workers of up to four months. After that period, the deferred tax will have to be paid.

The most frightening aspect of the payroll tax order is its impact on Social Security itself. The payroll tax is the program's single largest revenue source.

Based on the system's 2019 revenue and income for 2020 as projected by the Social Security trustees, the four-month deferral will deprive the system of nearly \$333 billion in real-time income. Even if the money is ultimately repaid, Social Security will have lost an estimated \$9 billion in interest on that revenue, permanently.

The Social Security trust fund, which currently holds \$2.9 trillion in assets, would be completely depleted within four years.



All: I am not typically political, and have refrained from commenting. But given recent events, and what apparently transpired at the City Council meeting last week, I am constrained to comment.

I am a long-time Manhattan Beach resident, and know many of you personally. So here are my questions and observations.

- 1. Who is going to pay for "reparations?" I am not anxious to write a check for what happened 100 years ago, and for which neither I nor any member of my family had any involvement or responsibility.
- 2. Most of us have a history of persecution, wrongful taking of property and murder of loved ones. I am white, and the descendant of Mormon pioneers who emigrated from Sweden in the early years of this Country. The founding member of my church was murdered in Carthage, Missouri. My ancestor's real properties were pillaged and taken (without eminent domain). My ancestors were forced out of Illinois and Missouri, and compelled to flee for their lives across the plains, on foot, eventually landing in Utah. "Reparations?"
- 3. Almost everyone on the Council has a similar story . . . I need not detail the facts of your histories.
- 4. I wish racism was not a fact of our collective experience, but it is. Why can't we focus on looking forward to address that endemic problem, rather than looking backward, with avarice and greed and hate.
- 5. Finally, I hope the current Council can make reasoned decisions, be strong not weak, even if the "mob" is shrill. If not, I suppose there are elections.

Black Lives Matter is a Marxist revolutionary movement aimed at transforming the United States into a communist dystopia (an imagined state or society in which there is great suffering or injustice). BLM states that it wants to abolish the nuclear family, police, prisons and capitalism. BLM leaders have threatened to "burn down the system" if their demands are not met. Fifty years after the signing of the 1964 Civil Rights Act, more than three in four Americans, including most whites and blacks, agreed that real progress has been made in getting rid of racial discrimination. Scholars have noted that BLM's inability to produce solid empirical evidence of systemic racism explains why its leaders continue to "broaden and deepen" the indictment to include the entire American social and political order. **BLM in its Own Words:**

"We actually do have an ideological frame. Myself and Alicia [Garza] in particular, we're trained organizers. We are trained Marxists. We are super versed on ideological theories." — BLM co-founder <u>Patrisse Cullors</u>, July 22, 2015.

"If this country doesn't give us what we want, then we will burn down this system and replace it. All right? And I could be speaking figuratively. I could be speaking literally. It's a matter of interpretation.... I just want black liberation and black sovereignty, by any means necessary." — BLM activist <u>Hank Newsome</u>, June 25, 2020.

If you think that most people in prison are black, you're right. That's because they are the ones who are committing crimes the most. And they criticize the police!

If you think for one moment, blacks don't have privilege in the US, check this out:

If we had WET (White Entertainment Television), we'd be racists. The TV show "Blackish" is an example If we had a White Pride Day, you would call us racists. A white woman cannot be in the Miss Black American pageant, but any color can be in the Miss America pageant. If we had a college fund that only gave white students scholarships, we would be called racists. There are over 60 openly proclaimed Black Colleges in the US ... Yet if there were 'White colleges", that would be a racist college.

If some of these blacks would get their asses to work instead of blaming white people for everything, maybe they could relate to the fact that hard work pays off.



Dear Mayor Montgomery et al,

By now you have received communication from David Slay, Michael Greenberg, and the DBPA all regarding the need for increased (visible and interactive) MBPD foot patrol in Downtown Manhattan Beach. I echo all of their messages and would like to reiterate how very important immediate action is. The City is being tested by its own residents and the visitors, of all ages and backgrounds. The tide changed back in March with the onset of the pandemic and also the prolonged presence of the blue bio tide. Combine that with the frustration of having to adapt to new routines, restrictions in activities and liberties, once so freely taken for granted, and then all the social unrest in June. Its a trifecta of a storm, one dramatic and potentially violent incident away from tragedy.

The MBPD is amazing. They always have been and they still are. The landscape of policing in the country has been challenged greatly. I am so grateful that we have our own department. They care, the city cares, the residents care and the business community cares. The system seems to be overtaxed by the onset of the pandemic, social unrest and challenges in procedure and the zero bail demands. How can we help our department? How can we empower them? How can we return to the stellar standards that have been stretched so thin across the city.? We have all been stretched so thin since March and challenged in ways we never imagined. We have been incredibly focused on so many COVID-19 related issues. Thank you! There are a few basics that are vital that need immediate attention.

From my vantage point (and hearing from so many who call upon us for change and resources) there are three areas that need immediate attention. Two appear to be quickly attainable, the third a bit more complex.

- Beach standards when did we become a city that allows the <u>open</u> consumption of alcohol on the beach, by all ages, residents and visitors, everyday? Gone seems to be the days of enforcing and citing anyone with an open container, rather beachgoers of all ages are being told to just "clean up after yourself and don't leave any trash". Groups (sometimes very large) drinking at the beach are everywhere everyday. The beaches are packed. Often people drag down furniture, ping pong tables and amplified sound units. Why is this being allowed? Lets keep them safe, clean, and return to the high expectations and standards that we are known for. Masks and COVID safety is important, so are the above standards. When one is ignored, its a signal... a signal that many are taking repeated advantage of. This will help the residents and the businesses in Downtown, and even the North End.
- Visible foot patrol tensions are high, foot traffic activity is higher, and the warning signs and actions by some, are becoming increasingly more aggressive. There are outright verbal assaults, physical altercations, degrading behaviors towards outdoor diners, public urination and defecation, posturing and peacocking by mixed crowds. Again, we are being tested. If we don't increase the MBPD presence on foot, and interacting with the businesses and visitors immediately, disaster is imminent. We can do this. Lets turn the tide before a tragedy strikes. Everyone needs to see the presence of MBPD on the sidewalks and interacting with people and saying hello to the businesses. Please empower and fund MBPD to have a larger and hands-on daily/nightly, in-person, presence.
- Illegal passing and use of drugs its happening under our nose with teens and adults. The street drugs (xanax and percocet) laced with fentanyl are killing adults and kids and sending dozens of teens to the local ERs. This is incredibly worrisome. Just in the past two weeks, <u>dozens</u> have fallen victim. Local teens are being targeted to distribute, others are being targeted to just experiment... its deadly. I realize this is a much much bigger problem and I'm sure there are many people and organizations working on this. Is there any type of messaging that can be sent out from the city via Nixle or other forms warning of street drugs and fentanyl? It might seem obvious to many to not take or experiment, but a very vulnerable young population is falling prey. What can we do immediately with messaging? How can we help?
