COVID-19 Situation Report

NOVEMBER 5, 2020

CURRENT INITIATIVES AND UPDATES

- Latest City Council Actions in Response to COVID-19 At the November 4, 2020, meeting, City Council took an additional measure to address COVID-19 impacts that consisted of directing staff to revise the City's Emergency Order that extends outdoor dining in the public right-of-way from the current date of January 15, 2021, to a future date that aligns with the County's Public Health Order to no sooner than the first Order that allows indoor dining.
- Where L.A. County Stands on the States Tier System As of November 4, 2020, Los Angeles County remains in Tier One, with "widespread" risk and the most restrictions. According to the State's website, L.A. County reflects 12.5 new COVID-19 cases per day (per 100K), with an adjusted case rate for tier assignment equaling 7.5. The County's overall test positivity rate is 4.0%, which meets the threshold for Tier 3; the health equity metric increased from 6.2% to 6.8% which still meets the threshold for Tier 2. When the case rates and positivity rates fall into different tiers, the stricter tier prevails.
- Manhattan Beach Honors Veterans Virtually on November 11th The City thanks our Veterans
 for their service and will hold a virtual celebration in their honor. On Wednesday, November 11 at
 11 AM, the City will commemorate veterans during the 23rd Annual Veterans Day Ceremony
 through a pre-recorded ceremony. The pre-recorded broadcast can be viewed on local
 community cable, Channel 8 (Spectrum), Channel 35 (Frontier), streamed via the City's MBtv
 webcast, and available to view on Facebook and YouTube. For more information, visit

FEDERAL, STATE, AND COUNTY UPDATES

- Mask Considerations for People with Disabilities Federal Emergency Management Agency (FEMA), National Preparedness Division is hosting a webinar on COVID-19 face mask guidance and specific considerations for people with disabilities. The webinar takes place Tuesday, November 10 at 11:30 AM. There are many masks to choose from and Duke University has recently developed a low-cost technique for the measurement of face mask efficacy for filtering droplets emitted during speech. This webinar will describe the set-up of this technique, preliminary results from a range of commonly available face mask types, and the potential of this technology as a demonstration and testing method for the community. Attend the webinar to learn when to wear a face mask, reasons why a person with a disability might not be able to wear a face mask, and the legal rights a person has under the Americans with Disabilities Act (ADA). Advanced registration is required.
- COVID-19 Vaccination Benefits and FAQs- In the United States, there is not yet an authorized or approved vaccine to prevent COVID-19. The federal government has been working since the pandemic started to make one or more COVID-19 vaccines available as soon as possible.
 Although the CDC does not have a role in developing COVID-19 vaccines, the CDC has been working closely with health departments and partners to develop vaccination plans for when a vaccine is available. The CDC has updated its <u>frequently asked questions and answers about</u>

- <u>COVID-19 vaccines</u> and <u>benefits of getting a COVID-19 vaccine</u> page. Visit <u>cdc.gov</u> for <u>vaccine</u> information for you and your family.
- College Students May Still Qualify for a Stimulus Check- The Internal Revenue Service (IRS) urges any eligible self-supporting college student who does not need to file a tax return to register by November 21 to receive an Economic Impact Payment before the end of the year. Since the Non-Filers tool launched in the spring, over 8 million people have used it to register for a payment. Anyone missing the November 21 cutoff, will need to wait until next year and claim a Recovery Rebate Credit when filing their 2020 federal income tax return. - Centering the Vulnerable During Crises and Emergencies The Mental Health and Developmental Disabilities National Training Center (MHDD-NTC), funded by the Administration for Community Living (ACL) is hosting a webinar titled Centering Individuals with Intellectual and Developmental Disabilities During Crises and Emergencies. 2020 has been an active year for crises and emergencies. From the COVID-29 pandemic to the wildfires on the west coast to multiple hurricanes on the east coast, people with disabilities are among the most impacted. - Actions of Recovery During COVID-19 The Governor's Office of Business and Economic
 Development (GO-Biz) announced \$80 million in tax credits that are projected to create 6,535
 new, full-time jobs in California. The funding, from the California Competes Tax Credit, will bring
 more than \$400 million in new investments across the state. As the state recovers from the
 effects of the pandemic, the California Competes Tax Credit helps spur innovation and growth

- Keeping Americas' Workers and Employers Safe During COVID-19 The U.S. Department of Labor, Occupational Safety & Health Administration (OSHA) provides information for workers and employers on the evolving coronavirus pandemic. The latest updates to its website include COVID-19 Guidance on Ventilation in the Workplace Visit and Respiratory Protection Guidance for the Employers of Those Working in Nursing Homes, Assisted Living, and Other Long-Term Care Facilities During the COVID-19 Pandemic. Other guidance documents OSHA highlights include, Returning to Work, Preparing Workplaces for COVID-19, and Workers in Shared Housing which addresses additional considerations for workers who reside in communal living arrangements. - National Service Repays Student Loans During the COVID-19 pandemic, 9.4K AmeriCorps members and volunteers engaged in emergency response, 100K members and volunteers conducted wellness checks, and over 14.5 million members and volunteers collected and distributed assistance to the food insecure. Have you considered service with AmeriCorps? Are you a young adult taking a gap year? Member benefits include student loan deferment, skills and training, living allowance, and limited health benefits. - Projections in Healthcare / Predictive Modeling Los Angeles County <u>Department of Health Services</u> (DHS) released the <u>COVID-19 Projections of Hospital-based Health Care Demand November 4 Update</u>. Key findings include:
 - The number of new patients with COVID-19 requiring hospitalization each day across Los Angeles County appears to be essentially unchanged from last week;
 - o The estimated transmission number ("R") is 1.02 with an uncertainty of 0.95 to 1.07. Last week the estimate was 0.95 with an uncertainty of 0.84 to 1.05. If R is above 1 the number of cases will increase over time;
 - Based on the current estimate for R, it is likely that the number of cases will go up slowly.

 The current number of hospital beds, ICU beds, and ventilators in Los Angeles County are likely adequate over the next four weeks;
 - The model suggests about 1 in 670 Los Angeles County residents are currently infectious to others and that about 1 in 6 have had COVID-19;
 - The model suggests that about 0.15% (uncertainty of 0.09% to 0.22%) of everyone in Los Angeles County is currently infected and infectious to others;
 - o This suggests about 1 in 670 (between 1 in 1100 and 1 in 450) Los Angeles County residents are currently infectious to others. Last week this estimate was 1 in 1000; and
 - The transmission of COVID-19 in Los Angeles County is changing over time. With different patterns in different geographic areas, more detailed geographical analysis is required to identify specific communities needing additional support in identifying cases and limiting spread.
- L.A. County Daily Briefing Statistics on COVID-19 L.A. County Department of Public Health (DPH) confirmed 25 new deaths, three new cases of COVID-19 in Manhattan Beach, and 2,065 new cases of COVID-19 in L.A. County in today's daily report. Today's number of new cases surpasses yesterday's (1,843) and is the highest number of new cases not associated with backlog cases reported since late-August. As COVID-19 spread continues increasing in Los Angeles County, the number of COVID-19 workplace outbreaks has also increased. During the two-week period of September 6 through September 19, there were 23 outbreaks in nonhealthcare and non-residential workplaces, the lowest number of worksite outbreaks since June. During the two-week period from October 4 through October 17, the number of worksite outbreaks increased to 40. DPH is carefully tracking outbreaks at worksites and continues to assist sectors with the required business protocol compliance and safety measures. During an outbreak, health inspectors assess the worksite and provide guidance to control the outbreak. At times, this may include requiring a business to close until required measures are in place to prevent the virus from spreading. Worker protections and safe workplaces are a crucial part of slowing the spread of COVID-19 and protecting the health of our communities. Workers and employers can anonymously report to DPH clusters of COVID-19 cases at worksites as well as violations of Health Officer Orders and Protocols in the workplace. Call the Environmental Health Customer Call Center at (888) 700-9995, Monday to Friday from 8:00 AM to 5:00 PM, excluding holidays. A complaint system to report violations is also available online at publichealth.lacounty.gov. To date, DPH has identified 315,564 positive cases of COVID-19 across all areas of L.A. County, and a total of 7,140 deaths. Testing results are available for more than 3,200,000 individuals, with 9% of all people testing positive. There are currently 825 confirmed
