She has made some half-hearted attempts to blame her incendiary remarks on "Midwestern values" and inexperience. That can't possibly excuse, "This is not the plague. I don't know anyone who has died of COVID. Maybe you do".

I've never held office, and I am known for my bluntness, but even I know one shouldn't be pontificating about death during a pandemic, "We can prevent drunk driving by banning alcohol, we can prevent car fatalities on the highway by closing our highways or preventing cars. The role of society is not to prevent death."

What kind of logic is this? I have traded comments with Ms. Hadley on the app Next Door, so I know that she

uses warped logic to defend her positions.

These remarks were so egregious, it made national news. Even Mayor Montgomery came out with a statement that these were not the values of Manhattan Beach.

If my mayor doesn't know that part of her job is prevent death in some circumstances, then I am very scared right now.

Further, when she has no direct influence over an entity, (the school board and County for example) she organizes rallies, starts posts on Next Door, and writes newspaper articles in order to spur residents into pressuring County officials into allowing us to open ahead of schedule. She may claim that she acts as an individual, but that's not the perception. Being in office gives her "personal opinions" undo weight. What will happen when she's the mayor?

Any protestations on her part that she's learning the ropes are just lip service, because she continues to create divisiveness and cater to the fringe; even as the pandemic is on the rise again, the soon-to-be-mayor is holding rallies (as of Nov 18) to open our schools immediately in defiance of Los Angeles County and the State of California.

This push seems more political than real, since the schools are in the process of opening. Why be so controversial?

During the September 1, 2020 city council meeting, Suzanne Hadley said, "All lives matter, not just Covid lives". She may have said it jokingly, but I think this statement says a lot. Using a racist retort and diminishing a pandemic at the same time takes real skill.

Absolutely there are two sides to any story, who doesn't know that... I didn't say that discussing an issue before making s decision is undignified, I said, "It would be undignified... to spend more than five minutes on this ridiculous agenda item" -- of course assuming there would be discussion. With all due respect, there are always at least two sides to any story. You should know that. To say that discussing an issue before making a reasoned decision is undignified, I'm curious how you make decisions on the parks and rec commission? I assumed when we appointed you that you would thoughtfully consider decisions without just rubber stamping or following a tradition.

Just so you know the kinds of emails we are receiving against making Suzanne mayor, the following is just one of many examples. Notice that the person is not concerned with her political background, but rather her statements and actions. Other emails have pointed out other statements she has made, such as when she said on national news to a reporter that she "didn't know anyone who died from covid, do you?"

This is just a sampling:

"I am a resident of Manhattan Beach. I'm calling on you not to appoint Suzanne Hadley as our next mayor. We're facing unprecedented challenges amidst a global pandemic and Hadley has repeatedly proven that she does not have the necessary qualities to lead our city through this crisis.

What Hadley dismisses as "gaffes" and "unvarnished positions" in fact reflect a pattern of behavior that will continue if she is appointed mayor and will reflect abysmally on Manhattan Beach. Her comments about Covid this spring were so despicable that Mayor Montgomery felt the need to clarify that "the comment Mayor Pro Tem Suzanne Hadley made on MSNBC today is NOT a reflection of how I feel as Mayor of Manhattan Beach, nor does it reflect how the entire City Council feels on this subject." It is abundantly clear that those comments were not isolated. She has continued to make equally dismissive comments throughout the pandemic, both in City Council meetings and online, including in saying "all lives matter—not just Covid lives," a disgusting and baffling way to address a pandemic that has become the third leading cause of death in the United States in the year since it emerged. I am sure you too remember that Hadley fought strenuously against the mask mandate and fought to carve out nonsense exceptions, e.g. spouses—as though spouses walking together would somehow be immune from encountering another person and catching the virus.

Moreover, she has abused her platform as a City Councilmember—School Board member Karen Komatinsky even said "Council member Hadley has continued to use her City leadership role in a less than collaborative spirit on behalf of the School District through her social media presence and commentary."

In addition to her reckless push to reopen schools against the best advice of public health experts, Hadley has likewise not displayed leadership by modeling the behavior public health experts are requesting of us. Over the summer, she publicly posted about her vacation, in which she flew to the other side of the country and attended a large family gathering that brought together multiple households, violating just about every recommendation our public health experts have offered. Just a few weeks ago, she publicly shared that she is planning to fly to Florida, an epicenter of the pandemic, this winter to go to Disney World, again apparently bringing together multiple households. In a position that Hadley herself has admitted is largely symbolic, why would we select someone who can't even model good behavior for the community themselves?

Hadley's record on race is also horrendous, and at a moment when we're in the national news often for the horrors of Bruce's Beach, do we really want to double down on our racist past by appointing a figurehead who retweeted a crude racist joke about Black people and Kool-Aid? Not only did Hadley have the poor judgement to share the tweet in the first place, she also said nothing and left it up for months after multiple residents publicly called attention to it in a public forum she was attending. In fact, she only seems to have taken down her Twitter account now that residents are calling for her not to be appointed mayor—but hiding her racism doesn't change it, and she clearly only removed it out of self-interest, not genuine remorse.

In her pitch to retain her rotation as mayor, Hadley wrote in the MB Patch that she should be appointed mayor because of her "Midwest values." I know there's a lot of weight placed on Midwestern values in national politics, but this is City Council. Manhattan Beach is not the Midwest. I want a mayor who shares my pride in Californian values, like justice, equality, empathy—none of which seem to be included in what Hadley considers to be her Midwestern values given her behavior and rhetoric. All too often, California falls short of enacting those values, and people like Suzanne Hadley are no small part of the reason why. We cannot afford to have Hadley as our representative to the world. We can and we must do better.

Please do the right thing for our city and do not vote to appoint Suzanne Hadley as our next mayor. Thank you.

Please explain. We were being safe. We were outdoors. We had face masks. This sent me a bit over the edge with just how inane it is.







Last year, when she ran for one of the two open seats on the Manhattan Beach City Council, Suzanne Hadley received the most votes by far. A distant second was Councilmember Hildy Stern who was also elected.

In her current role as Mayor Pro Tem, Suzanne is scheduled to assume the role of Mayor at the December 1st Council meeting under Manhattan Beach's traditional system of rotating the mayor's position between the five sitting councilmembers for 9-month terms. At that same meeting, Hildy Stern would presumably take the position of Mayor Pro Tem.

It is my understanding that you will be voting on the proposed restaurant closure tomorrow morning. I implore you to reconsider. I am a front line Physician and part of a Covid intubation team (which has been disbanded due to lack of cases).

Restaurants in Manhattan Beach and elsewhere are struggling. They have invested significant capital installing plexiglass shields, purchasing PPE for employees, purchasing heaters, etc. They are willing to decrease capacity by 50% but they cannot survive a total closure of outdoor dining. To whom it may concern:

Some of you may recognize my name/email. I am one of the most PRO BUSINESS and PRO RESTAURANT residents of Manhattan Beach that you will find. Prior this, I have frequently sent letters ONLY in support of extended restaurant hours, full liquor licenses, et.

The idea to fully close Manhattan Avenue from Manhattan Beach Blvd to 12th Street is a HUGE concern to me and seems completely absurd. When I first read about it I was in complete shock. Manhattan Avenue is a main thoroughfare in our city and we don't have many! Have any of the council members that voted for this actually done any investigation of what the traffic and congestion in this area already is? The traffic and many times gridlock in this area is already unbearable, especially in the summer time. Highland and Valley/Ardmore are already congested too and it will only make things worse. I PLEAD with the city to reconsider this as I feel it is an AWFUL decision for the overall traffic in our city and for ALL the residents!

I personally live RIGHT on CENTER PLACE. I am just west behind Slays. So I can attest to the HORRIFIC congestion on this narrow alley. Day and night there are trash trucks that come that serve all the restaurants. There are also constant deliveries done on this alley to all the surrounding restaurants. And with all the "pick-up" orders by patrons of the restaurants due to Covid, there are a slew of people that just park their cars and leave them unattended while they walk to get their pick up orders. Often I have to wait 10 or 15 minutes or more when my garage is blocked. If only the west/bottom of the ally is accessible – trash trucks/delivery trucks and other vehicles will literally get trapped on Center Place!

I VERY frequently cannot access or get into my garage off of Center Place – I live at 124 Center Place. When the top/East side of the ally/Center Place is blocked, I have to go around and enter from the west side. When the bottom (where Center meets Ocean) is blocked I have to enter from Manhattan Ave. As a side note, the city frequently puts up the temporary road blocks at the top of Center Place & Manhattan Ave and then on the corner of Ocean and 12th Street when they are trying to alleviate traffic on MBB. This COMPLETELY prevents me from accessing my OWN GARAGE! And when I get out of my car to move the road block I have been threatened with tickets and a few times even arrest! It's completely insane! I am a Manhattan Beach resident/property owner just trying to access my own garage!

***I want to call attention to the fact that I have NEVER once complained about the already terrible situation on the alley/Center place. I realize I live downtown and right by commercial property. But this closure of Manhattan Ave is just TOO much!

I have ZERO issue with closing both Pier Lots and turning them over for use by the restaurants. If this does happen, I think the current outdoor dining for the Strand House that is on Ocean Ave should be removed. This particular outdoor dining had created TERRIBLE GRIDLOCK! And I have never once complained about it.

And if for some reason you do move forward with the full closure of Manhattan Ave, the StrandHouse outdoor dining on Ocean MUST be removed!!! If not, there will be a bottleneck at the bottom of Center Place and Ocean. Ocean Avenue must be open in both directions to allow residents access to their own properties and to alleviate at least some of the congestion caused by the Manhattan Ave closure.

And saying this is a temporary change due to the shutdowns does not alleviate my concerns. Who knows how long this all will last. Closing down Manhattan Ave is a bad decision for both the short and long term.

SIDENOTE: The new multi-direction crosswalks also are adding to the overall traffic back-up. Many times there are none or almost no pedestrians crossing while traffic in both directions is completely stopped. Then when the lights are green for cars to go, pedestrians that have just arrived walk anyway (when the crosswalk is flashing red) and stop cars from proceeding. Perhaps these new crosswalks will be beneficial during the summer months when pedestrian crossing is more excessive. We shall see. In my opinion the big painted circle and lines really take away from our small town charm. Manhattan Beach is feeling more like Santa Monica every day. This is very sad to me.
