LA County is struggling, in particular, due to its recent stay-at-home order. We ask that you consider all small businesses in this category and recognize they are all currently struggling financially as a result of the ongoing crisis.

Moreover, this move by the city indicates an understanding that these products are vital revenue sources for these stores, and they should not be forced off of shelves until the COVID-19 pandemic is no longer a public health threat that continues to destroy small businesses.

CFCA appreciates the opportunity to provide comment on this proposal.

We sincerely appreciate the consideration by the council to delay the implementation of its flavored tobacco retail ban. We strongly support any relief that you are able to provide to these small businesses during this incredibly arduous time. CFCA does however, request that the city go one step further than granting extensions to those businesses that have submitted applications. Requiring a hardship application is regressive and will ensure only English-speaking, corporate-sided business with proper legal support will be able to successfully apply.

CFCA requests the city enact a blanket hardship exemption based on the current status of the pandemic and its lack of foreseeable resolution. LA County is struggling, in particular, due to its recent stay-athome order. We ask that you consider all small businesses in this category and recognize they are all currently struggling financially as a result of the ongoing crisis.

Moreover, this move by the city indicates an understanding that these products are vital revenue sources for these stores, and they should not be forced off of shelves until the COVID-19 pandemic is no longer a public health threat that continues to destroy small businesses.

"What Hadley dismisses as "gaffes" and "unvarnished positions" in fact reflect a pattern of behavior that will continue if she is appointed mayor and will reflect abysmally on Manhattan Beach. Her comments about Covid this spring were so despicable that Mayor Montgomery felt the need to clarify that "the comment Mayor Pro Tem Suzanne Hadley made on MSNBC today is NOT a reflection of how I feel as Mayor of Manhattan Beach, nor does it reflect how the entire City Council feels on this subject." It is abundantly clear that those comments were not isolated. She has continued to make equally dismissive comments throughout the pandemic, both in City Council meetings and online, including in saying "all lives matter—not just Covid lives," a

disgusting and baffling way to address a pandemic that has become the third leading cause of death in the United States in the year since it emerged. I am sure you too remember that Hadley fought strenuously against the mask mandate and fought to carve out nonsense exceptions, e.g. spouses—as though spouses walking together would somehow be immune from encountering another person and catching the virus.

Moreover, she has abused her platform as a City Councilmember—School Board member Karen Komatinsky even said "Council member Hadley has continued to use her City leadership role in a less than collaborative spirit on behalf of the School District through her social media presence and commentary." Over the summer, she publicly posted about her vacation, in which she flew to the other side of the country and attended a large family gathering that brought together multiple households, violating just about every recommendation our public health experts have offered. Just a few weeks ago, she publicly shared that she is planning to fly to Florida, an epicenter of the pandemic, this winter to go to Disney World, again apparently bringing together multiple households. In a position that Hadley herself has admitted is largely symbolic, why would we select someone who can't even model good behavior for the community themselves?

Hadley's record on race is also horrendous, and at a moment when we're in the national news often for the horrors of Bruce's Beach, do we really want to double down on our racist past by appointing a figurehead who retweeted a crude racist joke about Black people and Kool-Aid? Not only did Hadley have the poor judgement to share the tweet in the first place, she also said nothing and left it up for months after multiple residents publicly called attention to it in a public forum she was attending. In fact, she only seems to have taken down her Twitter account now that residents are calling for her not to be appointed mayor—but hiding her racism doesn't change it, and she clearly only removed it out of self-interest, not genuine remorse.

In her pitch to retain her rotation as mayor, Hadley wrote in the MB Patch that she should be appointed mayor because of her "Midwest values." I know there's a lot of weight placed on Midwestern values in national politics, but this is City Council. Manhattan Beach is not the Midwest. I want a mayor who shares my pride in Californian values, like justice, equality, empathy—none of which seem to be included in what Hadley considers to be her Midwestern values given her behavior and rhetoric. All too often, California falls short of enacting those values, and people like Suzanne Hadley are no small part of the reason why. We cannot afford to have Hadley as our representative to the world. We can and we must do better."

Dear City Council Members,

Regarding the upcoming discussion regarding the City's next Mayor, please observe how the discussion alone is causing further division and angst in our community. This is what Mrs. Hadley brings. This is her hallmark. It is also the reason that confirming her as Mayor at this time is the wrong choice.

To those who would cite tradition as a reason for making Ms. Hadley mayor, or those who claim it is her "turn," I urge you not to abdicate your responsibility to the residents of this city by using such thin and superficial reasoning. To continue a status quo that has a high probability of inflicting greater strife on our city is, I would argue, violative of your duty to all residents and to the greater good of the City. No city council member has a "right" to become mayor, and to the extent that is an element of the discussion at all, it serves only to highlight the skewed perspective that some are using to assess this situation. Your primary, and I would argue sole, fiduciary duty is to the residents of this city, not to the expectation one of your number may have. Regarding adherence to tradition as a precedence in this time, open your eyes. None of us are living in that world any more. Clinging to tradition as a justification for this choice, consequences be damned, is shortsighted and belies the intelligence I know you all have.

Mr Napolitano, I read the news article where you expressed your views on this matter. To you in particular I would say that you are in error when you claim that those who do not believe Mrs. Hadley should be mayor are the same ones calling for her to be removed from the Council (and, by implication, that therefore those voices matter less or can be disregarded). While I am sure there is some overlap, you work an injustice by concluding there is a near-complete alignment between those populations. You are making an assumption based on anecdotal evidence. Even if that assumption is correct, the implication is that therefore those residents' concerns are of lesser value in your estimation. I find that logic to be deeply troubling, and painfully dismissive. This choice matters, and as someone who voted for you, I expected more from you. I expected you to

take this seriously, respect the pain that Ms. Hadley's recent positions and statements have caused, and do right by your City whose residents deserve peace, thoughtful leadership, and elevated ethics. Mrs. Hadley has repeatedly shown herself to be incapable of these most basic traits of good leadership. And while I appreciate that you reached out to Mrs. Hadley and informed her of the error of her ways, the fact that you had to do so at all proves my point. She does not, on her own, display maturity of thought, an ability to intelligently assess the correct path forward in a non-partisan and empathetic way, or even a capability for the most basic skills one would need as Mayor: a capacity for meaningful self reflection and ability to think beyond one's own needs and opinions to consider something larger than one's self. I respect that as a colleague you attempted to reach out to her and save her from herself, but as a representative of the residents of Manhattan Beach, it is your job to put our needs over the hope you may have that Mrs. Hadley is capable of evolving into a more balanced leader some day.

The simple fact is - by her own admission regarding the error she made in wading into the issue of opening schools, a matter wherein she held no authority and, thanks to her incendiary tactics, only succeeded in making the situation worse for our Board of Trustees - right now, in this very moment in time, Mrs. Hadley has shown both through her hurtful words and harmful actions specifically relating to Covid-19, that she is not qualified to represent our city as Mayor at this time.
