# **COVID-19 Situation Report**

**DECEMBER 10, 2020** 

### CURRENT INITIATIVES AND UPDATES

- Playgrounds are Now Open! Play Smart in the Parks, Stay Six Feet Apart Aligning with State Outdoor Playground Guidelines, the Los Angeles County Department of Public Health (DPH) has allowed playgrounds in the County to open so that all children have safe access to outdoor recreational opportunities. Remember to bring <a href="handsanitizer">handsanitizer</a>, wash hands before and after play, stay six feet apart from playmates, and have fun!
- Happy Hanukkah, Celebrate Safely As you enjoy your holiday celebrations and family gatherings, be sure to take steps to protect yourself and the ones you love from getting or spreading COVID-19. The City wishes the community good health, prosperity, and a peaceful and joy-filled holiday season. Hanukkah Sameach.
- Your Actions Saves Lives California is experiencing the fastest increase in cases we have seen yet more rapid than what we experienced at the outset of the pandemic and this summer. This past week and a half, cases in L.A. County increased from an average of about 4,900 new cases each day the last week in November, to an average of more than 9,000 daily cases. Protect yourself, family, friends, and community by following these prevention measures:
  - Staying home except for essential needs/activities and following public health guidelines when visiting open businesses.
  - o Following the limited <u>Stay at Home Order</u> requires all non-essential work and activities to stop between 10:00 PM and 5:00 AM. The Order remains in effect until 5:00 AM December 21.
  - Staying close to home, <u>avoiding non-essential travel</u>, and practicing <u>self-quarantine</u> for 14 days after arrival if you leave the state.
  - Keeping <u>gatherings</u> small, short, and outdoors and limiting them to those who live in your household.
  - o Wearing a cloth face covering when out in public.
  - o Washing hands with soap and water for a minimum of 20 seconds.
  - o Avoiding touching eyes, nose, or mouth with unwashed hands.
  - o Covering a cough or sneeze with your sleeve or disposable tissue. Wash your hands afterward.
  - o Avoiding close contact with people who are sick.
  - o <u>Staying away from work, school, or other people</u> if you become sick with respiratory symptoms like fever and cough.
  - o Answer the call if a contact tracer from the <u>CA COVID Team</u> or your local health department tries to connect. Contact tracers will connect you to free, confidential testing, and other resources if needed.
  - o Follow all <u>Guidance from the Department of Public Health</u>.

The State updated tier assignments on December 8, 2020. Los Angeles County remains in Tier One (Purple), with "widespread" risk, the most restrictions, and many non-essential indoor business operations are closed. L.A. County reflects 41.8 new COVID-19 cases per day (per 100K); the adjusted case rate for tier assignment is 26.9. The County's overall test positivity rate equals 8.7%; the health equity quartile positivity rate is 13.9%. Effective December 6, 2020, an updated L.A. County Department of Public Health (DPH) Revised Temporary Targeted Safer at Home Health Officer Order for Control of COVID-19: Tier 1 Substantial Surge Updated Response went into effect. DPH Order aligns with California's Department of Public Health (CDPH) Regional Stay at Home Order and Supplement to the Order. CDPH regularly evaluates the adult ICU bed capacity for each Region, and data can be found at covid19.ca.gov. As indicated in the Order, when capacity is less than 15%, the Order's terms will apply. ## FEDERAL, STATE, AND COUNTY UPDATES

• L.A. County's First COVID-19 Death in a Child - Los Angeles County has tragically confirmed the first COVID-19 death in an L.A. County child under 18 years old. The child was hospitalized for Multisystem Inflammatory Syndrome in Children (MIS-C) and had severe underlying health conditions. The child that passed away is also the first MIS-C associated death in L.A. County. To date, Public Health has confirmed 45 children with MIS-C in L.A. County. The 45 children required hospitalization, and 50% were treated in the ICU. Most children exposed to or infected with SARS-CoV-2, the virus that causes COVID-19, develop only a mild form of the illness. However, others develop MIS-C, a severe, sometimes fatal, inflammation of organs and tissues, including the heart, lungs, kidneys, brain, skin, and eyes or gastrointestinal organs resulting in lifelong health impacts. While not all children will have every symptom of MIS-C, the symptoms include fever, abdominal pain, vomiting, diarrhea, neck pain, rash, bloodshot eyes, and or feeling extra tired. Parents should contact their child's doctor, nurse, or clinic right away if their child shows

- Approval of First Consumer COVID-19 Home Kit The U.S. Food and Drug Administration
  (FDA) authorized LabCorp's Pixel COVID-19 Test Home Collection Kit for use by adults 18 and
  older without a prescription. The kit is the first COVID-19 direct-to-consumer (non-prescription)
  test system. It allows an individual to self-collect a nasal swab sample at home and then send
  that sample for testing to LabCorp. Test results are sent to the user by a phone call from a health
  care provider. Negative test results are delivered via email or an online portal. Visit <u>fda.gov</u> for

- DMV Updates for 70+ and Want-to-Be Drivers The California Department of Motor Vehicles (DMV) now offers Californians, 70 and older, to renew noncommercial drivers' licenses online. Licenses that expire beginning March 1, 2020, and throughout the COVID-19 emergency are eligible, including REAL ID renewals. Most drivers 69 and younger can also renew online even if their renewal notice states they must come to an office. The DMV encourages customers to avoid an office visit when taking care of DMV needs. The DMV also announced that beginning December 14, behind-the-wheel driving tests are temporarily suspended for at least two weeks. The DMV is taking this step for customers' and employees' health and safety during the current statewide surge in COVID-19 cases. - Projections in Healthcare / Predictive Modeling Los Angeles County <u>Department of Health Services</u> (DHS) released the <u>COVID-19 Projections of Hospital-based Health Care Demand</u>

<u>December 9 Update</u>. DHS has not yet seen significant influenza activity in Los Angeles County. Influenza-associated illnesses typically lead to a demand for hospital beds similar to the current need for patients with COVID-19. DHS reports that estimates will be updated when influenza activity is detected. Key findings in the report include:

- The number of new patients with COVID-19 requiring hospitalization each day across Los Angeles County has continued to increase over the last week;
- The estimated transmission number ("R") is 1.14 with an uncertainty of 1.09 to 1.21. This is unchanged from last week when the estimate was 1.14 with an uncertainty of 1.07 to 1.22. When R is above 1, cases will increase over time;
- o Based on the current estimate for R, and assuming no change in transmission behavior, the number of cases will continue to go up, with possible shortages in the number of hospital beds and most likely in the number of ICU beds over the next four weeks. The number of ventilators in Los Angeles County appears adequate over the next four weeks;
- o The model suggests about 1 in 140 Los Angeles County residents are currently infectious to others and that about 1 in 5 have had COVID-19;
- The model suggests that about 0.71% (uncertainty of 0.45% to 1.03%) of everyone in Los Angeles County is currently infected and infectious to others;
- o This suggests about 1 in 140 (between 1 in 220 and 1 in 100) Los Angeles County residents are currently infectious to others. Last week this estimate was 1 in 200; and
- The transmission of COVID-19 in Los Angeles County is changing over time. With different patterns in different geographic areas, more detailed geographical analysis is required to identify specific communities needing additional support in identifying cases and limiting spread.
- L.A. County Daily Briefing Statistics on COVID-19 DPH confirmed 74 new deaths, including the first COVID-19 death of a child in L.A. County, six new cases of COVID-19 in Manhattan Beach, and 12,819 new cases in Today's Daily Report. Today's new cases surpassed the previous high on December 6 when the County experienced 10,528 new COVID-19 cases. There are 3,433 people with COVID-19 currently hospitalized, and 23% of these people are in the ICU. In just the past two days, the number of patients hospitalized with COVID-19 has increased by more than 300.
