COVID-19 Situation Report DECEMBER 29, 2020

CURRENT INITIATIVES AND UPDATES

- Ring in the New Year Safely at a Distance Due to the surge in cases, hospitalizations, and deaths, the safest way to celebrate the New Year Holiday is to celebrate at home with people who live with you. As the holiday nears, you may be tempted to make plans to gather with other family members, friends, and neighbors. Please celebrate safely with only those in your household. All public and private gatherings with people from more than one household are not permitted per the L.A. County Health Officer Order. Gatherings with family and friends who do not live with you can increase the chances of getting or spreading COVID-19. The California Department of Aging offers the Feeling Good & Staying Connected Activity Guide with tips, tricks, and tools to meaningfully connect with family and friends.
- Where L.A. County Stands on the States Tier System The State updated tier assignments today under its <u>Blueprint for a Safer Economy</u>. According to the State's website, L.A. County reflects 132.7 new COVID-19 cases per day (per 100K), an increase from 106.0, with an adjusted case rate for tier assignment equaling 66.4. The County's overall test positivity rate increased from 14.3% to 16.5%. The <u>health equity metric</u> also increased from 20.3% to 23.4%.
- Updated Safer At Home Health Order L.A. County Department of Public Health (DPH) issued a Revised Temporary Targeted Safer at Home Health Officer Order for Control of COVID-19:
 Tier One Substantial Surge Updated Response.
 The Revised Order became effective on December 27, 2020 and remain in effect for as long as the State Public Health Officer's Regional Stay At Home remains in effect in the Southern California Region. The State's Order is based on ICU capacity and will remain in place for at least three weeks. Today, Southern California's ICU capacity is 0.0%.
- Drive Safe and Sober Everyone is safest at home. Due to COVID-19, the State of California asks residents to avoid gatherings for the holidays to mitigate the virus's spread. However, if you are out, the City reminds the public about the importance of being safe and sober when driving. The Manhattan Beach Police Department is dedicated to keeping the public safe and urges people to stay at home or use a designated sober driver if you plan to drink. Make the right choice by not driving impaired so everyone can have a safe holiday. Impaired driving is not just from alcohol. Prescribed medications, over-the-counter drugs, and marijuana can also impair driving, especially in combination with alcohol. Stay safe and drive sober!
- Travel into L.A. County Requires a 10 Day Quarantine Because of the likelihood of exposure to COVID-19 while traveling outside of L.A. County, for everyone that traveled or are planning to travel back into L.A. County, <u>DPH requires that you quarantine for ten days</u>. The best way to safely quarantine is not to leave your home or allow any visitors into your home and find others who can help you buy groceries and other necessities. The virus can take up to 14 days to incubate, and for many people, the virus causes no illness or symptoms. If you go back to work,

- go shopping or go to any gatherings at any point over the next ten days, you could easily pass on the virus to others.
- CIF COVID-19 Tier Map for High School Sports California Interscholastic Federation (CIF) recently released an education-based athletics COVID-19 Tier Map providing high school sports guidelines based on Tier Assignment throughout the State. While Manhattan Beach is in Tier One (Purple), the sports allowed in this tier include cross country, golf, skiing/snowboarding, swimming & diving, tennis, and track & field, depending upon the season. In the Southern Section, the CIF Season One Sports, which runs January through April, will include traditional competitive cheer, cross country, field hockey, football, gymnastics, skiing/snowboarding, girls volleyball, and water polo. The CIF Season Two Sports, which runs March through June, will include badminton, baseball, basketball, competitive sport cheer, golf, lacrosse, soccer, softball, swimming & diving, tennis, track & field, boys volleyball, and wrestling. FEDERAL, STATE, AND COUNTY UPDATES

- Expect Your Economic Impact Payment Today, the Treasury Department and the Internal Revenue Service will begin delivering a second round of Economic Impact Payments as part of implementing the Coronavirus Response and Relief Supplemental Appropriations Act of 2021. This second round of payments will provide critical economic support to those who have been adversely impacted by the COVID-19 pandemic through no fault of their own. The initial direct deposit payments may begin arriving as early as tonight for some and will continue next week. Paper checks will start to be mailed tomorrow. - Actions in Response to COVID-19 Governor Newsom announced a partnership with CVS and Walgreens to provide Pfizer vaccines to residents and staff in long-term care facilities at no cost to the State and local government. California opted to participate in the federal COVID-19 Pharmacy Partnership for Long Term Care Program. CVS and Walgreens will administer the Pfizer vaccine to residents and staff in long-term care in over 850 facilities. The vaccines will be given by pharmacists, pharmacy technicians, and nurses under a recent waiver by the Board of Pharmacy that requires appropriate supervision under California law and specialized training. - State Crisis Care Continuum With the current surge in the pandemic, many hospitals are stretched to capacity. To address the swell, the California Department of Public Health (CDPH) released an All Facilities Letter (AFL) on implementing the Crisis Care Continuum Guidelines issued in June 2020. The guidelines support facilities that adapt their operations and space, including staff and other resources, to handle the surge as best as possible. All facilities must be prepared for crisis care, during which times medical professionals may have to make hard choices about allocating treatments. - Phase 3 Trial of Novavax Vaccine Open to Volunteers The National Institutes of Health (NIH) announced the Phase 3 trial of another investigational COVID-19 vaccine has begun enrolling 30,000 adult volunteers. The National Institute of Allergy and Infectious Diseases (NIAID), part of the NIH, and the Biomedical Advanced Research and Development Authority (BARDA), part of the U.S. Department of Health and Human Services, are funding the trial. Novavax of Gaithersburg, Maryland, is leading the trial as the regulatory sponsor. - No Evidence of Virus Variant Causing Increased Severity An L.A. County Public Health Alert key message states that the variant strain reported in the United Kingdom shows no evidence that this variant is associated with increased disease severity or that the COVID-19 vaccines will offer less protection against this variant. The Center for Disease Control and Prevention (CDC) monitors the situation closely and will communicate new information as it becomes available. - L.A. County Daily Briefing Statistics on COVID-19 DPH confirmed 227 new deaths, nine new cases of COVID-19 in Manhattan Beach, and 12,979 new cases in Today's Daily Report. The high number of new deaths reflects a significant number from the backlog associated with the Spectrum outage and holiday reporting delays. DPH anticipates additional deaths due to the backlog of death reports over the next two to three days. Today, is the highest number of hospitalizations reported in a day, with 7,181 people with COVID-19 currently hospitalized. This is an increase of 267 people reported yesterday. Of the 7,181 people with COVID-19 currently hospitalized, 20% of these patients are in the ICU. The number of daily hospitalizations is nearly a 1,000% increase from two months ago, when on October 29, L.A. County experienced 750 COVID-19 hospitalizations. For comparison, today's number is more than three times the peak of the July surge, when L.A. County experienced 2,232 people hospitalized with COVID-19. Testing results are available for approximately 4,650,000 individuals, with 15% of all people testing positive. To view DPH's COVID-19 Daily Data, visit lacounty.gov.
