COVID-19 Situation Report

JANUARY 5, 2021

CURRENT INITIATIVES AND UPDATES

- Outdoor Public Seating Areas Closed As the number of new COVID-19 cases continues to rise in Manhattan Beach and across the County of Los Angeles, the City closed outdoor seating spaces on public property on Sunday, January 3 at 10:00 PM. While the public seating spaces are closed, please continue to support our local businesses offering pick-up, curbside, takeout, and delivery services. When out, be sure to wear a face covering at all times, keep your distance from others, wash your hands often, and stay home if you are sick. - Manhattan Beach Fire Department Vaccinations The Manhattan Beach firefighters and
 paramedics, have received the Moderna COVID-19 vaccine's first dose. The Fire Department has
 been fortunate to have had minimal COVID-19 impact and has retained staffing levels providing
 quality service to the community they always have, albeit, call loads have increased. Thankfully
 with the vaccinations, the Fire Department will be in the best position to protect, serve, and
 respond to emergencies and keep our community safe.
- Manhattan Beach Emergency Transport The COVID-19 pandemic has increased emergency medical calls for service, expanding wait times in emergency rooms/areas, and ICU's at capacity. Fire Chief Knabe reassures the community that plans are in place to address these issues at the City, County, and State levels. Manhattan Beach can rest assured that the City is doing everything possible, both in preparation and response, to minimize the pandemic's impact. Several news media has reported that fire departments and ambulances will limit patient transportation or response. This is not currently applicable in Manhattan Beach. The Manhattan Beach community will still receive the excellent care and service they have always received. The only change in transportation is in certain situations where death is determined in the field. Request for emergency medical services will be responded to with available resources; patients will be treated and transported appropriately. The City will continue to coordinate with other agencies and has plans to provide the best response possible to the pandemic.
- California Small Business COVID-19 Relief Grant Applications are open for the California Small Business COVID-19 Relief Grant Program. The grant is administered by the California Office of the Small Business Advocate (CalOSBA) at the Governor's Office of Business and Economic Development for small businesses that have been impacted by COVID and the health and safety restrictions. The Grant Program provides micro-grants ranging from \$5,000 to \$25,000 to eligible small businesses and nonprofits impacted by COVID-19. The due date for the first round of applications has been extended to January 13. Details for the second round will be announced near term. Visit careliefgrant.com for more information.
- Where L.A. County Stands on the States Tier System According to the State's website, L.A.
 County reflects 107.9 new COVID-19 cases per day (per 100K), with an adjusted case rate for tier assignment equaling 65.8. The County's overall test positivity rate is 17.8%. The health equity metric is 25.0%. The Southern California Region ICU availability remains at 0.0%; the ICU

- projection does not meet the criteria to exit the <u>Regional Stay at Home Order</u>. The Order will remain in effect as long as ICU capacity is below the threshold of 15%.
- What Can You Do To Help the County Reach a Lower Tier Our Community, Our Health, Our Responsibility. Everyone can continue to help L.A. County reach a lower tier in the State's Tier System:
 - Stay home except for essential services;
 - o Wear a face cover in public;
 - Wash your hands regularly;
 - o Keep at least six feet of physical distance when in public; and
 - o Limit mixing with people you don't live with.
- Vaccine Distribution The distribution of COVID-19 vaccines is currently being managed by Los Angeles County and healthcare providers, however, the City is currently in communication with the County to ensure vaccine distribution can be executed toward the general public in the future. At this point, the vaccine will be offered to different groups of people at different times (or phases). - barriers to equitable vaccine implementation and decision-making in the State. The next meeting occurs Wednesday, January 6, from 3:00 PM to 6:00 PM; the discussion will include Phase IB and IC rollout and vaccine administration operationalization. - Updated Public Health Guidelines Several guidelines have been updated by the L.A. County Department of Public Health (DPH). The <u>Protocol for Social Distancina</u> now includes definitions and multiple updates to incorporate universal physical distancing, face covering use, and other infection control protocols for businesses. The Protocols for Office Worksites include an updated requirement related to break rooms for employees and consists of an email option for employers reporting clusters of 3 or more cases of COVID-19 to DPH. The Protocols for Shopping Center Operators includes an update to clarify which indoor and outdoor seating is permitted at shopping centers. In the Protocol for COVID-19 Exposure Management Plan in Early Care and Education (ECC) Sites, the Reopening Protocols for K-12 Schools, and the Protocol for COVID-19 Exposure Management in Institutes of Higher Education, the updates include DPH reporting requirements, the required guarantine period for individuals who have been in close contact with a person diagnosed with COVID-19 has been shortened, and hyperlinks for isolation and guarantine. DPH also updated the definition for a close contact to be an individual who was within 6 feet of an infected person for a total of 15 minutes or more over a 24-hour period. Be sure to review the updated protocols at <u>publichealth.lacounty.gov</u> to ensure compliance and to mitigate the spread of COVID-19.
- Mandatory Travel Directive and Restrictions The County Health Officer issued a Mandatory Directive on Travel to furtherance the State's Travel Advisory. The Directive provides that both Californians stay home or in their Region and avoid non-essential travel and persons who arrive into any California region, self-quarantine for ten days after arrival. For the Directive, "quarantine" means staying at home or another place of temporary shelter and away from contact with others, including those in one's household (unless they are also under quarantine), for ten days. Quarantine may end after Day 10 if the traveler(s) never had any symptoms, and they must continue to monitor themselves for COVID-19 symptoms for 14 days after arrival. - Addressing Mental Health of Young Adults during COVID-19 The pandemic has resulted in changes in plans and missed significant life events resulting in young adults facing isolation, anxiety, and depression. FEMA, National Preparedness Division, will host a webinar supporting young adults' mental health (ages 18-24) during the pandemic on Tuesday, January 12, from 9:00 AM to 10:00 AM. A guest speaker from ComuniLife will discuss the impacts of quarantine on the mental health of young adults. Learn symptoms, warning signs, and how to help young adults manage these challenging times. Advanced registration is required.
- L.A. County Daily Briefing Statistics on COVID-19 DPH confirmed 224 new deaths, six new cases of COVID-19 in Manhattan Beach, and 13,512 new cases in Today's Daily Report. L.A. County had experienced more than 1,000 new COVID-19 deaths in less than a week when on December 30, DPH reported 10,056 deaths. There are 7,898 people with COVID-19 currently hospitalized, and 21% of these people are in the ICU. This is a new high and an increase of more than 200 patients reported yesterday. Healthcare workers and hospitals continue to be taxed and overwhelmed by COVID-19 patients. The pandemic's devastating impact is disrupting emergency medical care due to the sheer volume of COVID-19 patients and staffing limitations. These challenges will get worse if we do not slow the COVID-19 spread. Testing results are available for approximately 4,826,000 individuals, with 16% of all people testing positive.
