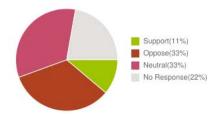

#### **Overall Sentiment**



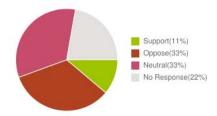

#### Overall Sentiment

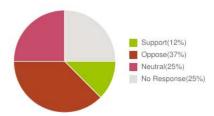

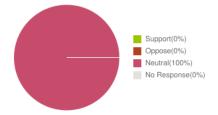
