COVID-19 Situation Report

FEBRUARY 23, 2021

CURRENT INITIATIVES AND UPDATES

- Manhattan Avenue Reopens The City restored two-way traffic on Manhattan Avenue in Downtown Manhattan Beach after a two-week trial closure to facilitate further social distancing at restaurants offering outdoor dining in the public right-of-way. Upon assessing impacts and carefully considering community input, the City decided to reopen the affected areas to vehicular traffic. The City appreciates the residents and businesses for their patience during the trial street closure. Residents are encouraged to continue to shop and dine local, supporting all businesses in Manhattan Beach. Visit citymb.info for details.
- Where L.A. County Stands on the States Tier System The State updated tier assignments today, under its <u>Blueprint for a Safer Economy</u> the criteria used to loosen and tighten regulations on activities. While <u>Los Angeles County remains in Tier One</u> (Purple), with "widespread" risk and the <u>most restrictions</u>, it continues to improve its standing. According to the State's website, L.A. County reflects 16.5 new COVID-19 cases per day (per 100K), decreasing from 29 (last week), with an adjusted case rate for tier assignment equaling 12.3. The County's overall test positivity rate dropped from 7.2% to 5.1%. L.A. County's daily case rate must be at or below seven (7) new cases per 100K, and the County's test positivity rate must be at or below 8% to move out of Tier One (Purple). The <u>health equity metric</u> also reduced from 10.10% to 7.50%. FEDERAL, STATE, AND COUNTY UPDATES

- Vaccination Update There continues to be a scarcity of supply and variability in the amount of vaccine received from week to week. The County has capacity for almost 500,000 appointment slots this week. However, there are only enough doses for 209,000 appointments. The large capacity vaccination sites alone could provide 157,000 additional doses if there were sufficient vaccine supply. At this time, as more vaccine comes into L.A. County, the priority is to ensure that eligible residents and workers in the hardest-hit communities have easy access to vaccines. On March 1, three other sectors become eligible to receive vaccinations; education and childcare, food and agriculture, emergency services, and first responders. The County is working with these sectors and other partners to finalize vaccination strategies that offer multiple sites where eligible workers can get vaccinated. There are approximately 691,000 people in the education and childcare sector, 145,000 people in the emergency services and law enforcement, and 470,000 people in the food and agriculture sector eligible for a vaccine. - COVID-19 Home Test for Older Adults The L.A. County Home Test Collection is a pilot program with Fulgent Genetics that provides Older Adults the opportunity to take a COVID-19 test at home. The Fulgent Genetics home test collection is the same nasal swab offered at County testing sites. Home PCR tests are available from many sources, but only people who meet one of the following criteria will qualify for a no-cost test through the L.A. County Home Test Collection. 1) Have symptoms of COVID-19. 2) Were in close contact with someone who has or is suspected of having COVID-19 in the past two weeks. And 3) you are an older adult or person with a disability who feel were exposed to COVID-19 and cannot go to a testing site. Sign up on the Fulgent Genetics website to have a test kit shipped to your home address via FedEx. The test kit will arrive in two days. The L.A. County Home Test Collection Pilot Program concludes February 28. Visit covid19.lacounty.gov for details.
- Actions in Response to COVID-19 <u>Governor Newsom signs several legislative measures</u> in response to COVID-19 that provides relief to Californians experiencing hardship during the pandemic:
 - Assembly Bill 81 COVID-19 relief for tenant rental debt;
 - o Assembly Bill 82 COVID-19 pandemic emergency: contact tracing: childcare;
 - Assembly Bill 85 Budget Act of 2020;
 - Senate Bill 87 California Small Business COVID-19 Relief Grant Program, income tax gross income exclusion, and small business grants;
 - Senate Bill 88 One-time stimulus payment delinquent accounts Earned Income Tax Credit;
 - Senate Bill 94 Waives alcoholic beverage control, barbering & cosmetology license and renewal fees; and
 - Senate Bill 29 vote by mail ballots extension to January 1, 2022.
- FDA Addresses Virus Variants The U.S. Food and Drug Administration (FDA) is committed to
 identifying efficient ways to modify medical products; specifically covering vaccines, tests,
 diagnostics, and therapeutics that are either in the pipeline or have been authorized for
 emergency use to address the emergence of variants of SARS-CoV-2. The FDA issues guidance

- Schools Grades K-6 May Reopen in Purple Tier with C.R. < 25 per 100K- The California Department of Public Health (CDPH) posted an updated School Reopening Framework. Schools may not reopen for grades 7-12 if the County is in Purple Tier. However, grades K-6 may reopen for in-person instruction in the Purple Tier with case rates (C.R.) less than 25 per 100,000 if they complete and post a COVID-19 Safety Plan (CSP) to their website homepage and submit the CSP to their local health officer (LHO) and the State Safe Schools for All Team. There are no identified deficiencies, as described in the CSP Posting and Submission Requirements for In-Person Instruction. Visit cdph.ca.gov for more information.
- County Updated Health Order Addresses Schools Grades TK-6 L.A. County Department of Public Health (DPH) updated the Health Order to address Schools (K-12) and School Districts. Key points include when the adjusted daily case rate has been less than 25 per 100,00 for five consecutive days, and the school has met all State and County requirements for reopening, schools may open for in-person instruction for students in grades TK-6. Students in grades TK-6 returning for general in-person instruction must be assigned to stable groups of students and instructors day-to-day that do not mix with other regular groups. - Updated Health Equity Playbook CDPH updated the COVID-19 Health Equity Playbook. The COVID-19 Health Equity Playbook for Communities intends to support local communities in achieving their Health Equity Measure as part of California's Blueprint for a Safer Economy and building an equitable recovery. Counties can use this document to inform Targeted Equity Investment Plans. This living document will continue to be updated as the pandemic progresses and as more is learned about what strategies are working. The COVID-19 Health Equity Playbook Bulletins share new equity resources, best practices, and procedures to support communities and local health departments on an ongoing basis. - COVID-19 Resources for Educators Teachers, administrators, and school staff play a vital role in creating supportive and healthy environments in which students learn and thrive. As schools resume in-person learning during the COVID-19 pandemic either for the first time or following an outbreak, the Center for Disease Control and Prevention (CDC) provides resources to help protect students' health and well-being, staff, and administration. - Projections in Healthcare / Predictive Modeling Los Angeles County <u>Department of Health Services</u> (DHS) released the <u>COVID-19 Projections of Hospital-based Health Care Demand February 22 Update</u>. The update includes data on hospitalizations through February 19, 2021. The underlying statistical prediction model is unchanged from last week. Key findings in the report include:

- The number of new patients with COVID-19 requiring hospitalization each day across Los Angeles County has continued to decrease.
- o Based on the most recent available hospitalization data, information that reflects transmission that occurred near the end of January and the beginning of February, the estimated transmission number ("R") at that time was 0.78 with an uncertainty of 0.71 to 0.83. Our prior estimate for one week earlier was similar at 0.81 with an uncertainty of 0.76 to 0.85.
- Based on the pattern in hospitalizations, we expect a decreasing demand for hospitalbased services, including hospital beds, ICU beds, and ventilators, over the next four weeks.
- o Daily mortality is falling and is predicted to continue to fall.
- o An increase in behaviors that facilitate transmission could lead to a new upturn in the number of hospitalized patients in about three weeks.
- o The DHS team's epidemic model estimates the number of people in Los Angeles County who:
 - Are still susceptible to infection if exposed;
 - Have been exposed and are incubating, but not infectious;
 - Have COVID-19 and are infectious to others, though they may have no symptoms;
 and
 - They have had COVID-19 and either recovered or died, so they are no longer infectious.
- o The model suggests that about 0.14% (uncertainty of 0.08% to 0.23%) of everyone in Los Angeles County is currently infected and infectious to others.
- This would suggest about 1 in 730 (between 1 in 1200 and 1 in 440) Los Angeles County residents are currently infectious to others. One week ago, this estimate was 1 in 460.
- Approximately 1 in 3 persons in Los Angeles County has been infected with COVID-19 since the beginning of the pandemic.
- L.A. County Daily Briefing Statistics on COVID-19 DPH confirmed 157 recent deaths, two new cases in Manhattan Beach, and 2,091 new COVID-19 cases in Today's Daily Report. To date. DPH identified 1,183,378 positive cases of COVID-19 across all areas of L.A. County and a total of 20,057 deaths. There are 2,146 people with COVID-19 currently hospitalized, and 31% of these people are in the ICU. Testing results are available for approximately 5,778,000 individuals, with 19% of all people testing positive. Public Health inspectors examine businesses every day to ensure compliance with the Los Angeles County Health Officer Order, identify violations, and issue citations for companies out of compliance. During Public Health's recent business compliance checks, inspectors noted restaurants with unapproved structures, tables less than eight feet apart, T.V.s turned on, staff without face shields, and retail stores not monitoring occupancy. For organizations to remain open, all businesses are required to adhere to their sector-specific protocols fully. From February 14 through February 18, Public Health issued 36 citations to companies, including restaurants, food markets, gyms, personal care salons, and shopping malls, for noncompliance with Health Officer Orders.
