NOT ONLY THAT THEY WANT A COMMITTEE TO OVERSEE AND TAKE CHARGE OF -- OF VIRTUALLY EVERYTHING THAT WE DO AS A CIVIC ORGANIZATION.

WE DESERVE BETTER.

THIS IS SOMETHING THAT SHOULD NOT HAPPEN.

- I HAVE LIVED HERE FOR 50 YEARS, SO I'VE SEEN LOT OF STUFF GO ON.
- I CAN'T BEGIN TO TELL YOU THAT I DO NOT THINK WE'RE RACIST.

WE TRUST THAT YOU'LL ALWAYS HAVE OUR BEST INTERESTS AT HEART.

HOPEFULLY YOU WILL NOT THROW US UNDER THE BUS AND DECLARE US A RACIST

CITY.

REMEMBER, YOU SERVE MANHATTAN BEACH NOT MISS HAHN.

SECONDLY, I THINK IT IS IMPORTANT THAT WE STOP IMMEDIATELY THIS CONSIDERATION OF MANHATTAN BEACH AS A RACIST CITY.

IT IS SOMETHING WE CANNOT HAVE.

>> I'M SAMANTHA, I'M THE CHIEF OF SUSTAINABILITY AT THE AIRPORT.

REALLY APPRECIATE THIS OPPORTUNITY TO DO A BRIEF PRESENTATION ON AN

UPCOMING PROJECT, THE AIRFIELD AND TERMINAL MODERNIZATION PROJECT

OR EPMT.

IF THAT'S OKAY, I'M GOING TO SHARE MY SCREEN.

WE HAVE A -- WE HAVE A BRIEF PRESENTATION.

EVERYONE ABLE TO SEE THAT OKAY?

>> YES.

>> TERRIFIC.

IF YOU HAVE ANY QUESTIONS, PLEASE FEEL FREE TO ASK THEM ALONG THE WAY OR I'LL TAKE ANY OUESTIONS AT THE END.

AGAIN BRIEF OVERVIEW OF WHAT THIS PROJECT IS.

IT STARTS OFF HERE IN THE NORTH AIRFIELD WHERE WE ARE MAKING SOME AIRFIELD IMPROVEMENT TO OUR TAXI WAY EXIT.

THESE TAXI WAY EXITS ARE IN THE HIGH ENERGY ZONE WHERE PLANES ARE TAKING OFF AND WE'LL RELOCATE THOSE FOR SAFETY AND EFFICIENCY ON OUR AIRFIELD.

WE'RE ALSO LOOKING AT EXTENDING WHAT WE CALL TAXI WAY D, AGAIN TO ALLOW FOR MORE OPERATIONAL EFFICIENCY ON THE AIRFIELD.

IT TAKES OUT SOME WEST REMOTE GATES.

THESE ARE ARE GATES THAT ARE -- NEED TO BE BUSSED TO.

THEY DON'T HAVE ANY PROCESSING.

THEY DON'T HAVE RETAIL OR CONCESSIONS.

THEY'RE BASICALLY NOT THE GREATEST PASSENGER EXPERIENCE SO BY TAKING OUT THE GATES WE'RE ABLE TO RELOCATE THEM ON CONCORD ZERO AND HERE TO TERMINAL 9 WHICH WILL PROVIDE FOR A BETTER PASSENGER EXPERIENCE. THIS WILL PROVIDE BETTER ACCESS INTO AND OUT OF THE AIRPORT.

THOSE ARE THE MAJOR PROVISIONS OF THE PROJECT.

JUST A BIT OF BACKGROUND ON WHY WE'RE EMBARKING ON THIS PROJECT.

IT REALLY STARTED OFF WITH IMPROVEMENTS AS I MENTIONED TO THE NORTH

AIRFIELD.

WE WANTED TO BRING THAT AREA UP TO FAA STANDARD.

THERE WAS SAFETY ISSUES IN TERMS OF THE TAXI WAY EXITS.

WE NEEDED IMPROVED MANAGEMENT OF OUR AIRFIELD OPERATIONS.

THE TERMINAL CAME ABOUT WHEN WE REQUIRED REMOVAL OF SOME WESTERN GATES.

WE'RE ALSO ANTICIPATING FUTURE GROWTH.

WE WANTED TO MAKE SURE THAT THE PASSENGER EXPERIENCE THAT WE THINK WOULD BE BETTER WITH THE CONTACT GATES AT ZERO AND NINE HAVE FULL-SERVICE FACILITIES.

THEY'RE BETTER INTEGRATED INTO THE TERMINAL AREA AND THEY WILL WITH BE REACHABLE BY OUR AUTOMATED PEOPLE MOVER.

YOU TAKE THE TRAIN TO THE AIRPORT AND REACH THESE FACILITIES.

THEY WILL BETTER BE ABLE TO HANDLE INCREASED PASSENGER LEVELS IN THE YEARS AHEAD.

AND THEN THE ROADWAY IMPROVEMENTS ARE ARE OBVIOUSLY A FACTOR.

ANYONE WHO HAS BEEN TO THE AIRPORT KNOWS THAT THEY'RE -- THERE HAS

GOT TO BE A BETTER WAY TO GET IN AND OUT OF THE AIRPORT.

WE KNEW ESPECIALLY THAT TUNNEL WAS -- WAS GETTING QUITE CONGESTED AND REALLY WE WITH WANTED TO TAKE THIS AS AN OPPORTUNITY TO NOT ONLY PROVIDE ACCESS TO HAD IT NEW TERMINAL NINE BUT SHAPE AND CHANGE THE WAY PEOPLE ACCESS THE AIRPORT.

WE WITH WANTED TO MAKE SURE THESE IMPROVEMENTS WERE IN PLACE BY 2021.

WE TOOK A LOT LOT OF PLANNING TIME TO LOOK AT PASSENGER LEVELS AT LAX.

WE WORKED CLOSELY WITH SKAGG AND THEIR REGIONAL TRANSPORTATION PLAN
TO LOOK AT THE DEMAND FORECAST.

THEIR FORECAST GOES THROUGH 2045.

WE WORKED WITH THEM ON THOSE PROJECTIONS AND BOTH PROJECTS WERE DONE REALLY INDEPENDENT OF THE PROJECT, MEANING WE LOOKED AT PASSENGER DEMAND WITHOUT THIS PROJECT.

WE CAME UP WITH THE SAME NUMBERS AS SKAGG.

THROUGH 2045 IT WAS ANTICIPATED ABOUT 127 MILLION ANNUAL PASSENGERS WOULD BE COMING TO LAX AND THIS IS ACTUALLY A SMALLER SHARE OF WHAT WILL BE DISTRIBUTED THROUGHOUT THE REGION.

THAT MEANS THE OTHER AIRPORTS ARE TAKING ON THEIR SHARE OF THE GROWTH.

WE ALSO PROJECTED ACTIVITY LEVELS OF ABOUT 800,000 ANNUAL AIRCRAFT

OPERATIONS AND BECAUSE THIS PROJECT OPENS IN 2028 OUR -- OUR PASSENGER

COUNT WAS ABOUT 110 MILLION ANNUAL PASSENGERS.

AGAIN THIS WAS DONE WITHOUT CONSIDERING THE PROJECTS.

THESE ARE THE NUMBERS WITH WITH OR WITHOUT THIS PROJECT.

SO A LITTLE BIT MORE ABOUT CONCORD ZERO.

IT IS AT THE CURRENT SITE OF THE L.A. CONCORD.

THERE WILL BE NINE NEW PASSENGER GATES AND CONNECTED TO THE CENTRAL TERMINAL AREA AND PEDESTRIAN CONNECTION TO THE NEW AUTOMATED PEOPLE WHO ARE UNDER CONSTRUCTION.

TERMINAL NINE WILL HAVE GATES, 12 GATES FOR WIDE BODY AIRCRAFT.

CAMPUS PEEL SO THAT DOMESTIC AND INTERNATIONAL PASSENGERS HAVE

GREATER CONNECTIVITY AND CAN GO FROM ONE TERMINAL TO THE OTHER.

IT WILL ALSO HAVE ACCESS TO THE AUTOMATED PEOPLE MOVE STATION.

THIS GIVES YOU A SNAPSHOT OF THE ROADWAYS.

WE'RE LOOKING AT -- AT THIS -- THIS SOUTHBOUND ON SEPULVA.

IF YOU'RE GOING SOUTHBOUND, YOU TAKE THE SKYWAY BRIDGE AND GOES TO THE RIGHT AND COMES INTO THE TERMINAL AREA.

WE WANTED TO IMPROVE THE COMMUNITY EXPERIENCE BY REDUCING TRAFFIC CONGESTION ON LOCAL STREETS.

PUBLIC COMMENT CLOSES ON MARCH 15TH.

DURING CONSTRUCTION AND THE OPERATIONS.

WE LOOKED THROUGH THESE RESOURCE AREAS AND YOU COULD SEE HERE THE AREA THAT HAD SIGNIFICANT IMPACT AND EVEN HAVING SIGNIFICANT IMPACTS AFTER MITIGATION.

AND SO WE INCLUDED A LOT OF MITIGATION MEASURES IN THE EAR.

AND AS I MENTIONED PREVIOUSLY A LOT -- WE WERE ABLE TO FORECAST PASSENGER GROWTH WITH AND WITHOUT THE PROJECT.

SO THAT INCLUDES FROM THE TYPE OF EQUIPMENT WE USE TO RECYCLING TO ROCK CRUSHING FACILITIES ONSITE TO ELIMINATE TRUCK TRAFFIC AND USING THINGS LIKE SOLAR ENERGY.

THAT HAS BEEN BUILT IN THE PROJECT.

FOR CONSTRUCTION NOISE WE WERE ABLE TO MITIGATE THAT TO A LEVEL LESS THAN SIGNIFICANT BASED ON A LOT OF OTHER PLANS THAT WE USED FOR SIMILAR PROJECTS.

AND FOR AIRCRAFT NOISE WE ARE PROPOSING TO UPDATE OUR NOISE EXPOSURE MAP BEFORE THE PROJECT IS OPERATIONAL.

THIS MAP SHOWS THE CONTOURS OF WHAT RESIDENCES ARE ARE IMPACTED BY NOISE FROM AIRCRAFT AND WE WOULD COMMIT TO PROVIDE SOUND INSULATION FOR ANY RESIDENT THAT WOULD BE PART OF THE CONTOURS.

LASTLY, OUR PROGRAM HAS A VERY COMPREHENSIVE VEHICLE MILES TRAVEL PRODUCTION PROGRAM.

THIS IS THE NEW MEASURE FOR HOW TO REDUCE TRANSPORTATION IMPACTS.

YOU HAVE TO REDUCE THE VEHICLE MILES TRAVELED.

SO WE HAVE A COMPREHENSIVE PROGRAM INCLUDED IN OUR MITIGATION
MEASURES THAT AIM TO GET PEOPLE OUT OF THEIR CARS AND INTO OTHER

ALTERNATIVES.

WE HAVE THINGS LIKE ON DEMAND MICRO TRANSIT, OUR SERVICE, EXPANDING OUR RIDE SHARE PROGRAM TO THE ENTIRE L.A.X. CAMPUS AND EVEN CONDUCTING CONGESTION PRICING STUDY THAT WOULD MOVE PEOPLE TO OUR AUTOMATED PEOPLE MOVER AND TO THOSE FACILITIES.

SO THIS IS THE TIMELINE FOR THE PROJECT.

THE DRAFT AS I MENTIONED THE DR. E.I.R. WAS RELEASED IN OCTOBER AND COMMENTS WILL BE ACCEPTED UNTIL MARCH 13TH.

WE HAVE A VIRTUAL OPEN HOUSE AND WE HAVE A VIRTUAL OPEN -- OPEN MEETING PRESENTATION FROM OUR MEETING THAT WE DID IN THE SUMMER.

FOOD AND FOOD SERVICE ELIGIBLE THIS WEEK AS WELL AS EMERGENCY SERVICES.

THERE ARE MORE THAN 400 VACCINE LOCATIONS ACROSS L.A. COUNTY AND THEY

HAVE ALSO SHARED HAS THEY WILL BE DOING SOME DEDICATED CLINICS FOR THOSE SPECIFIC POPULATION.

THIS IS SOMETHING TO CELEBRATE THAT WE PULLED TOGETHER PARTNERSHIP OF 11 SCHOOL DISTRICTS AND COME TOGETHER AND COLLABORATE AND GET OUR TEACHERS VACCINATED.

WE'RE PLEASED.

IT HASN'T BEEN EASY.

AS YOU KNOW, COORDINATING 11 DIFFERENT GROUPS IS -- IS TRICKY, BUT IT IS WORKING WELL.

AND WE'RE REALLY PLEASED TO GET STARTED TOMORROW.

WE ARE AT -- AT SORT OF THE -- OF THE MERCY IF YOU WILL OF L.A. COUNTY AS FAR AS WHAT VACCINES WE GET.

WHILE WE REQUESTED VACCINES FOR OUR PRIVATE SCHOOLS IF THE BEACH CITIES WE DID NOT RECEIVE AN ALLOCATION FROM L.A. COUNTY FOR THOSE PRIVATE SCHOOLS.

SO THEY'RE PART OF THE CONSORTIUM.

WE'VE BEEN GOING TO BAT FOR THEM BUT L.A. COUNTY RELEASED VACCINES FOR THOSE SCHOOLS.

WE'VE BEEN REQUESTING VACCINES FOR GENERAL DISTRIBUTION FOR A MONTH NOW.

WE'RE A CERTIFIED PROVIDER.

WE HAD THE ADVENTURE PARKS WITH YOUR HELP READY TO GO.

WE JUST HAVEN'T RECEIVED VACCINES.

THESE ARE THE FIRST VACCINES WE RECEIVED FOR A SPECIFIC GROUP OF TEACHERS.

WE HOPE THAT OTHER VACCINES WILL -- WILL BE COMING.

IN THE MEANTIME, WE HAVE BEEN FOCUSING ON THE HEALTH PROMOTION AND EDUCATION.

YOU COULD SEE WHAT WE'VE DONE WITH OUR OLDER ADULT CLIENTS THAT WE HELP WITH.

I THINK AS MOST PEOPLE KNOW, THESE CITIES HEALTH DISTRICT, WE HAVE ABOUT FIVE SOCIAL WORKERS, WE WORK WITH 350 OLDER ADULT CLIENTS TO PROVIDE THEM ASSISTANCE IN THE THREE BEACH CITIES.

WHAT WE'RE DOING IS WE'RE GOING TO THEIR HOMES AND BOOKING

THEM -- BOOKING APPOINTMENTS FOR THEM SO YOU COULD SEE THERE WHERE

WE'VE DONE THAT FOR 28 OF OUR CLIENTS AND SEVEN OTHER OLDER ADULTS.

THAT'S SOMETHING WE'RE ASSISTING WITH.

WE'RE ASSISTING WITH WITH TRANSPORTATION IN GETTING PEOPLE TO THE SITES AND SUPPORTING HOMEBOUND OLDER ADULTS.

YOU CAN SEE IT IS CLOSER TO 68 PERCENT THAT RECEIVED THE FIRST DOSE OF OUR CARE MANAGEMENT CLIENTS.

WE'RE ALSO CONTINUING TO -- TO TRY TO DO A CLOSED CLINIC SIMILAR TO WHAT WE'RING TO WITH EDUCATORS WHERE WE WOULD PERHAPS GO TO APARTMENT COMPLEX OR WE WOULD HAVE FOLKS COME TO US HERE AT THE ADVENTURE PLEX AND WE'RE ALL SET UP AND READY TO GO.

THAT'S WHAT WE HOPE TO DO WITH OLDER ADULTS.

WE HOPE THAT CHANGES.

WE'RE TAKING WHAT THEY'RE GIVING US WHICH ARE THE VACCINES FOR EDUCATORS AND THEN WE HOPE THAT WE'LL GET PORE.

WE URGE PEOPLE TO CALL OUR HOTLINE.

CALL US WITH ANY QUESTIONS AND BEEN AN ACTIVE HOTLINE.

WE HOPE PEOPLE WILL CALL THAT.

IF YOU'RE OLDER ADULT AND NEED HELP, PLEASE CALL THAT NUMBER AND WE'LL TO OUR BEST TO HELP YOU GET A VACCINE AND HOPEFULLY SOON WE'LL BE DOING VACCINES HERE IN THE SOUTH BAY.

THIS IS LOTS MORE LOCATIONS HERE SINCE -- SINCE MARCH 1ST AND A LOT MORE PEOPLE THAT ARE ARE ELIGIBLE.

THIS IS JUST SOME OF WHAT WE'RE HEARING FROM SOME OF OUR -- OUR OLDER

ADULTS THAT HAVE BEEN ABLE TO WORK WITH US TO GET A VACCINE.

THIS IS ONE OF OUR STATS, ACTUALLY FOR A TICKET BECAUSE THEY DID NOT HAVE A PRIMARY COMPUTER.

THIS IS AN EXAMPLE OF THE TYPES OF THINGS THAT WE'RE DOING FOR OUR -- FOR OUR OLDER ADULTS AND 196 HAVE BEEN VACCINATED.

SO WE'RE PLEASED WITH THAT.

OVER TWO-THIRDS THROUGH OUR CARE MANAGEMENT LIST.

I THINK THAT COVERS WHAT WE WANT TO TALK TO YOU ABOUT.

HAPPY TO ANSWER QUESTIONS.

I KNOW THERE'S LOTS OF QUESTIONS AND WE WANTED TO BE AVAILABLE TO ANSWER ANY QUESTIONS THAT YOU MAY HAVE AS WE WE GET READY TO OPEN THE CLOSED CLINIC TOMORROW.

I SEE COUNCIL MEMBER MONTGOMERY HAS A QUESTION.

ON THAT NOTE THIS IS TO DISCUSS COMMENTS ON THE LOS ANGELES AIRPORT PROPOSED AIRFIELD AND TERMINAL MODERNIZATION PROJECT AT LOS ANGELES

INTERNATIONAL AIRPORT.

THIS IS COMING BEFORE YOU AS A RESULT OF A REQUEST BY THREE CITY COUNCIL MEMBERS AS OF FEBRUARY 16, 2021 MEETING TO DISCUSS THE PROJECT AS -- AS INDICATED IN THE -- IN THE EARLIER PORTION OF THE MEETING.

THERE'S SIGNIFICANT PROJECT UNDER WAY, A PROPOSED PROJECT UNDER WAY
FOR DISCUSSION.

PURSUANT TO THE PROJECT, CALIFORNIA ENVIRONMENTAL QUALITY ACT AN SQA DOCUMENT DRAFTED BY THE REPORT IS BEING PREPARED ABOUT THE ENVIRONMENTAL IMPACTS.

THE DEADLINE FOR THE COMMENTS IS MARCH 15TH.

ONE IS STREET PARKING IN MANHATTAN BEACH.

ALL NEIGHBORHOODS HAVE SEEN THIS WHERE PEOPLE FROM ORANGE COUNTY OR VENTURA, EVERYWHERE JUST COME UP AND THEY'LL PARK ON THE STREETS AND THEY'LL TAKE A -- TAKE A -- A SHARE -- A VEHICLE TO THE AIRPORT BECAUSE THE ONSITE PARKING JUST COSTS SO MUCH.

AND MIKE GORDON, HOUSE MEMBER MAYOR OF EL SEGUNDO AT THE TIME MADE

A COALITION FOR A REGIONAL AIRPORT.

HE WAS APPOINTEE FOR THE REGIONAL EFFORT.

I WORKED ON IT FOR A NUMBER OF YEARS.

LEFT BY THE WAY SIDE.

THERE'S NEVER REGIONAL.

I'M ASSUMING WE'LL LET DIRECTOR TAI GO THROUGH WITH THE TECHNICAL COMMENTS.

CORRECT?

ANYBODY HAVE OBJECTION TO THAT?

OKAY.

SEEING NONE, DIRECTOR TAI YOU HAVE DIRECTION ON THAT.

YES.

>> I WANTED TO ADD ON, YOU KNOW, THANK YOU ALL OF THE COUNCIL MEMBERS FOR YOUR COMMENTS.

THERE ARE EXTENSIVE TECHNICAL STUDIES THAT ARE -- ARE IN THE EIR.

THEY TELL US A LOT ABOUT THE EXISTING NOISE FROM -- FROM WHETHER IT

IS ROADWAY NOISE OR AIRCRAFT NOISE AS WELL AS THE POST DEVELOPMENT

NOISE THAT THEY ANTICIPATE.

I MEAN, IN GENERAL BECAUSE HERE DOING EAST WEST CHANGES THERE'S NEW NOISE IMPACTS FOR EXAMPLE DIRECTLY TO THE EAST OF THE AIRPORT.

YOU KNOW, WE IN LOOKING AT THE DOCUMENT COLLEEN AND I HAVE ACTUALLY YOU KNOW, WE HAVER A PRELIMINARY ASSESSMENT OF A LOT OF THESE IN TERMS

OF IMPACTS AND I MEAN THIS ARE REGIONAL TRAFFIC CONGESTION ISSUES
ALREADY AND YOU KNOW BASED ON OUR REVIEW OF THAT THIS WILL BE REGIONAL
TRAFFIC CONGESTION ISSUES WHETHER THE AIRPORT EXPANDS OR OTHERWISE.
ASSUMING YOUR 2 PERCENT TRADITIONAL GROWTH WAIT.

I WANT TO SAY THIS -- IN TERMS OF AN EIR COMMENT LETTER ARE, WE CAN COMMENT -- I DON'T WANT TO BE TOO DRAMATIC ABOUT THIS, WE CAN WRITE VERY DETAILED COMMENTS AND ASK QUESTIONS SO AT THE END OF THE DAY, THERE'S VERY THOROUGH TECHNICAL ANALYSIS TO SUPPORT THE POSITION, THE CITY OF MANHATTAN BEACH OTHER THAN EXISTING ISSUES THAT FRANKLIN MENTIONED WE WON'T SEE TOO MUCH ADDITIONAL IMPACT OF THIS.

WE'LL GET INTO THE LETTER AND THE DETAILS, THAT'S WHAT WE'RE SEEING IN OUR PRELIMINARY ASSESSMENT.

WITH REGARD TO THINGS LIKE WHAT PEOPLE DO BEFORE THEY GO TO LAX AND PARKING ON RESIDENTIAL STREETS OR YOU KNOW, DRIVING THROUGH THEIR CHOSE OF WHICH STREET IT IS TO GET THERE, THERE'S VERY LITTLE CONTROL THAT ANYBODY.

WE CAN'T CONTROL WHERE PEOPLE CHOOSE TO TURN.

SO WITH WITH THE STREET PARKING ISSUE, I'VE SEEN NEIGHBORHOODS AROUND AIRPORTS PUT UP RESTRICTIVE PARKING SIGNS.

48-HOUR LIMIT OR WHATEVER.

IF THAT'S A CONCENTRATED ISSUE, MAYBE A CONVERSATION WITH LAX.
WE COULD LOOK AT THINGS LIKE THAT.

THE EIR DOCUMENT DOES IDENTIFY CONSTRUCTION HALL ROUTES AND IF THE COUNCIL WANTED WE COULD CERTAINLY PROVIDE THAT INFORMATION.

BUT I JUST YOU KNOW, REALLY WANT TO SAY A LOT OF THAT IS ANALYZED

THANK YOU.

>> I JUST WANTED TO POINT OUT ANOTHER CONCERN IS SOMETHING WE LEARNED IN THE PRESENTATION.

THERE'S A NET INCREASE IN THE NUMBER OF TERMINALS AND GATES THAT THIS PROJECT WILL PRODUCE.

IT IS AN ABSOLUTE EXPANSION.

IT IS NOT JUST A REDISTRIBUTION OF THE CURRENT USE OF THE AIRPORT.

AND YOU KNOW, THAT HAS IMPLICATIONS THAT ARE ARE LASTING FOR OUR

COMMUNITY, FOR SURE, BECAUSE IT WILL ABSOLUTELY INCREASE THE USE OF

THE AIRPORT.

AT SOME POINT WHEN YOU EXPAND SOMETHING HAS IS -- THAT IS -- IS -- YOU KNOW, IT IS NOT JUST FOR PASSENGER USE BUT -- BUT THEY'RE CREATING THE TERMINAL.

IT WILL INCREASE THE USE OF THE AIRPORT BY -- BY AIRLINES.

THAT INCREASED TRAFFIC WILL HAVE A POSITION AS WELL.

THEN I THINK THE DIRECTION, IT DOESN'T SOUND LIKE WE NEED A MOTION, QUINN, IS THAT RIGHT?

WE CAN PROVIDE DIRECTION FOR KERRY TO SUBMIT THE EIR COMMENTS AND THEN WE'VE ALREADY ASKED THAT WE LIKE INPUT FROM HAHN FOR THE FUTURE AND WE'LL POSTPONE THE DISCUSSION OF ANOTHER LETTER AND STARTING A LAWSUIT.

FOR THE FUTURE.

HANDS UP.

YES.

>> I WOULD SAY THE NEXT STEP, OUR DIRECTION TO HAVE HER HAVE THE ABILITY TO WORK WITH THEM ON THE CONSULTANT WHETHER IT IS A JOINT OPERATION OR HERMOSA MANHATTAN BEACH, WHATEVER IT TAKES, WHATEVER IS APPROPRIATE AND I WANT TO MAKE SURE THAT'S AN OPTION AVAILABLE TO HER AND WE GO FROM THERE.

- >> I WANT TO TALK TO HAHN BEFORE I CONSIDER HIRING CONSULTANT.

  IF HAHN IS IN FAVOR OF THIS, I THINK WE CAN GO AHEAD.
  - >> IT IS ALLOW THAT FOR THE CITY.

NOT FOR THE SUPERVISOR, IT IS FOR OUR OWN BENEFIT.

LIKE OTHERS HAVE DONE.

>> I UNDERSTAND.

WE'VE ALSO HEARD FROM STEVE THAT -- THAT -- THAT IN THE 90S THE BOARD

OF SUPERVISORS WERE SO OPPOSED THEY SUED AND THAT SENT A MESSAGE TO LAWA.

I DON'T SEE OR HEAR THAT OPPOSITION NOW.

FOR JENNIFER TO SAY SUPERVISOR HAHN HAS NOT TAKEN A POSITION I THINK IS TELLING US SHE'S AT LEAST NOT STRIDENTLY OPPOSED OR I THINK WE WOULD ALREADY KNOW.

I'M SKEPTICAL WE'LL BE ABLE -- I'M RELUCTANT TO SPEND CITY FUNDS ON SOMETHING I DON'T THINK WILL ULTIMATELY BE SUCCESSFUL.

IF THE PROJECT GOES FORWARD WE'LL NIP AROUND THE EDGES.

I'M SURE AS PART OF THIS AND LAWA IS LOS ANGELES CITY.

SO YOU KNOW JUST FOR OTHER VOICES IN HERE TO HELP US GET IMPACT.

ADDITIONAL IMPACT.

>> STEVE YOU WANT TO WEIGH IN?

>> IT IS A GOOD IDEA THAT -- THAT -- THE QUESTION IS AGAIN YEARS

AGO WE DID A REGIONAL -- WHAT IS THAT, WE DID A REGIONAL EFFORT THAT

PUT TOGETHER THE LOCAL ELECTED.

I THINK IF THERE'S GOING TO BE, IF WE GO DOWN THE ROAD FOR INSTANCE
OF HIRING OR JOINING OUR NEIGHBORING CITIES THEN THERE SHOULD BE SOME
SORT OF SUBCOMMITTEE TO WORK TOGETHER.

WE'RE GOING TO DELVE INTO THE FUTURE OF THE LOS ANGELES COUNTY GRANT AND ROUNDTABLE DISCUSSION ON DECEMBER 10TH, UPDATE ON THE HOMELESSNESS COUNT AND MEOW POLICE DEPARTMENT INITIATIVE AND ABLE TO INCLUDE IN THE STAFF REPORT BUT IT IS EXCITING NEWS AND I CAN'T WAIT TO SHARE IT TODAY.

REDONDO BEACH ACTION OF INTEREST TO THE COMMUNITY AND COUNCIL, AS WELL AS COLLABORATION.

SO WITH THAT BEING SAID, HARBOR INTERFACE HAS BEEN UNDER CONTRACT FOR ONE ENTIRE YEAR.

THAT BEING JANUARY OF 2020.

YOU'LL RECALL THAT WE ENTERED INTO A CONTRACT WITH THEM, NOVEMBER OF 2019 THEN AFTER THEY WERE -- UP AND RUNNING AND THEY BEGAN DOING OUTREACH TO OUR HOMELESS COMMUNITY.

THIS IS THE REPORT THAT REVIEW MONTHLY WITH THE OTHER BEACH CITIES IN CONJUNCTION WITH REDONDO BEACH AND HERMOSA BEACH.

WHAT WE'VE DONE HERE, WE MEASURE ASSESSMENTS.

WE MEASURE INTERACTIONS AND CLIENT CASE MANAGERS.

WE MEASURE AND WE DIVIDE IT UP BY HERMOSA AND REDONDO AND MANHATTAN BEACH.

WHAT I'M UTILIZING IS CONTRACT START METRICS.

YOU RECALL WE HAD 35 CLIENTS.

223 INTERACTIONS.

THE REASON WE'RE DIFFERENTIATING BETWEEN CLIENTS IS THERE ARE PEOPLE THAT ARE DUPLICATES, PEOPLE THAT WE HAVE SUCCESSIVE INTERACTIONS WITH AND ONE CLIENT HAS IS DEDICATED TOWARD THAT.

THAT OF WE DIFFERENTIATE BETWEEN WHAT IS A ONE UP INTERACTION AND PEOPLE THAT ARE CASE MANAGERS, PEOPLE ACTIVELY INVOLVED IN SERVICES.

MANHATTAN BEACH RECALLS THAT -- THAT -- AN IT IS 12 INDIVIDUALS THAT HAVE BEEN CASE MANAGED ON A YEARLY BASIS BUT WITHIN THE BEACH CITIES, IT IS 76.

YOU KNOW, I DON'T MEAN TO -- TO -- THROUGH THE REPORT, YOU'LL SEE HAS WE DIVIDED THE DATA BY EACH CITY.

THE REASON WHY THAT IS -- IS -- IS DIVIDED, THE ONE WAY WE DIFFERENTIATE BETWEEN EACH CITY IS WHAT -- WHAT WOULD BE LOCATION AND WHICH THE INDIVIDUAL WOULD INITIALLY IDENTIFY BY.

THE ORIGINAL LOCATION THAT THE INDIVIDUAL WOULD IDENTIFY AT.

WHAT WE'VE BEEN DOING IS SAYING WE'RE CREATING A REGIONAL RESPONSE,
HOWEVER, THE WAY WE LOOK AT IT, IT IS A WIN FOR REDONDO IS WIN FOR
HERMOSA AND WIN FOR HERMOSA IS WIN FOR MANHATTAN.

WE'RE ALL WORKING TOGETHER.

HERE'S ADDITIONAL, SOME ADDITIONAL METRICS.

UP WE GOT THE 82 PEOPLE TOTAL DOCUMENT READY, THE PEOPLE WHO HAVE ALL OF THE NECESSARY DOCUMENTS ENROLLED IN THE PROPER BENEFITS.

OUR GOAL IS 120.

IN TERMS OF HOUSING REFERRALS, OUR GOAL WAS 28 SO WE SHOT PAST THAT.

WHILE THE GOAL IN THE BEGINNING ARE, WE WANT TO TRACK THAT UNTIL WE

HAVE 14 PEOPLE TOTAL THAT -- THAT WE'RE PLACED IN INTERFACE SERVICES.

WE HAVE 11, OUR GOAL IS 50.

WE'RE SHORT OF THAT BUT WE HAVE TO RECOGNIZE, THAT IS A COVID DIRECT IMPACT.

A LOT OF THESE FACILITIES WILL CLOSE DOWN.

YOU CAN'T ACCESS THEM MOST OF THE TIME.

THEN THE GREAT GOAL THAT WE'RE EXTREMELY PROUD ABOUT IS STABLE HOUSING REFERRALS.

THE DIFFERENCE YOU'LL SEE, STABLE HOUSING REFERRAL.

STABLE HOUSING REFERRAL IS FOR LONG-TERM, NOT NECESSARILY ON ONE MONTH, TWO MONTH, THREE MONTH LEASES.

WE MADE HOUSING PLACEMENTS ACROSS THE SIX CITIES, SIX BEING IN MANHATTAN BEACH.

OUR GOAL IS 22 FOR THE CONTRACT START DATE FROM MOVE TO MARCH.

SO I'LL TALK ABOUT HOW THAT CONTRACT IS EXTENDED NOW.

SO CERTAINLY, A GREAT -- A GREAT PLACE -- A GREAT NUMBER OF PLACEMENTS
MADE AND WE'RE HAPPY ABOUT THAT.

THERE'S STILL PROGRESS TO BE MADE.

SO THE FUTURE OF LOS ANGELES COUNTY GRANT.

THE CITY IS AWARDED 330,000 IN THE GRANT.

THE COUNTY RECOGNIZED THAT A LOT OF THESE HOMELESS SERVICES WERE IMPACTED BY COVID-19 AND THEY ACTUALLY EXTEND THE GRANT PERIOD FROM MARCH 2021 TO DECEMBER 2021.

SO THEY -- THE COUNTY HAS A NO COST EXTENSION.

THE FUNDING DOES NOT INCREASE BUT TIME TO ACCOMPLISH GOALS INCREASED.

WE HAVE CONTRACT SAVINGS AS A RESULT OF THAT.

THE CONTRACT HAS BEEN UNDER BUDGET.

SO THEREFORE WE'RE JUST EXTENDING THOSE -- THOSE BUDGET SAVINGS AND UTILIZING IT TOWARD THE END OF DECEMBER 2021 OR SOONER.

RIGHT NOW WE'RE PROJECTING FUNDS TO LAST UNTIL OCTOBER 2021 AND POSSIBLY SOONER MAY BE EXHAUSTED.

I'VE HAD PRELIMINARY CONVERSATIONS WITH THE COUNTY BECAUSE WE RECOGNIZE THAT THE CITY AND THE COMMUNITY DRASTICALLY IS APPRECIATIVE OF THIS SERVICE.

AND WE'RE IN CONVERSATIONS TO SEE HOW WE CAN FILL THAT GAP BECAUSE
THE NEXT ROUND OF GRANT FUNDING THAT THE COUNTY HAS WILL BE JANUARY
2022.

SO WE'RE WORKING ON A PROVIDE UPDATE TO THE CITY COUNCIL TO LET THEM KNOW HOW THE SERVICES WILL CONTINUE TO BE FUNDED.

THAT'S SOMETHING THAT IS JUST BY WAY OF UPDATE FOR THE CITY COUNCIL.

YOU'LL RECALL THAT WE DID -- SINCE THE LAST UPDATE WE HAD A ROUNDTABLE
DISCUSSION.

THE CITIES HELD A VIRTUAL COMMUNITY MEETING.

I THINK AT THE HEIGHT OF THE MEETING IT HAD ABOUT 120 VIEWERS ON THE ZOOM AND ACROSS THE YOUTUBE.

RIGHT NOW IT IS 63 VIEWS.

- I THINK THE LAST TIME I CHECKED THEY HAD 80 VIEWS ON THERE.
- I THINK WHERE YOU VIEW ON YOUTUBE IS INDIVIDUAL WATCHES SOMETHING

FOR LONGER THAN 30 SECONDS.

IT IS LONGER THAN FIVE TO TEN SECONDS.

EVERY METRIC IS DIFFERENT.

HOMELESS COUNT, WE DID NOT HAVE A HOMELESS COUNT THIS YEAR.

THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT HAD A POINT IN TIME COUNT WHILE THIS WASN'T THE BEST NEWS IT WAS UNDERSTANDABLE GIVEN THE PANDEMIC.

OBVIOUSLY HOMELESS COUNTS REQUIRE A GOOD AMOUNT OF INDIVIDUALS TO GATHER.

THEY ALSO IS SOMETHING THEY'VE DONE UTILIZING VOLUNTEERS

TRADITIONALLY MANHATTAN BEACH HAS 30 VOLUNTEERS AT THE COMMUNITY

CENTER, GIVEN THE CIRCUMSTANCES IT PROBABLY WOULD HAVE BEEN VERY

DIFFICULT TO CONDUCT THE HOMELESS COUNT.

SO UNFORTUNATELY, THE CITY WON'T HAVE THAT ON THE CITY'S HOMELESS COUNT FOR THE YEAR UNTIL 2021.

ONE THING THAT WAS RECENTLY ROLLED OUT BY THE CITY'S POLICE DEPARTMENT IS -- IS THE ESTABLISHMENT OF HOMELESS LIAISONS WITHIN THE PATROL DIVISION.

THIS WAS DONE BY -- BY BOSQUE PARTICULARLY AND IS GEARED TO UNIFYING OUR HOMELESS RESPONSE.

YOU NOTICE WE HAVE OFFICERS AND THE POLICE THAT OBVIOUSLY A FIFTH OF EFFORTS AND WE'RE REALLY DEDICATING INDIVIDUALS TO REALLY BE THE POINT PERSON FOR HANDLING HOMELESSNESS AND WE'RE SPREADING THAT OUT TO INDIVIDUALS IN THE DAYTIME SHIFT AS WELL AS NIGHTTIME SHIFT AND SO WE COULD UNIFY AND COORDINATE OUR EFFORTS.

OFTENTIMES THERE MAY BE INDIVIDUALS THAT -- THAT A CALL FOR SERVICE CAME IN OR ONE POLICE OFFICER GOES OUT AND MAKES THE CALL FOR SERVICE AND THE OTHER POLICE OFFICER IS UNAWARE OF HAS CALL FOR SERVICE.

WE'RE TRYING TO UNIFY OUR RESPONSE AND TRY TO SHARE INFORMATION INTERNALLY.

THESE LIAISONS WILL INTERACT WITH THE MENTAL HEALTH COMMISSION AND THE CASE MANAGER AS WELL AS THE HOMELESS LIAISON.

WITH THAT BEING SAID, THE CITY OF REDONDO BEACH IS TAKING A VARIETY OF ACTIONS THAT ARE OF INTEREST, ONE BEING THE SHELTER, THAT POWER SHELTER IS CONSTRUCTED.

IT WAS CONSTRUCTED WHEN WAS IT UTILIZED AND CARES ACT FUNDING.

IT COMES AT VALUE OF 72,000 DOLLARS.

THEY CHOOSE THE LOCATION NEXT ON THE GALLERIA.

THAT LOCATION, THE SHELTER IS CURRENTLY ACTIVELY HOUSING PEOPLE RIGHT NOW.

THEY ONLY HAVE FUNDING AND AN AGREEMENT AND DIRECTION BY CITY COUNCIL TO -- TO HAVE THAT LOCATION APPROVE BY JUNE OF 2021.

WE DON'T KNOW HOW LONG THAT LOCATION IS GOING TO BE IN EXISTENCE OR IF IT IS GOING TO BE MOVED OR IF THE PROGRAM WILL CONTINUE.

AS OF RIGHT NOW, THAT'S THE SHELTER.

I'VE BEEN TOLD IT IS A SUCCESS.

BUT I HAVE NOT SEEN ANY NUMBERS ON IT PER SE.

HOMELESS COUNT, REDONDO BEACH HIRES AN OUTSIDE CONTRACTOR TO DO THEIR COUNT.

I THINK IT CAME OUT ABOUT A COST OF 20,000 DOLLARS.

THEY'RE REALLY INTERESTED TO KNOW HOW THEIR HOMELESS POPULATION WAS DIFFERENT FOLLOWING THE PILOT SHELTER AS WELL AS OTHER INITIATIVES THAT THEY'VE BEEN TAKING AND ALSO THEY WANTED TO REVISE -- THEY WANTED TO EXPLORE HOW THEIR COUNT MAY DIFFER FROM LOTS OF COUNTS BECAUSE THEY HAVE DIFFERENT DEFINITIONS.

AND THEN HOMELESS COURT HAS GOT ATTENTION.

IT IS AN OPPORTUNITY FOR HOMELESS INDIVIDUALS THAT MAY COMMIT CRIMES TO -- TO -- TO OFFER REPRIEVE TO DISMISS CERTAIN CRIMES AGAINST THEM AS LONG AS THEY FOLLOW UP WITH THE HOMELESS CASE MANAGER.

OVERALL IT IS A SUCCESSFUL PROGRAM.

THAT BEING SAID, IT IS A PRICEY PROGRAM.

IT IS FUNDED BY MEASURE H FUNDING GRANTED BY THE SOUTH BAY CITY COUNCIL OF GOVERNMENTS.

IT CAME OUT OF ANNUAL COSTS OF ABOUT 250,000 DOLLARS.

THAT PROGRAM IS -- IS FUNDED -- MOST OF THOSE COSTS GO TO THE PROSECUTION OF SERVICES.

THERE'S MORE TO BE TOLD ON THAT.

I WOULD REQUIRE IN-DEPTH STAFF ANALYSIS BECAUSE IT HAS TO DO

PROSECUTION AND THERE'S FUNDING QUESTIONS, ESPECIALLY SINCE THE CORE

IS ONLY FUNDED UNTIL JUNE AND WE'RE NOT AWARE IF THEY'RE GOING TO

CONTINUE FUNDING THAT AND THE PROGRAM WILL CONTINUE.

LEASE AGREEMENT FOR HOMELESS INDIVIDUALS.

THEY FOUND UNITS IN WILMINGTON AND THAT AREA AND THEY LEASE THOSE OUT TO HOMELESS INDIVIDUALS AND THEY FOLLOW-UP WITH CASE MANAGEMENT. IT IS SOMEWHAT CONTROVERSIAL.

I THINK CITY COUNCIL MEMBER FROM L.A. FROWNED ON IT A BIT IN THE MEDIA.

I THINK THEY'VE -- SO FAR HAVE GOTTEN FOUR -- THEY GOT FOUR UNITS APPROVED AND I'M NOT QUITE SURE HOW LONG THAT PROGRAM IS GOING TO LAST BUT I THINK IT CAME AT A COST OF 15,000.

DOUBLE-CHECK MY NUMBERS ON THAT.

SO WITH THAT BEING SAID, I WANTED TO INFORM THE COMMUNITY IT OF SUCCESS STORY AND COLLABORATION.

THIS IS INTERFAITH SERVICES, THERE WAS A CLIENT THAT WAS TRANSITIONAL AGED YOUTH, SO YOUNG TEEN AND HAD BEEN SLEEPING NEAR A GROCERY STORE IN MANHATTAN BEACH THROUGH HI COLLABORATION ALONG WITH LOCAL COMMUNITY GROUP, OUTREACH WORKER WAS ABLE TO CONNECT THE CLIENT AND LOCATE A SILVER LIVING PLACE WHERE THE CLIENT REQUESTED.

THE CLIENT AND OUTREACH WORKER WENT TO THE GROCERY STORE AND THE CLIENT WAS OFFERED A JOB ON THE SPOT.

THEY IMMEDIATELY WENT TO THE COMMUNITY GROUP.

THEY DONATED A WORK UNIFORM SO THE CLIENT COULD BECOME SELF-SUFFICIENT.

SAY THIS STORY BECAUSE HOMELESSNESS IS A -- IS A -- IT IS A COMPLEX ISSUE AS WE ALL KNOW AND IT REALLY REQUIRES ALL OF US TO PITCH IN.

IT REQUIRES OUR PATIENCE.

IT REQUIRES OUR COMPASSION.

IT REQUIRES OUR ABILITY TO UNITE AS A COMMUNITY TO ASSIST OUR NEIGHBORS.

SO WITH THAT BEING SAID, THEY SHOULD BE COMMENDED FOR THEIR EFFORTS

AND THEIR GENEROUS DONATIONS PARTICULARLY LUCIA AND LISA CRABTREE.

THEY'VE BEEN INSTRUMENTAL IN OUTREACH EFFORTS AND HE TRY TO WORK AS

CLOSELY AS POSSIBLE WITH OUR SERVICES TEAM TO PROVIDE REFERENCES AND

TO LET THEM KNOW OF ANYTHING ONGOING IN THE CITY.

WITH THAT BEING SAID, I WANTED TO HAVE CONCLUDING REMARKS.

THE CITY CONTINUES TO REMAIN DILIGENT.

STILL THINGS NEED TO BE DONE IN THE REGION IN TERMS OF THE MOU EFFORT AND WE PROVIDE OUARTER MY REPORTS TO THE SAY COUNCIL.

THERE'S A BEACH CITY REGIONAL RESPONSE REPORT THAT HARBOR FAITH
SERVICES IS WORKING ON TO COORDINATE OUR EFFORTS AS PACKAGED UNDER
THE MOU AND THAT'S BEING DRAFTED RIGHT NOW AS WELL AS TRAINING.

I TALKED ABOUT TRAINING FOR A WHILE.

I'M SORRY, IT IS DELAYED A COUPLE OF TIMES.

WITH EVERYTHING GOING ON AND THE BENEFIT SERVICES AS PART OF THE SUBCONTRACT IS WORKING ON THAT ALONG WITH THE COUNTY AND WE'RE TRYING TO MAKE SURE THAT THE TRAINING IS PROVIDED TO THE APPROPRIATE STAFF. SO WITH RESPECT TO REDONDO, THERE'S A LOT OF PARTICULARS WITH REDONDO WHO LIKELY REQUIRE AND COUNCIL REQUESTS FOR STAFF TO CONDUCT AN ANALYSIS.

WE'RE UNAWARE IF THEY HAVE INTEREST IN JOINING IN ON THE EFFORTS AT THIS POINT BUT IF WE RECEIVE CITY COUNCIL DIRECTION TO FURTHER EXPLORE IT, WE WOULD DEFINITELY DO SO.

WITH THAT SAID HOMELESS COURT IS A PROGRAM THAT THE CITY OF REDONDO BEACH LAUNCHED BECAUSE THEY HAD HOMELESS INDIVIDUALS THAT WERE COMMITTING CRIMES AND A SIGNIFICANT QUALITY OF LIFE NUISANCE ISSUES THAT THEY WERE TRYING TO ADDRESS.

GOING TO A SOBER LIVING FACILITY AND SO FORTH.

I PARTICIPATED TWICE IN THE HOMELESS COUNT.

I THINK IT WAS MOSTLY VOLUNTEERS THAT I SAW.

I SEE HERE THERE'S A PRICE HERE OF LIKE 28,321 DOLLARS.

THAT WAS THE CITY OF REDONDO BEACH.

THAT'S WHAT THEY'RE GOING TO BE PAYING.

VOLUNTEERS CAN CONDUCT A HOMELESS COUNT.

WE HAVE IN FRONT OF COUNCIL THE FINANCIAL STRUCTURES IN THE PENSION POLICY.

AT TONIGHT'S COUNCIL MEETING WILL BE THE FINAL REVIEW OF THE PRELIMINARY OFFERING STATEMENT.

THEN OUR CREDIT RATING FROM STANDARD AND POOR AND WE'LL BRING BACK
TO CITY COUNCIL THE APPROVAL OF THE POI AND HAS WILL BE IN APRIL 20TH
AND IN MID TO LATE MAY BOND PRICING AND CLOSING.

THESE FINANCING OPTIONS WERE PRESENTED, ALL THREE OPTIONS ON FEBRUARY 19, 2021.

AND TO GIVE A LITTLE BACKGROUND, WE HAVE CURRENTLY THREE GROUPS.

WE HAVE THE POLICE DEPARTMENT, FIRE DEPARTMENT, AND THE MISCELLANEOUS

GROUP.

CASE OPTION NUMBER ONE IS OUR BEST CASE WHICH IS OUR CURRENT

AMORTIZATION SCHEDULE WHICH CURRENTLY RUNS 24 YEARS FOR POLICE AND

FIRE AND 22 YEARS FOR MISCELLANEOUS.

THE POTENTIAL SAVINGS FROM THIS CASE WOULD BE 1.3 MILLION TO 4.6 MILLION OVER THE NEXT TEN YEARS AND THEN 23.8 MILLION OVER THE TERM OF THE AMORTIZATION PERIOD WHICH IS 24 YEARS FOR POLICE AND FIRE AND 22 YEARS FOR MISCELLANEOUS.

OPTION NUMBER TWO WOULD BE TO -- 22-YEAR AMORTIZATION PERIOD AND WE'LL END THE POLICE AND FIRE SAVING ON THE -- ON THE LATTER TWO YEARS TO MATURE THE SAME TIME AS THE MISCELLANEOUS AND ALIGN THE PLANS WITH ONE AMORTIZATION SCHEDULE AND THE POTENTIAL IT ANNUAL BUDGETARY

SAVINGS WOULD RANGE FROM 1.1 MILLION TO 4.4 MILLION OVER THE NEXT TEN YEARS IN ABOUT 34 MILLION OVER THE TERM.

OPTION THREE WOULD BE FOR -- FOR MATURITY TO END ON 2021 AND SHORTEN IT TO 20 YEARS.

IT REDUCES AMORTIZATION SCHEDULE FOR ALL PLANS.

IT DROPS TO 800,000 TO 4 MILLION OVER THE NEXT TEN YEARS AND THEN 35 OVER THE TERM OF THE AMORTIZATION.

OUR RECOMMENDATION TONIGHT AS WELL AS THE FINANCE HOUSE RULES AT THE FINANCE SUBCOMMITTEE WAS OPTION NUMBER TWO, KIND OF STILL GIVES US THAT FLEXIBILITY THAT WE'RE LOOKING FOR, SHORTENS THE TRAIL OF THE AMORTIZATION PERIOD FROM 24 YEARS TO 22 YEARS AND GIVES US THAT SAVINGS THAT WE'RE LOOKING FOR.

THIS KIND OF GIVES YOU A CHART TO SEE -- TO SEE THE DIFFERENT MATURITIES FOR THE BEST CASE ON THE FAR LEFT.

THIS IS FOR THE CURRENT, THIS IS OUR CURRENT AMORTIZATION PERIOD AND THEN THE MATURITY, THIS IS -- THIS IS THE ONE THAT -- THAT STAFF RECOMMENDS IS TO HAVE 22-YEAR AMORTIZATION AND THEN 2041 WHICH WOULD BE A 20-YEAR AMORTIZATION PERIOD.

THESE ARE THE DIFFERENT RATES.

AGAIN WE WANT TO REMIND THAT INTEREST RATES ARE FLEXIBLE.

THESE WERE PRESENTED.

POLICY IN PLACE SIGNALS RATING AGENCIES THAT THE CITY IS WELL MANAGED

AND FINANCIALLY DISCIPLINED.

AFTER THE PENSION OBLIGATION BOND PROCEEDS TO CALIPERS, BY THAT TIME THE CITY WILL HAVE NEW UNFUNDED LIABILITY IN THE FUTURE, TO OFF SET THAT THEY'RE CREATING A FUNDING PLAN IN ACCORDANCE WITH OUR POLICY AND AS WELL AS PUTTING FUNDS IN SECTION 113 FOR FUTURE RESERVES.

AROUND THE POLICY, WE RECOMMEND ALLOCATIONS OF POTENTIAL BUDGETARY SAVINGS.

ALLOCATING APPROXIMATELY 60 PERCENT TO FUTURE URL AND THESE FUND MAY BE DEPOSITED IN THE CITY'S TRUST UNTIL THE DECISION TO USE THE FUTURE PAYMENTS.

THEN TAKING 40 PERCENT OF THE CAPITAL, FOR CAPITAL IMPROVEMENTS, INFRASTRUCTURE NEEDS OR DEBT SERVICE AND FURTHER RECOMMENDATIONS FOR THE NEXT ITEM WHICH IS USING PART OF HAD 40 PERCENT SAVINGS IF FIRE STATION TO DEBT SERVICE FOR THE NEXT ITEM.

WITH THAT I'LL CONCLUDE FOR DISCUSSION.

TO PRESENT THE STAFF REPORT FOR THIS ITEM, I WOULD LIKE TO INTRODUCE SENIOR CIVIL ENGINEER MO ESTEPA.

GO AHEAD.

- >> SOMEBODY ELSE HAVE THEIR SCREEN SHARING?

OKAY.

I'M SENIOR CIVIL ENGINEER WITH THE PUBLIC WORKS DEPARTMENT.

TONIGHT I'M JOINED BY KELLY AND CHIEF AND CAPTAIN FROM THE MANHATTAN BEACH FIRE DEPARTMENT.

TONIGHT THE FINAL DESIGN TO REPLACE FIRE STATION NUMBER TWO AND THE RESOLUTION APPROVING THE ATTENTION TOISH TAX-EXEMPT CERTIFICATES FOR PARTICIPATION TO RUN THE CONSTRUCTION.

IT REPLACES OUTDATED FACILITY THAT IS INADEQUATE FOR OPERATING AND

RUNNING A MODERN FIRE DEPARTMENT.

THE EXISTING FACILITY, WE KNOW THAT THE FACILITY IS OVER 66 YEARS OLD.

IT IS AROUND 3300 SQUARE FEET AND IT HAS REACHED THE END OF ITS USEFUL LIFE.

AN INDEPENDENT ARCHITECTURAL FIRM IDENTIFIED STATION NUMBER WHO WITH A NUMBER OF DEFICIENCIES.

A LITTLE HISTORY, SEPTEMBER 2017 COUNCIL PRIORITIZED STATION TWO FOR COMPLETE REPLACEMENT AND IN MAY 2018 COUNCIL FUNDED AND AWARDED A CONTRACT TO WAC ARCHITECTS FOR DESIGN AND CONSTRUCTION SUPPORT AND THEN IN OCTOBER AND DECEMBER OF 2018 THE CITY HELD HAD PUBLIC MEETINGS TO -- TO RECEIVE FEEDBACK ON THE PROJECT.

IN DECEMBER OF 2018 COUNCIL APPROVED THE SITE AND FLOOR PLANS AND PROVIDED DIRECTION ON THE EXTERIOR OF THE BUILDING AND AUGUST 2019 IT WAS PRESENTED TO THE PLANNING COMMISSION FOR REVIEW.

THE CONSTRUCTION WAS PREPARED AND SUBMITTED FOR REVIEW AND SUBSEQUENTLY RECEIVED APPROVAL FROM THE -- FROM THE CITY BUILDING SAFETY DEPARTMENT IN JANUARY OF 2021.

MOST NOTABLE DEFICIENCY THAT WAS IDENTIFIED IN THE FACILITY WAS THE EXISTING SYSTEM, THE BUILDING'S ABILITY TO RESIST EARTHQUAKES.

THIS CAN COMPROMISE THE FACILITY DURING SEISMIC EVENT WHICH WOULD MAKE IT INADEQUATE TO FUNCTION AS AN ESSENTIAL FACILITY.

NOW LEARN OTHER DEFICIENCIES THAT WERE IDENTIFIED STATION A FOUND IN THE APPARATUS AND SHOP AREA AND THE ADMINISTRATIVE OFFICES AND THE REST ROOMS AND LOCKER AREAS AND VENTILATION SYSTEM AND THE TURNOUT

ROOM.

IF WE CONSIDER THE APPARATUS, IT IS CURRENTLY TOO SMALL TO ACCOMMODATE FIRE AGENTS.

YOU SEE CLEARANCE AROUND THE FIRE ENGINE WHEN IT IS PARKED INSIDE THE STATION.

ALL FIRE ENGINES THAT ARE HOUSED IN STATION TWO MUST BE CUSTOM BUILT AND THEY MUST BE CUSTOM BUILT AT A SIZE SMALLER THAN YOU WOULD EXPECT A TYPICAL FIRE ENGINE TO BE CONSTRUCTED AT.

IT LIMIT ARES THE CONFIGURATION OF THE APPARATUS.

TWO PLEDGES ARE USED IN THE FIRE.

AND NOW IN ADDITION THE FIRE ENGINE MAINTENANCE CAN'T BE PERFORMED IN THE APPARATUS AND MUST BE PERFORMED OUTSIDE.

THE REASON THIS IS A CONCERN IS THE ABILITY TO CONTAIN THE POTENTIALLY CARCINOGENIC PARTICLES ON THE APPARATUS AND IT COULD BLOCK PEDESTRIAN SIDEWALK IN FRONT OF THE STATION.

THE DEFICIENCY AREA WAS LOCATED IN THE SHOP AREA.

THIS LACKS A DEDICATED SHOP AREA.

GOING TOO PAST, TO MAINTAIN ITS TOOLS.

NOW THE EXISTING SHOP AREA IS LOCATED IN THE NARROW CORRIDOR THAT IS ASMALL.

IT HAS FIRE EQUIPMENT AND SUPPLIES IF THE STATION AND WATER LOCATED IN THE CABINETS THERE.

BECAUSE IT IS A SPACE CONSTRAINED AREA AND A LOT OF TIMES FIREFIGHTERS
WILL SPEND EXTENDED AMOUNT OF TIME IT MAINTAIN THEIR TOOLS.

EACH FIREFIGHTER HAS A NUMBER OF ADMINISTRATIVE TASKS WHEN THEY'RE

NOT ON CALLS.

THIS IS THREE FIREFIGHTERS ON SHIFT, BUT YOU SEE THERE'S ONLY SPACE FOR TWO FIREFIGHTERS TO PERFORM ANY OF THEIR ADMINISTRATIVE DUTIES AT ONE TIME.

NOW THE EXISTING RESTROOM AND CHANGING AREAS ARE NOT PRIVATE.

THEY HAVE NO SEPARATE FACILITIES.

AND THERE ARE BUILDING ELEMENTS THAT ARE NOT ADA COMPLIANT, INCLUDING ENTRANCES TO THE BUILDINGS AND THE SHOWER STALLS.

NOW THERE ARE A NUMBER OF KEY FEATURES IN MODERN FIRE STATIONS WHICH PROTECT THE LONG-TERM HEALTH OF THE FIREFIGHTERS.

IT INCLUDES VENTILATION SYSTEM AND PRESENCE OF EXTRACTOR.

NOW THE FIRE STATION THERE SHOULD BE A SEPARATION OF THE ATMOSPHERE PRESENT IN THE APPARATUS AND IN THE LIVING QUARTERS.

THE MIXING OF THOSE TWO AREAS WILL PROLONG THE FIREFIGHTERS EXPOSURE AND CARCINOGENIC PARTICLES.

THOSE PARTICLES WILL COLLECT ON THE TURNOUT AND THE PERSONAL PROTECTIVE EQUIPMENT.

THOSE ARE A SPECIAL DEVICE KNOWN AS EXTRACTOR.

STATION TWO BECAUSE IT IS CONSTRAINED DOES NOT HAVE AN EXTRACTOR SO FIREFIGHTERS MUST USE EXTRACTOR AT STATION ONE TO CLEAN THEIR GEAR. SO IN CONTRAST, A REPLACING FIRE STATION NUMBER TWO WILL ADDRESS THE DEFICIENCIES PREVIOUSLY IDENTIFIED WHICH WILL PREPARE NOT ONLY THE MANHATTAN BEACH FIRE DEPARTMENT BUT ALSO THE CITY FOR THE NEXT 50 YEARS.

NOW THE NEW STATION WILL MEET MODERN BUILDING STANDARDS.

HAVE AN APPARATUS THAT WILL BE ADEQUATELY SIZED FOR MODERN FIRE FIGHTING EQUIPMENT.

THEY'LL FIT TWO ENGINES AND PARAMEDIC TRUCK.

THERE WILL BE A DEDICATED SHOP AREA.

THERE WILL BE DEDICATED ADMINISTRATIVE AREAS TO ACCOMMODATE THE FIREFIGHTERS.

THERE WILL BE PRIVATE CHANGING ROOMS.

THERE WILL BE INDIVIDUAL DORMS FOR EACH OF THE FIREFIGHTERS.

THERE WILL BE SEPARATION OF THE ATMOSPHERE BETWEEN THE APPARATUS SHOWN HERE IN PINK AND THE LIVING QUARTERS SHOWN HERE IN BLUE SEPARATED BY THE VESTIBULE.

THERE WILL BE AN EXTRACTOR AT STATION TWO.

NOW IN ADDITION TO THE WORK, OUTSIDE IMPROVEMENTS, ONE REPLACES THE BEACON OR THE PREEMPTION DEVICE.

CURRENTLY THERE'S A FLASHING BEACON PRESENT THAT PULLS AND THAT SET UP IS OUTDATED AND WOULD BE MODERNIZED.

CURRENTLY THAT WOULD BE FLASHING WHETHER OR NOT THIS IS A CALL, ACTIVE CALL OR NOT.

THE WAY THE FEW SYSTEM WOULD WORK IS THAT THE PREEMPTION DEVICE WOULD BE ACTIVATED.

IT WOULD FLASH AND GIVE THE ATTENTION TO THE MOTORIST SO THEY CAN STOP AND SLOW DOWN AND PROVIDE ACCESS FOR THE FIRE ENGINES TO EXIT THE STATION AND GO IN WHICHEVER DIRECTION IT NEEDS TO GO AND AFTER IT LEAVES THE PREEMPTION DEVICE WOULD BE TURNED OFF.

NOW ONE OF THE QUALITY CONTROLS AND CONTRACT COMPLIANCE MEASURES THAT

THE CITY PLANS TO DO IS TO INSURE THE QUALITY AND CONSTRUCTION OF THE PROJECT AND THE CONTRACTOR'S COMPLIANCE WITH THE PROJECT'S SPECIFICATIONS.

THE CITY WILL PROCURE SERVICES FOR MATERIAL TESTING DURING
CONSTRUCTION AS WELL AS PROCURE FULL-TIME CONSTRUCTION OVERSIGHT.
WHEN STATION TWO IS CONSTRUCTED WHERE THE FIREFIGHTERS GO.
ONE OF THE CANDIDATES IDENTIFIED WOULD BE CONSTRUCT A TEMPORARY FIRE
STATION LOCATED AT 1501 NORTH PAT AVENUE WHICH IS ON MBUSB SCHOOL

THIS SITE WAS PREVIOUSLY USED DURING THE CONSTRUCTION OF FIRE STATION ONE AND THE POLICE FACILITY AT THE CIVIC CENTER.

IT IS NO LONGER INHABITABLE.

DISTRICT PROPERTY.

AND THIS SITE BECAUSE IT IS A QUARTER MILE AWAY FROM THE EXISTING STATION, THE FIRE DEPARTMENT CAN MAINTAIN ITS FIVE MINUTE RESPONSE TIME ON EMERGENCY CALLS.

SO THIS IS AN EXAMPLE OF WHAT THE STATION, THE TEMPORARY STATION COULD LOOK LIKE, EFFECTIVELY AS A MODULAR, MODULAR TRAILER WHICH WOULD HOUSE THE THREE FIREFIGHTERS WITH ONE FIRE ENGINE BEING PARKED ADJACENT TO IT OUTSIDE.

WE TALK ABOUT THE COST OF THE STATION.

THE COST FOR FIRE STATION NUMBER TWO, THE BUILDING CONSTRUCTION AND DEMOLITION ON THE SITE IS ON THE ORDER OF 7.35 MILLION DOLLARS.

NOW IF WE COMPARE THAT TO THE FIGURE ESTIMATED IN -- IN 20 -- 2017

THAT WAS -- THAT WAS ESTIMATED TO BE -- I'LL PULL THAT UP.

ON THE ORDINARY OF SEVEN --

>> 87.

>> 7.78 MILLION DOLLARS.

THE CURRENT ESTIMATE IS NEARLY HALF A MILLION LESS THAN ORIGINALLY ESTIMATED.

THE PREEMPTION DEVICE IS 125,000.

CONSTRUCTION MATERIAL AND MATERIAL TESTING WHICH AMOUNTS TO 1 PERCENT OF THE CONTRACT IS -- IS ABOUT 100,000 DOLLARS.

CONSTRUCTION OVERSIGHT WHICH AMOUNTS TO ABOUT 5.8 PERCENT OF THE TOTAL CONTRACT COST IS 550,000 DOLLARS.

THE TEMPORARY FIRE STATION WILL COME IN AT 275,000.

IF WE ADD A CONSTRUCTION CONTINGENCY OF ABOUT 16 PERCENT THAT -- FOR ANY UNKNOWN SCENARIOS THAT WOULD BE 1.1 MILLION.

THE TOTAL COST OF THE ENTIRE PROJECT DEMOLISH THE EXISTING STATION AND CONSTRUCT THE NEW STATION AND PROVIDE TEMPORARY FACILITIES DURING CONSTRUCTION IS 9.5 MILLION DOLLARS.

FOR THE TIMELINE, ESTIMATED TIMELINE AND FOR THE NEXT STEP PROVIDED WE CAN PROCEED WITH THIS PROJECT.

THE PLAN WOULD BE TO FINALIZE THE PLAN AND PREPARE FOR BIDS.

AND THEN COUNTY AUTHORIZE FINANCING AND AWARD THE PROJECT IN THE MIDDLE OF THE SUMMER AND FUNDING BY THE END OF THE SUMMER.

WE ANTICIPATE GIVING THEM LIST TO PROCEED BEFORE PRECONSTRUCTION REQUIREMENTS AND PULLING THE PERMITS IN SEPTEMBER SO THAT GROUNDBREAKING CAN HAPPEN AS EARLY AS OCTOBER OF 2021.

THIS PROJECT WILL TAKE APPROXIMATELY 21 MONTHS TO COMPLETE, SO IT IS ANTICIPATED THAT CONSTRUCTION WILL MOVE INTO THE NEW STATION AND

COULD HAPPEN AROUND JULY OF 2023.

STAFF IS RECOMMENDING THAT CITY COUNCIL ADOPT A RESOLUTION APPROVING
THE INTENTION CERTIFICATES OF PARTICIPATION TO FUND THE CONSTRUCTION
PROJECT TO REPLACE FIRE STATION NUMBER TWO.

IT WAS REALLY GOOD TO GET INSIDE AND WE SEE THE NEED TO HAVE IT REPLACED.
