#### Task Force:

I would prefer you revise Appendix 5 to address the topics in a more general fashion. I realize this is only an "aspirational" document, but as can be derived from recent social media postings, often something meant for "discussion purposes only" takes on a different life of its own.

Similarly, were the Council to approve discussion of such a list, it conveys an acquiescence to all enumerated principles. One can say "we're just talking" until you are blue in the face, but public perception often takes a different turn, and perception often becomes reality.

As examples of a more generalized approach, in respect to inclusionary housing, you could just reference "Review local inclusionary housing policies or practices in respect to racial exclusion issues" instead of these specifics (and if you are going to list such, I would recommend you add the issue of the number of days homes are vacant either due to exorbitant pricing or not intention of occupancy).

Instead of this:

4. Facilitate and encourage development of affordable housing units and attendant entitlements within the City.5. Incentivize City property owners to dedicate rental units and ADUs/JADUs for use as affordable housing.

In respect to educational assistance and incentives, I would prefer a description more to "Explore educational scholarship incentives for African American studies in general, and the expansion of information on the racial history of Manhattan Beach and the South Bay in specifics, for an appropriate (limited) amount of time.

Instead of this:

9. Sponsor an annual scholarship of \$1,500 to high school students who will study African American history in college, to be administered by the Task Force.
10.Sponsor a grant of \$1,000, administered by the Task Force, to graduate students who pursue the study of the racial history of Manhattan Beach.

I'm not necessarily saying that these shouldn't be final recommendations in the event the council expands your current brief.

#### Dear BBTF:

I am writing for several reasons: to express both my admiration for the work done by each and every member of the Bruce's Beach Task Force, my support for the apology proposed by the Task Force, and my concern regarding the optics, and impact, of the public display of discord among the members.

On the positive side, the level of thought and discourse I have heard in the recorded meetings is quite impressive. The issues you are addressing are difficult, namely wrongs that are centuries, if not millenia, in the making. Like anything important in life, decisions regarding what to do to address past injustices are neither simple nor quick. And the fact that the Task Force has made the progress it has in its relatively short existence is commendable.

Regarding the apology, an apology by the City will go a long way to helping us grow as a more welcoming and diverse community. As the Northeastern School of Law's Civil Rights and Restorative Justice Project notes, "apologies can be meaningful moments to victims of historical wrongs and an important step toward validating an unpleasant moment in history." Apologies are not signs of weakness, but rather recognition. The City of Glendale issued an apology last year; the City of Manhattan Beach should do the same.

Finally, it is unfortunate that all the good that has been accomplished by the Task Force is being derailed by the actions of its leadership. It should come as no surprise that certain members of the Task Force, such as Allison Hales, would feel passionately about the topics being discussed. And the fact she is assertive in her positions is not a negative; if race relations were an easy, polite topic we would have been living in a post-racial society decades ago. But we're not. Everyone who signed up for the Task Force should have known that their discussions would be hard, and personal, and pointed.

The leaders of the Task Force have enough experience to know that disputes within a group are best resolved within that group. Yet they decided, for reasons that are not entirely clear, to directly attack Ms. Hales both by discussing Task Force issues at a public City Council meeting and by making statements to be published in the echo chambers of NextDoor and Patch.

I hope the Task Force can get back on task, reinstate Ms. Hales, and move forward with helping make a positive change in our community.

Dear Manhattan Beach City Council Members,

I am writing to express my concerns about the City's long history of racism relating to Bruce's Beach – from the City's tacit approval of intimidation and threats by the KKK in the 1920s against the Bruces and other Black members of the Los Angeles area community, to the forced taking of the property from Charles and Willa Bruce in 1924, to ignoring and continually whitewashing the true history of what happened in our beloved beachside community with regard to Bruce's Beach. It is long past time for the City to meaningfully accept responsibility for its actions and inactions over the years, to issue a heartfelt, meaningful, and direct apology to the descendants to the Bruces and other Black members of the Los Angeles area community adversely impacted by the City's conduct, and to meaningfully educate current residents of the South Bay about what really transpired. The City's past conduct not only was racist and discriminatory but also deprived Charles and Willa Bruce and their descendants from amassing generational wealth associated with property ownership in a thriving and popular beachside community. Such conduct cannot stand.

And while each of the above-described actions are necessary to accept responsibility and begin to heal our community, much more can and must be done. LA County Supervisor, Janice Hahn, has called for consideration of having the portion of the property that is owned by LA County to be repurposed to tell the true story of Bruce's Beach and even returning the property to the descendants of Charles and Willa Bruce. The City can and must follow the lead of Supervisor Hahn and the City of Los Angeles by actively working to bring about these changes in relation to the remaining portion of the property still controlled by the City. And if the City is unwilling to return the land to the descendants of the Bruces, at the very least, the City should join with the City of Los Angeles in erecting a substantial educational outpost on the site to tell the true history of Bruce's Beach and allow the descendants of the Bruces to use the property to begin replacing the generational wealth opportunities that were taken from them by the City. In so doing, the City should commit to working directly and collaboratively with the descendants of the Bruces to ensure their voices are heard and properly amplified.

By doing so, the City can finally help put an end to this long and sad chapter in the City's history. On the other hand, if the City Council considers anything less than the rational and morally correct actions under consideration by the Los Angeles Board of Supervisors or if the City is unwilling to work collaboratively with the descendants of the Bruces towards a meaningful resolution, the City's sad legacy will only continue.

The current City Council has the opportunity not only to finally right a horrible wrong and remove a deep and longstanding stain on our community but also to become part of the solution going forward. I understand that building consensus around some of the options being discussed will not be easy, but that's what leadership and being a leader is all about. As members of the Manhattan Beach City Council, each of you asked the citizens of this community for your vote and to give you the opportunity to lead. The ball is now in your court and history is watching. What will your legacy be?
