The State updated tier assignments on March 30, under its Blueprint for a Safer Economy – the criteria used to loosen and tighten regulations on activities. The County met the threshold to move from Tier Two (Red) Status, a "Substantial" risk level where some non-essential indoor business operations are closed, to Tier Three (Orange) Status. In this "Moderate" risk level, some indoor business operations can open with modifications. According to the State's website, L.A. County continues to improve its standing reflecting 3.8 new COVID-19 cases per day (per 100K), decreasing from 4.8, with an adjusted case rate for tier assignment equaling 3.1. The County's overall test positivity rate dropped from 1.8% to 1.5%. The health equity metric also reduced from 2.5% to 2.1%. A revised Los Angeles County Health Officer Order will go into effect on Monday, April 5 at
