WE HAVE TWEAKS ON THE FISCAL SIDE, BUT OVERALL, THE PROJECTS IN THE PLAN REMAIN THE SAME.

WITH THAT I TURN IT OVER TO THE CITY ENGINEER.

107 PROJECTS CARRIED FORWARD.

WE DID NOT ADD ANY NEW PROJECTS DUE TO STAFFING AND RESOURCE ISSUES.

AND THE FIVE-YEAR FUNDING PLAN AT THAT TIME THAT WAS PRESENTED WAS \$145,122,239.

WE PRESENTED THAT LIST ON APRIL 22ND.

ON TONIGHT'S RECOMMENDED ACTION BEFORE YOU IS THE PROPOSED LIST. THE SAME 707 PROJECTS CARRIED FORWARD.

NO NEW PROJECTS HAVE BEEN ADDED.

HOWEVER, BETWEEN MAY 26 AND APRIL 29, THEY WENT THROUGH THE FUNDING THAT WAS AVAILABLE TO US AND RECOMMENDED TO THE PUBLIC WORKS TEAM THAT WE NEEDED TO REDUCE OUR FIVE YEAR C.I.P. BUDGET DUE TO THE REVENUE ISSUES.

THE NEW PLAN IS REDUCED BY 100,000 PLANS, SO THE PLAN IS \$144,092,239.

I WANT TO MAKE ANOTHER COMMENT.

THERE MAY BE FURTHER DISCUSSIONS LATER, PROBABLY IN THE NEXT MEETING OR SUBSEQUENT COUNCIL MEETINGS, JUST SPECIFICALLY FOCUS ON THAT.

WE'LL CONTINUE WITH THE SLIDE ON THAT PRESENTATION TO JUST HIGHLIGHT THE FUNDING REQUEST FROM THE SCHOOL DISTRICT. MOST SLIDES YOU HAVE SEEN.

PLEASE TELL ME TO SLOW DOWN.

THE C.I.P. PROGRAM CONSISTS OF THESE CATEGORIES OF PROJECTS, WATER, WASTEWATER, PROJECTS, BUILDINGS AND STREET PROJECTS AND OTHER RIGHT-OF-WAY PROJECTS.

A SNAPSHOT OF THE C.I.P. PRESENTED TO YOU, THE TOTAL 5-YEAR IS LISTED HERE.

FOR 2021-22 THE UPCOMING FISCAL YEAR, THE NEW APPROPRIATION IS 14 MILLION \$620,000 THAT HAS NOT CHANGED FROM APRIL 6TH.

AND THE PREVIOUS APPROPRIATED IS CARRIED FORWARD, THAT'S THE 88.

IN TERMS OF THE PIE CHART, THIS IS A REAL VISUAL ON WHERE THE MONEY IS GOING.

THE REMAINING IN THE OUTER YEARS FOR FUTURE APPROPRIATIONS.

THE WATER FUND, THE WASTEWATER FUND AND THE STREETS AND SIDEWALKS AND RIGHT-OF-WAY PROJECTS.

AND THE FUNDING SOURCES, IT IS CLEAR YOU HAVE C.I.P. FUNDS THAT ARE FUNDED BY T.O.T. AND PARKING CITATIONS AND METERS AND GRANTS AND TRUST FUNDS.

THEN YOU HAVE THE ENTERPRISE FUNDS WHICH THE FUND ARE SOLELY USED FOR THESE PURPOSES AND CANNOT BE USED FOR ANYTHING ELSE. WASTEWATER, STORM WATER.

MANY HAVE LOCAL RETURNS AND STREET FUNDED PROJECT AND

PROPOSITION C ARE ALSO LIMITED IN ITS USE AND CAN BASICALLY BE USED ON THOSE PROJECTS.

STATE PIER LOT FUNDS ARE TYPICALLY ALLOCATED FOR IMPROVEMENTS AT THE PIER.

GOING FORWARD WITH THE CATEGORIES, THE STREET SIDEWALKS AND RIGHT-OF-WAY, WE HAVE 28 UNIT PROJECTS.

A PRICE OF OVER \$42 MILLION.

THESE ARE THE FUNDING SOURCES.

IT INCLUDES STREET RESURFACING, AND OTHER PROJECTS.

THIS IS A BREAKDOWN OF THE PROJECTS I LISTED.

SOME HIGHLIGHTS ARE THE SEAL WHICH IS A POPULAR PROJECT AMONG RESIDENTS.

THIS YEAR WE WILL DO A PORTION OF THE KEY SECTION AND THE FAN SECTION.

THEN WE HAVE PROJECTS LIKE THE ADVANCED SIGNAL SYSTEM AND PROCEEDING WITH CONSTRUCTION ANY DAY NOW AND STARTING WITH THE AVIATION IN ARTESIA.

CONTRACTS ARE EXECUTED.

WE'RE CLOSE TO GETTING THAT PROJECT UNDER WAY AS WELL.

AS YOU KNOW THE BRIDGE WIDENING IS STILL UNDER CONSTRUCTION.

A LOT OF ACTIVITIES AND HOPING IT GETS COMPLETED.

WATER FUND 18-UNIT PROJECT AND THE MAIN HIGHLIGHT BEING THE RESERVOIR PROJECT.

AND THE TANK IS GETTING CLOSE TO BEING PAINTED AND COMPLETED IN A FEW MONTHS HERE.

THESE ARE DETAILED ON THE WATERFRONT PROJECTS.

IT IS VERY IMPORTANT FOR US TO CONTINUE WITH THE ANNUAL PIPELINE REPLACEMENTS.

WE ALSO HAVE PUMP STATIONS THAT ARE GOING TO BE UPGRADED.

SO THEY'RE IN THE WORKS.

STORM WATER PROJECT. WE HAVE 15-UNIT PROJECTS AND MNPDS AND OTHER ENHANCED WATERSHED MANAGEMENT PROJECT REQUIREMENTS THAT WE NEED TO MEET.

SO UNDER HERE WE HAVE THE CAPITAL BMPS ARE BEST MANAGEMENT PROJECTS.

WE HAVE A 2023 DEADLINE TO MEET THE DAILY REQUIREMENTS.

THESE ARE PROJECTS TO ENSURE THAT WE MEET THE NPDS PERMIT REQUIREMENTS.

AND ALSO, YOU KNOW, AS YOU MAY HAVE RECALLED A COUPLE OF YEARS BACK WE HAD SINKHOLES ON ARTESIA BOULEVARD.

IT IS IMPORTANT THAT WE CONTINUE TO DO ANNUAL STORM-RAIN REPAIRS AND REHAB PROJECTS SO WE DON'T HAVE THOSE SINKHOLES. WASTEWATER FUND.

WE HAVE 13 UNIT PROJECTS.

BIG PRICE TAG BECAUSE WE HAVE SEVERAL STATIONS THAT ARE UPGRADED ALONG WITH OUR SEWER PIPE REPLACEMENT.

PARKING FUND, WE REHABBED LOT FOUR WHICH IS AT THE NORTHEAST

CORNER OF HIGHLAND AND ROSE.

WE'RE DOING URGENT REPAIRS BECAUSE OF THE SAVINGS THAT THE CONTRACTOR AND CITY WORKED OUT.

WE HAD CHANNELED THAT TO URGENT REPAIRS.

WE WILL COME BACK WITH MORE REPAIRS PROBABLY LATER IT YEAR FOR COUNCIL CONSIDERATION AND AWARD.

THE STATE PIER PROJECT RECENTLY IN FEBRUARY THE COUNCIL IT APPROVE MOVING FORWARD WITH THE FINAL DESIGN AND CONSTRUCTION OF THE PIER RAILING REPLACEMENT.

WE'RE MAKING HEADWAY THERE.

THEN THE C.I.P. HAS 29 UNIT PROJECTS.

THE MAIN PROJECT HERE BEING FIRE STATION TWO REPLACEMENT.

WE ALSO HAVE THE CITY HALL HVAC REPLACEMENT PROJECT, ANOTHER BIG PROJECT.

WE'RE MAKING GOOD HEADWAY ON THE CAMERAS FOR THE CITY BUILDINGS. WE HAVE OUR CONSULTANT FINALIZING THE REPORT ON WHERE THE

CAMERAS NEED TO GO.

WE ALSO HAVE THE SCOUT COMMUNITY CENTER THAT WE HAVE FUNDED, THE CITY'S CONTRIBUTION AND WE'RE EXCITED TO SEE THE FUNDING CONTINUING.

WE ANTICIPATE THAT WILL BE THE ENTITLEMENT AND PLAN CHECK PROJECT COMING UP.

WE'RE POSITIVE AND EXCITED ABOUT SEEING THAT PROJECT COME THROUGH.

THEN WE HAVE THE PLAYGROUND REPLACEMENT.

THAT'S ANOTHER BIG PROJECT THAT COMES OUR WAY IN THE C.I.P. FUND CATEGORY.

AGAIN, THIS IS IMPORTANT ALLOCATION OF RESOURCES.

WE NEED TO RECOGNIZE THAT WE HAVE THESE ISSUES AND ONE OF THE SEVEN FIGURES HERE, STICK FIGURES THAT WORK ON ALL OF THE PROJECTS AND I WISH I WAS A STICK FIGURE.

[LAUGHTER].

ESSENTIALLY THEY'RE IMPORTANT, THE CITY COUNCIL MADE CONCERTED EFFORT FOR GENERAL PROJECTS AND FUNDED FULL ENGINEER POSITIONS AND THE COMMITMENT THERE WOULD THEY WON'T HIT THE GENERAL FUND IN TERMS OF FUNDING THOSE ENGINEERS.

THESE WERE ALLOCATED IN THE FOLLOWING MANNER THAT TWO OF THE ENGINEERS WOULD BE WORKING ON JUST UTILITY PROJECTS IN OUR VERY IMPORTANT INFRASTRUCTURE, WATER, SEWER, STORM.

AS PART OF THE FOUR ENGINEERS THAT WAS ADDED TO OUR -- ALLOCATED TO THESE.

ONE WAS ALLOCATED TO ALL OF THE LOCAL RETURNS WHICH ARE MAINLY STREET PROJECTS AND PIER PROJECTS AND THOSE THINGS AND ONE ADDITIONAL ENGINEER WAS ALLOCATED FOR C.I.P. FUNDS.

IN THIS CURRENT FISCAL YEAR AS WE APPROACH THE UPCOMING FISCAL YEAR THESE ARE ALL OF THE PROJECTS WE COMPLETE AND 17 WE INTEND TO COMPLETE BY JUNE 30TH.

DESPITE THE PANDEMIC AND THE CHALLENGES THAT COME WITH IT, WE'RE PROUD OF THE LIST OF WHAT WE GOT ACCOMPLISHED THIS PAST 12 MONTHS.

NOW TO TOUCH ON THE MBUSB FUNDING REQUEST, IT CAME IN ABOUT THREE WEEKS OR SO AGO.

ESSENTIALLY THEY LISTED PRIORITY ONE AS 346,500 FOR PLAYGROUNDS.

AND FULL ZONE SURFACE IMPROVEMENT AND AN ELEMENTARY SCHOOL.

PRIORITY TWO, ADDITIONAL 350,000 OR SO FOR POOL DECK REPAIRS.

PRIORITY THREE BEING MORE WORK ON THE POOL AREA WHICH IS THE POOL PAST THE RESURFACING.

PRIORITY FOUR IS APPROXIMATELY A QUARTER MILLION FOR TENNIS COURT IMPROVEMENTS.

AND SO THESE WERE THE LIST THAT WAS PROVIDED BY THE SCHOOL DISTRICT.

ALSO WANTED TO IDENTIFY THAT THE -- IN FISCAL YEAR 2019-20, THE CITY CONTRIBUTED \$250,000 FOR SCHOOL PROJECT FUNDING.

WE DID RECEIVE AN INVOICE FROM THE SCHOOL EARLY THIS YEAR. THEY USED UP ALMOST ALL OF THE FUNDS.

I THINK ABOUT \$243,000 WAS USED AND WE IT PAY THAT INVOICE.

SO THAT HAS BEEN UTILIZED.

SO THEY HAVE A NEW REQUEST.

I BELIEVE DONNA LYNN THE DEPUTY SUPERINTENDENT IS ALSO AVAILABLE AT THIS MEETING FOR HAVE ANY QUESTIONS.

SHE MAY HAVE COMMENTS.

I THINK SHE'S MORE PREPARED FOR ANY QUESTIONS THAT MAY ARISE. WITH THAT I MOVE ALONG.

THIS IS THE SHEET THAT IS PART OF THE FIVE-YEAR SUMMARY C.I.P. SHEETS.

AS YOU CAN SEE, WE HAVE IDENTIFIED -- AGAIN, WE KEPT ALL OF THE SAME PROJECTS.

WE HAVE NOT ADDED ANY NEW PROJECTS.

BECAUSE WE'RE ADDING A NEW COLUMN, IT IS A ROLLING FIVE-YEAR AND WE HAVE TO ADD A NEW COLUMN.

YOU'LL SEE THE RED FUND WHERE WE ADDED THE FUNDS.

AND ALSO IF THERE'S ANY CHANGES IN ANY OF THE FUNDING WITHIN THE CURRENT PROJECTS, WE ALSO HIGHLIGHTED THAT.

WE ALLOCATE 50,000 EACH YEAR FOR PROJECTS THAT COME UP.

THEN WE HAVE THE FACILITIES IMPROVEMENTS PROJECT.

I WANT TO HIGHLIGHT, THIS IS WHERE THE \$200,000 REDUCTION CAME ABOUT BETWEEN APRIL 6TH AND TODAY'S PRESENTATION.

BASICALLY WE HAD TO REDUCE THE AMOUNT ROUGHLY BY ABOUT \$50,000 FOR FOUR OF THE FISCAL YEARS, ADDING UP TO \$250,000 REDUCTION.

THIS REALLY GOES TO PROJECTS LIKE THE SECURITY CAMERA, THE YOU KNOW REPLACEMENT AT VARIOUS DIFFERENT CITY FACILITIES.

ADA ACCESS IMPROVEMENT AT DIFFERENT REST ROOMS.

THIS IS WHERE THEY TWO.

AGAIN WITH THE REVENUE SHORTFALL, AT ONE TIME YOU COULD GO BACK

TO 2018.

THIS LINE WAS IN THE RANGE OF \$800,000.

OR \$830,000.

DUE TO OTHER LINE ITEMS, THIS LINE IS BEING REDUCED AND CONTINUES TO BE REDUCED BY \$200,000.

THIS ITEM IS AN IMPORTANT ITEM.

WE HAVE OVER 45 CITY FACILITIES THROUGHOUT THE CITY AND MANY OF THEM NEED MAINTENANCE, IMPROVEMENTS AND THE FUNDING COMES FROM A LOT OF THE BIG DOLLAR ITEMS, LIKE I MENTIONED, LIKE THE HVAC REPLACEMENT AND STUFF LIKE THAT COME FROM THIS LINE ITEM. SOMETHING TO KEEP IN MIND AS WE MOVE FORWARD.

AGAIN, CONTINUING TO SHOW YOU SOME OF THE EXAMPLES OF THE CHANGES THAT WERE MADE TO THE FIVE-YEAR C.I.P., WE HAVE THE ADDITION OF THE OUTER YEAR.

WE ALSO REALLOCATED FUNDS.

I'LL PUT IT IN THE RIGHT CATEGORY JUST BECAUSE OF RESOURCES. WE MAKE SURE THAT WE ALLOCATE THE FUNDS IN THE YEAR THAT WE HAVE A GOOD CHANCE OF ACTUALLY GETTING TO IT AND WORKING ON IT. WITH THAT, THOSE COME DOWN TO THOSE LISTS.

NOW WE HAVE THE MAP THAT KIND OF CAPTURES WHAT YOU SAW IN THE SHEETS IN TERMS OF THE ACTIVE PROJECTS.

WE METHOD IT OUT, HERE IT IS HELPFUL BECAUSE OF ANYONE THAT HAS A QUESTION, WE COULD QUICKLY ANSWER THE QUESTION AS WELL AS WHERE THE PROJECTS ARE AT.

IT IS THE YEAR THAT THEY'RE FUNDED AND TWO ADDITIONAL YEARS FOR OTHER PROJECTS THAT ARE HELPFUL IN TERMS OF DEALING WITH UTILITIES AND THE OUTSIDE AGENCIES IN TERMS OF PLANNING FOR PROJECTS AND MAKING SURE WE HAVE A STREET PROJECT TWO OR THREE YEARS OUT.

IT IS IMPORTANT TO KEEP THE INFRASTRUCTURE IN.

THAT'S VERY HELPFUL.

WITH THAT, JUST THE END OF THE PRESENTATION AND I'M AVAILABLE FOR QUESTIONS AND ANSWERS.

IT BRINGS US TO TONIGHT AND WE HAVE A FOLLOW-UP BUDGET DISCUSSION ON JUNE 1ST, TAKING ANYTHING FROM TONIGHT'S MEETING AND ADDITIONAL REQUESTS.

WE'LL TRY TO DO THAT TO HAVE THE OUT THE DOOR PACKETS.

WE HAVE THAT INFORMATION ON JUNE 1ST.

ALL GOING WELL, WE HAVE A PUBLIC HEARING TO ADOPT THE OPERATING BUDGET FOR THE YEARS 2022 AND THE C.I.P. ADOPTION AS WELL WHICH THEY HAVE USUALLY BEEN HAND IN HAND.

THE DISCUSSION ON MAY 11TH BROUGHT FORTH THE PROPOSED BUDGET PRESENTATION FOR YEARS 22.

IT TALKS ABOUT REVENUES AND EXPENDITURES AND CHANGES INCLUDED IN THE PROPOSED BUDGET AND THE FIVE-YEAR FORECASTS.

WE HAVE HAD HAD DEPARTMENT OVERVIEWS THAT LOOKED AT ACCOMPLISHMENTS AND PROPOSALS FOR THE FOLLOWING YEAR.

CITY COUNCIL DID REQUEST FOR US TO PROVIDE CONTROL OF THE PAST EXPENDITURES BY LINE ITEMS OVER \$1,000 AS WELL AS IN -- SORTED BY DEPARTMENT IN DESCENDING ORDER AS WELL.

HOPEFULLY, YEAR ALL ABLE TO GET THOSE BINDERS, SO WE WILL BE REFERENCING THOSE IN A FEW MINUTES.

CONTROLLABLE COSTS AND LINE ITEMS, THE OVERALL INFORMATION, THESE ARE EXPENDITURE LINE ITEMS THAT INCLUDE OVERTIME AND PART TIME AND DEPARTMENTAL SUPPLIES AND MATERIALS AND SERVICES, CONTRACTS, TRAINING AND THOSE TYPE OF THINGS.

I DID WANT TO INCLUDE, \$4.4 MILLION, 2 PERCENT OF THE GENERAL FUND WAS HELD OVER FROM LAST YEAR'S CUTS.

DEPARTMENTS KNOWING THAT WE'RE NOT OUT OF THE WOOD AND WANTED

TO -- HOLD THE LINE A MAINTAIN CUTS AND DID NOT INCLUDE A LOT IN THIS YEAR.

2 PERCENT OF THE GENERAL FUND WAS CUT FROM LAST YEAR.

THOSE ARE INCLUDED IN THE PROPOSED BUDGET FOR FISCAL YEAR 22. ALSO THAT INCLUDES THE GENERAL FUND AND THE INTERNAL SERVICE FUNDS AND THE BUILDING AND OPERATIONS FUND, I.T. FUND AND FLEET FUND AS WELL AS THE INSURANCE FUND.

THESE ARE AGAIN INTERNAL SERVICE FUNDS THAT ARE USED BY THE CITY TO CENTRALIZE CERTAIN SERVICES AND THEN ALLOCATE THE COSTS OF THOSE SERVICES TO THE USER DEPARTMENTS ON A COST REIMBURSEMENT BASIS AND BECAUSE THE GENERAL FUND RECEIVES THE MOST BENEFIT FROM THE INTERNAL SERVICE FUNDS, APPROXIMATELY 90 PERCENT OF FUNDS ARE CHARGED AND ALLOCATED TO THE GENERAL FUND.

ALSO WANTED TO BRING TO YOUR ATTENTION THAT WE DID REVISE THE ESTIMATED SURPLUS, THE 454,000 AND I DID MENTION WHEN WE DID THE PROPOSED BUDGET A FEW WEEKS BACK THAT WE HAD HAD ADDITIONAL SAVINGS FROM OUR PENSION OBLIGATION BOND PAYMENT AND LEVEL DEBT SERVICE BY NEARLY \$200,000.

THAT'S WHY YOU'RE SEEING THE DIFFERENCE BETWEEN THE SURPLUS FROM THE PREVIOUS PRESENTATION.

WITH THAT SAID, IF THERE'S ANY QUESTIONS, WE CAN SWITCH OVER TO THE LIST AND WE CAN START GOING THROUGH THEM AS YOU PLEASE. >> THANK YOU, STEVE.

ARE THERE ANY QUESTIONS BEFORE WE GET TO COUNCIL DISCUSSION AFTER PUBLIC COMMENT?

ANYONE HAVE QUESTIONS?

COUNCIL MEMBER.

>> THANK YOU.

YOUR REVISED SURPLUS OF 454,000.

IS THAT REVISING THE 557,000 FOR THE 20-21 PROJECTION OR THE PROPOSED?

>> THANK YOU.

THAT'S THE PROPOSAL WE BROUGHT UP.

PROPOSED BUDGET SURPLUS WITH REVENUES OVER EXPENDITURES OF 154,000 AND THAT HAS CHANGED DUE TO THE SAVINGS OF NEARLY A MAJORITY.

WE GOT THE PENSION BONDS AND WE PREPPED THE BUDGET AND THOSE NUMBERS WEREN'T FINALIZED.

WE WERE ABLE TO INCLUDE THEM.

IT DOESN'T MATCH THE BUDGET BOOK THAT WE PRINTED OUT IN THE GREEN BINDERS.

THOSE WERE PROPOSED.

I JUST WANTED TO BRING THAT INFORMATION OUT THAT WE'RE LOOKING AT 454,000 VERSUS 254,000 AND THAT MIGHT BE GOOD INFORMATION FOR EVERYONE.

>> 454,000 SURPLUS.

>> YES.

>> THAT AGAIN, FOR THOSE LISTENING AT HOME DOES NOT INCLUDE ANY OF THE MONEY WE'RE EARMARKED TO GET FROM WASHINGTON, D.C. AND WE DON'T KNOW WHAT WE'RE -- EXACTLY WHAT WE'RE GETTING AND WHAT IT CAN BE SPENT FOR, ET CETERA.

IF NOT THE INTERACTIONS, JUST THE SERVICES THAT THEY PROVIDE FOR OUR COMMUNITY.

I DO HAVE A CONCERN ABOUT THAT.

IF STAFF CAN ASSURE ME THAT WE'LL MAINTAIN THE SAME LEVEL OF SERVICE.

THAT GETS INTO MY OTHER POINT THAT I WANTED TO MAKE.

I WANT -- IF WE SEE A SIDEWALK THAT IS BLOCKED BY OVERGROWTH, WE CAN FIX THAT.

PUT THAT ON THE LIST.

IT IS SOMETHING TO DO.

IF WE SPEND THINGS.

SOMEONE CAN'T GET BY A SIDEWALK, THAT'S ADA.

IF THERE'S COMBS THERE SOMEBODY PICK IT UP.

SIGNAGE.

THE OTHER THING I WANT TO TALK ABOUT.

IT IS A BUDGET ITEM AND MENTALITY AND PRIDE OF PLACE ITEM.

I WANT EVERYONE TO HAVE PRIDE OF MANHATTAN BEACH AND KNOW THEY DO.

I KNOW WE GET IN RUTS.

WE CAN TURN BLIND TO THINGS.

THAT'S WHAT I DO.

GET OUT OF OUR SILOS AND LOOK AT THIS ON A DAILY BASIS.

THE OTHER THING IS OUR HISTORIC HOUSE, RIGHT?

OUR HISTORIC COLLECTION.

I THINK THERE'S A CONSTANT MENTALITY THAT THE HISTORIC HOUSE IS RUN BY A HISTORIC SOCIETY.

SMALL GROUP OF VOLUNTEERS THAT COME AND GO AND ARE OF A CERTAIN AGE AND AGING.

THEY DO AS MUCH AS THEY CAN.

IT IS NOT THEIR JOB.

IT IS OUR JOB.

IT IS OUR HISTORY.

IT IS OUR BUILDING AND IN OUR PARK.

WE HAVE THE MONEY FOR THE LIBRARIES.

IT IS A CULTURAL, AS FAR AS I'M CONCERNED A LIBRARY RESOURCE FOR STUDENTS AND WE NEED TO -- WE NEED TO REALLY ATTACK THAT THIS YEAR.

I DON'T WANT ANOTHER YEAR TO GO BY WITHOUT GIVING ANSWERS ON THAT AND WITHOUT GIVING A PROGRAM IN PLACE AND SOME MOVEMENT FOR THE PRESERVATION OF OUR HISTORY.

IT COULD BE CLOSED UP.

WHERE IS THAT.

DIRECTOR, YOU ON THE CALL.

WHAT HAPPENED TO THE BUILDING AS ADJUNCT?

>> A NUMBER OF MOVING PIECES HERE.

REGARDING THE BUILDING, WE DID REQUEST COST ESTIMATES WITH THE SAME VENDOR THAT WE WORKED WITH THE SAND DUNE BUILDING.

AND GET BACK TO YOU AS SOON AS POSSIBLE.

>> I APPRECIATE THAT.

WHOEVER IS RENEWING THE CONTRACT, DON'T HOLD IT UP.

IF IT IS LEVEL AND SIGNED, EVERY DAY IS FURTHER DECAY.

>> I'M THINKING ABOUT THAT SERVICE CALL THAT IS ADVERTISED ON THE RADIO, LEGACY BOSS.

THEY ARE IN THE SLIDES, YOUR PICTURES, YOUR NEGATIVES, YOU SHIP IT OFF AND THEY SEND IT BACK TO YOU.

I THINK WITH STEVE, LET'S NOT SLOW IT DOWN.

IT IS GRADING OF THE MATERIAL.

THE HISTORY ADVISORY BOARD IS RUNNING INTO THAT WITH THE BRUCE'S HISTORY REPORT.

EVEN THE MICROFICHE HAVE DEGRADED AND STUFF DOESN'T LAST FOREVER, ESPECIALLY HERE AT THE OCEAN WITH THE SALT AIR. OKAY.

THINGS LIKE THAT.

I JUST CAUTION RESIDENTS TO THINK THAT THIS IS JUST A GRAB BAG 6 MILLION DOLLAR FUND OF EXCESS FUNDS.

COUNCIL MEMBER MONTGOMERY.

>> THIS IS THE SECOND TIME I'VE GONE THROUGH EXTREME BUDGETS.

THE FIRST TIME WAS THE GREAT RECESSION AND COVID.

I'M NOT A BIG FAN OF CUTTING BUDGETS.

THERE HAS TO BE A REASON.

TRIMMING THE BUDGET, I GET IT.

BUT CUTTING SERVICES THAT WE CAN AFFORD FOR OUR RESIDENTS,

THAT'S WHAT WE SHOULD BE DOING.

FOR INFRASTRUCTURE AND PUBLIC SAFETY, THAT'S A GOOD REASON FOR YOU TO VOTE FOR SOMETHING.

NOT THAT IT WILL PAY FOR IT.

JOE IS RIGHT, WE GOT THE LAST FEW AND WE DIDN'T SPEND.

THE MALL KNOWS IT AND WE ALL KNOW IT.

THIS WAS NOT NEWS TO CITY MANAGER MOE OR GEORGE GABRIEL.

I WOULD LIKE -- I WOULD LIKE -- RICHARD AND I TALKED ABOUT IT.

I WOULD LIKE TO HIRE RAMON.

I DON'T KNOW WHO RAMON IS.

HE'S FULL TIME HOUSING OFFICER.

PEOPLE LIKE RAMON.

AGAIN, I DON'T KNOW WHO HE IS.

HE'S A PLACE HOLDER.

HE'S NOW ONE -- WE SHARE HIM WITH THREE CITIES, HERMOSA BEACH AND REDONDO BEACH AND MANHATTAN BEACH.

I WANT HIM HERE.

I WANT BOOTS ON THE GROUND FOR GEORGE IDEALLY.

AND CITY MANAGER MOE.

PEOPLE COMING HERE AND NOT WELL AND DANGEROUS COULD REALLY NEED HELP.

OUR COMMUNITY EXPECT US TO HELP THEM.

WE NEED TO SPEND THE PUN TO HELP THEM.

- >> STEVE YOUR HAND WAS UP.
- >> OH
- >> I DON'T THINK ANYONE DISAGREES AGREE WITH THE CONCERN BUT THIS GOES BACK TO YOU KNOW, WE HAD A MEETING AND WE WENT OFF ON A LONG TANGENT ON OTHER THINGS.
- I WOULD LIKE TO TALK ABOUT THAT BEFORE GOING INTO THE MEETING TONIGHT.
- WE HAVE MORE BACKGROUND WITH THE HOMELESSNESS ITEM.
- >> IT IS COMING UP AGAINST.
- >> RIGHT.
- >> I WANT CONTEXT FOR THESE THINGS BEFORE I SAY YEAH, I'LL SPEND 350,000.
- >> MAYOR HADLEY: CHICKEN OR THE EGG.

- I APPRECIATE WHAT REDONDO BEACH IS DOING.

- THE BED WE TALKED ABOUT FOR A WHILE.

- THAT'S NOT SUSTAINABLE.

\$45,000 A YEAR FOR FIVE SRO ROOMS IN WILMINGTON.

THAT'S SUSTAINABLE.

IT ALLOWS US TO VOICE UNDER BOISE.

>> I WOULD TURN TO BRUCE ABOUT WHERE WE'VE BEEN SINCE THE LAST TIME WE TALKED ABOUT BEDS AND BELL.

WE WEREN'T SUPPOSED TO STOP LOOKING FOR THEM.

>> A COUNCIL MEMBER CALLED BELL AND GOT POLITICAL.

THAT'S WHAT HAPPENED TO BELL.

GEORGE, YOU STILL ON THE LINE ABOUT WILMINGTON AND WHAT REDONDO BEACH IS DOING?

>> MEMBERS OF THE CITY COUNCIL.

WITH REGARD TO WHAT REGARD TO WILMINGTON, THERE'S APARTMENTS BEING RENTED.

NOT NECESSARILY SHELTERS FOR BED.

THEY'RE BEING -- REDONDO BEACH HIRED A DIFFERENT SERVICE PROVIDER, CITY NET IN ORDER TO PROVIDE THE WRAP AROUND SERVICES FOR THAT.

IN REGARDS TO WHAT OUR STATUS OF THAT IS SHELTERS.

THEY'RE NOT OFFERING THEM TO CITIES IN TERMS OF THE POLITICAL ELEMENTS OF THAT.

- I THINK MAYOR PRO TEM STERN, HAVE YOU MADE YOUR SORT OF BIG PICTURE SOAPBOX SPEECH, NOW IS THE TIME.
- >> I DON'T KNOW IF I HAVE A BIG PICTURE SPEECH.
- I WANT TO REMIND US THAT WE TAKE THIS SERIOUSLY.
- I WAS GLAD WE TOOK THIS LINE BY LINE.
- I WANT TO SHOW THE RESIDENTS THAT WE UNDERSTAND THE CITY AND WE'RE LOOKING AT IN NOW.
- IT IS ONLY BEEN A COUPLE OF YEARS THAT I'VE BEEN IN THIS PROCESS, BUT IN THE LAST COUPLE OF YEARS WE HAVE GONE THROUGH THE PROCESS OF BEING DONE.
- WE'VE GONE LINE BY LINE AND WE'RE DOING WHAT WE PROMISED WE WOULD TO FOR OUR TAXPAYERS IN MANHATTAN BEACH AND WE'RE SPENDING MONEY BECAUSE WE KNOW WE'RE SPENDING THE MONEY.

IT WAS INTERESTING.

WE HAD A LOT OF ITEMS.
