County resident cases dating back to March 16, 2020, that are included in case totals. These cases came from inpatient and outpatient medical records and cases with updated address information or revised jurisdiction criteria. As such, Public Health reported an additional 11 new cases dating back to March 16, 2020 in Manhattan Beach. Therefore, these additional cases do not properly reflect a typical daily increase. The change reflects daily increases, not increases from the prior situation report.

The State updated tier assignments on March 30, under its Blueprint for a Safer Economy – the criteria used to loosen and tighten regulations on activities. The County met the threshold to move from Tier Two (Red) Status, a "Substantial" risk level where some non-essential indoor business operations are closed, to Tier Three (Orange) Status. In this "Moderate" risk level, some indoor business operations can open with modifications. According to the State's website, L.A. County continues to improve its standing reflecting 3.8 new COVID-19 cases per day (per 100K), decreasing from 4.8, with an adjusted case rate for tier assignment equaling 3.1. The County's overall test positivity rate dropped from 1.8% to 1.5%. The health equity metric also reduced from 2.5% to 2.1%. A revised Los Angeles County Health Officer Order will go into effect on Monday, April 5 at 12:01 AM to reflect newly permitted activities. This allows the County to follow the State guidelines and wait until three weeks are completed in the Red Tier to ensure that case numbers do not rise this third week since the County's earlier reopenings.
